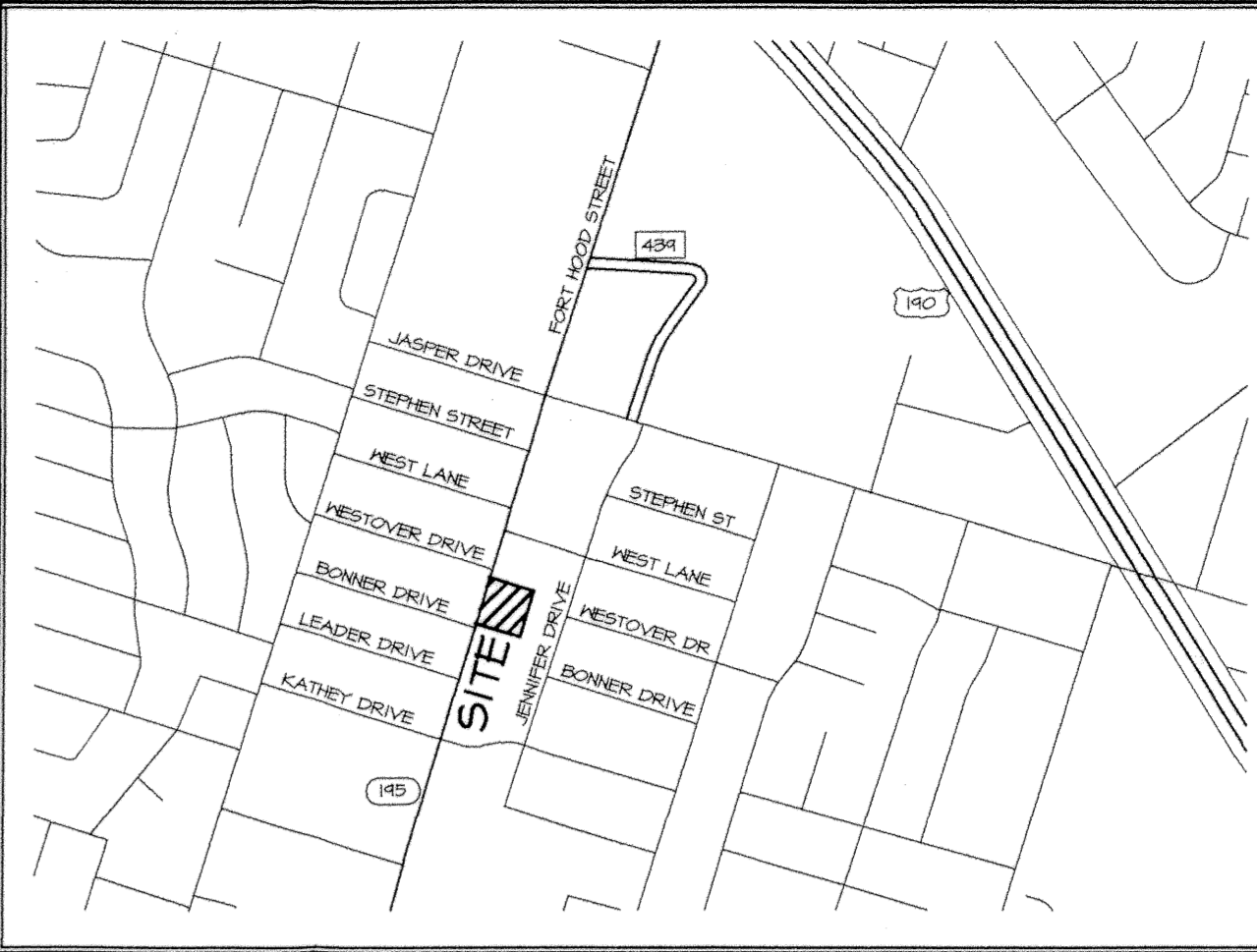


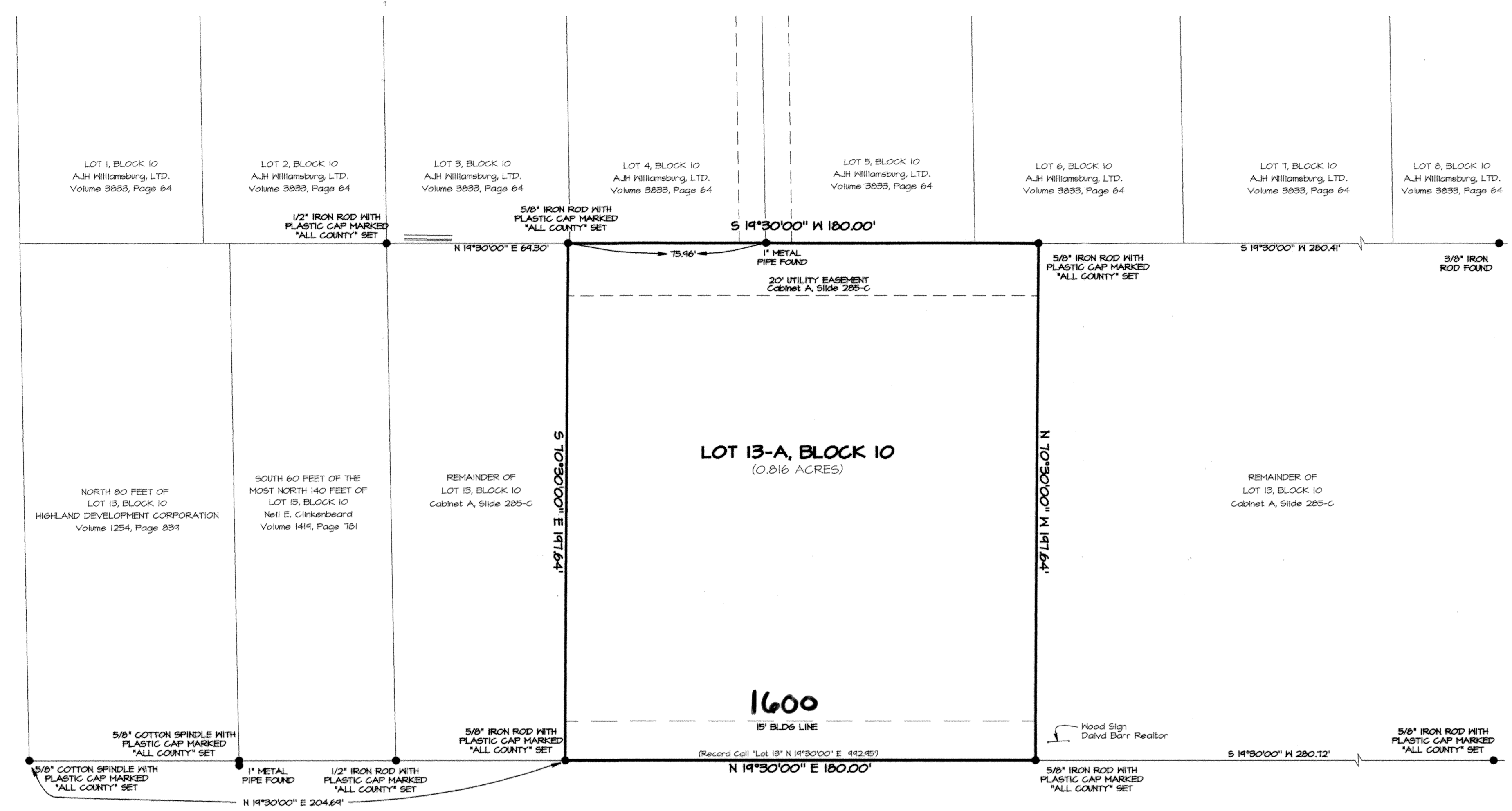
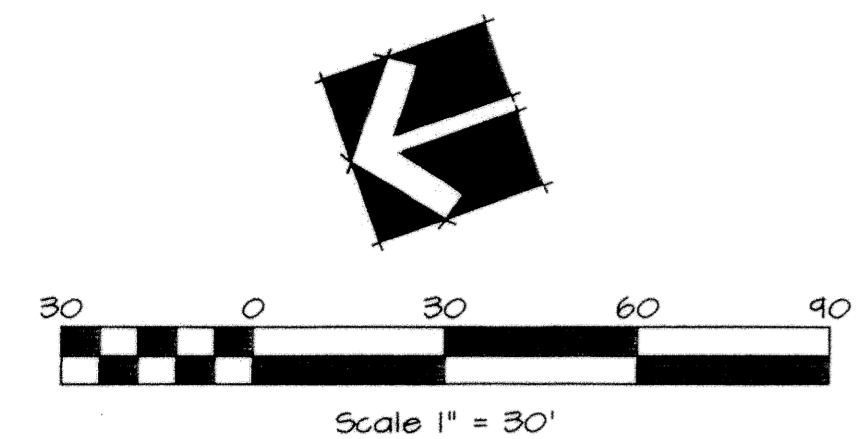
FINAL PLAT OF
