KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Michael Attas, being the sole owner of a certain tract of land in the City of Killeen, Bell County, Texas, which premises are more particularly described as follows:

Situated in the City of Killeen, Bell County, Texas and known as being a part of the original J. R. Smith 160 acre survey and being more particularly described as follows: Beginning at a point on the East line of Tenth Street 533 feet South 18° West from a post at the intersection of the North line of the J. R. Smith Survey with the East line of Tenth Street in Killeen, Texas; Thence South 71° East 320 feet to a point for the Northeast corner of this; Thence South 18° West 145 feet to a point for the Southeast corner of this; Thence North 71° West 320 feet to a stake in the East line of Tenth Street for the Southwest corner of this; Thence North 18° East 145 feet with the East line of Tenth Street to the place of beginning. does hereby subdivide said land into a block and lots to be known as Attas Addition as shown by the plat thereof, attached hereto, made a part hereof and approved by the City Council of the City of Killeen,

Bell County, Texas; and said Michael Attas hereby dedicates said plat of Atlas Addition as a subdivision within the City of Killeen, Bell County, Texas, and for the purpose of selling lots of land with reference thereto and for all other purposes; and does hereby dedicate to the City of Killeen, Texas, that portion of the above described premises included in the street areas shown on said plat, the same to be used as public thoroughfares and for the installation and maintenance of public utilities when and as authorized by the City of Killeen. The utility easements shown on the said plat are dedicated to the City of Killeen, Texas, for installation and maintenance of any and all public utilities which said City may elect to install and maintain or permit to be installed and maintained and no permanent structures shall be erected on said easements.

#### RESOLUTION

A RESOLUTION APPROVING THE SUBDIVISION AND DEDICATION OF STREET AREAS AND EASEMENTS IN THE ATTAS ADDITION TO THE CITY OF KILLEEN, BELL COUNTY, TEXAS, ACCORDING TO THE PLAT THEREOF FILED WITH THE CITY SECRETARY AND HEREBY APPROVED.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KILLEEN:

SECTION I. That the action of Michael Attas in subdividing and dedicating the Atlas Addition to the City of Killeen, Bell County, Texas, together with street areas and utility easements is hereby in all things approved by the City Council of the City of Killeen, as meeting all the requirements and provisions of the Ordinances of said City. The lots and block of said Atlas Addition are fully shown on the Plat of such addition on file with the City Secretary of the City of Killeen, which plat is hereby approved as constituting the lots, block, street areas and utility easements of the Atlas Addition.

SECTION II. BE IT FURTHER RESOLVED that the Plat of Atlas Addition on file with the City Secretary aforesaid together with the dedication of street areas and easements in and through said Atlas Addition are hereby approved and accepted.
