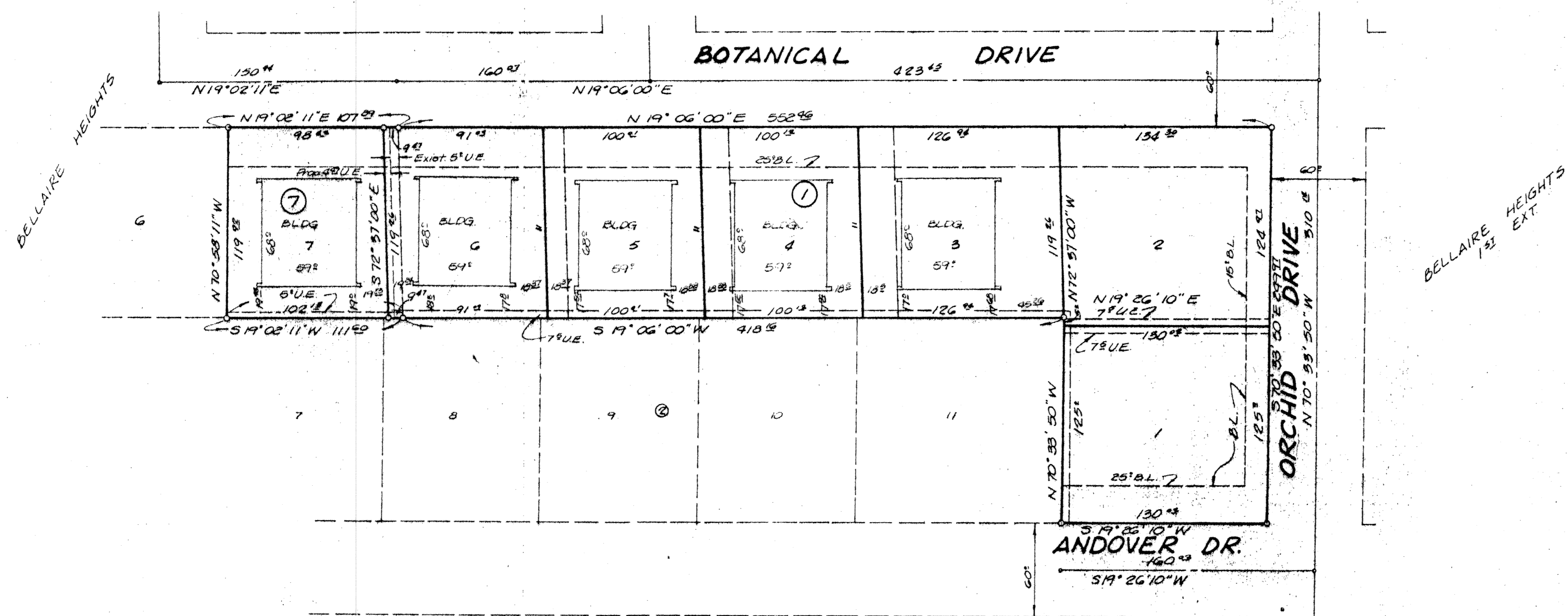


BELLAIRE HEIGHTS
