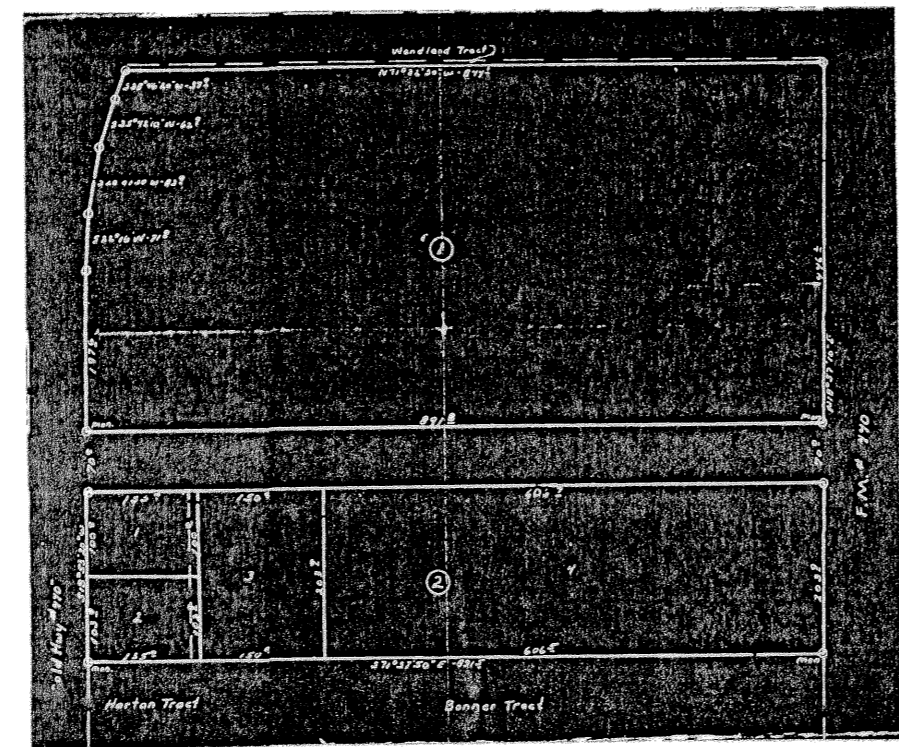


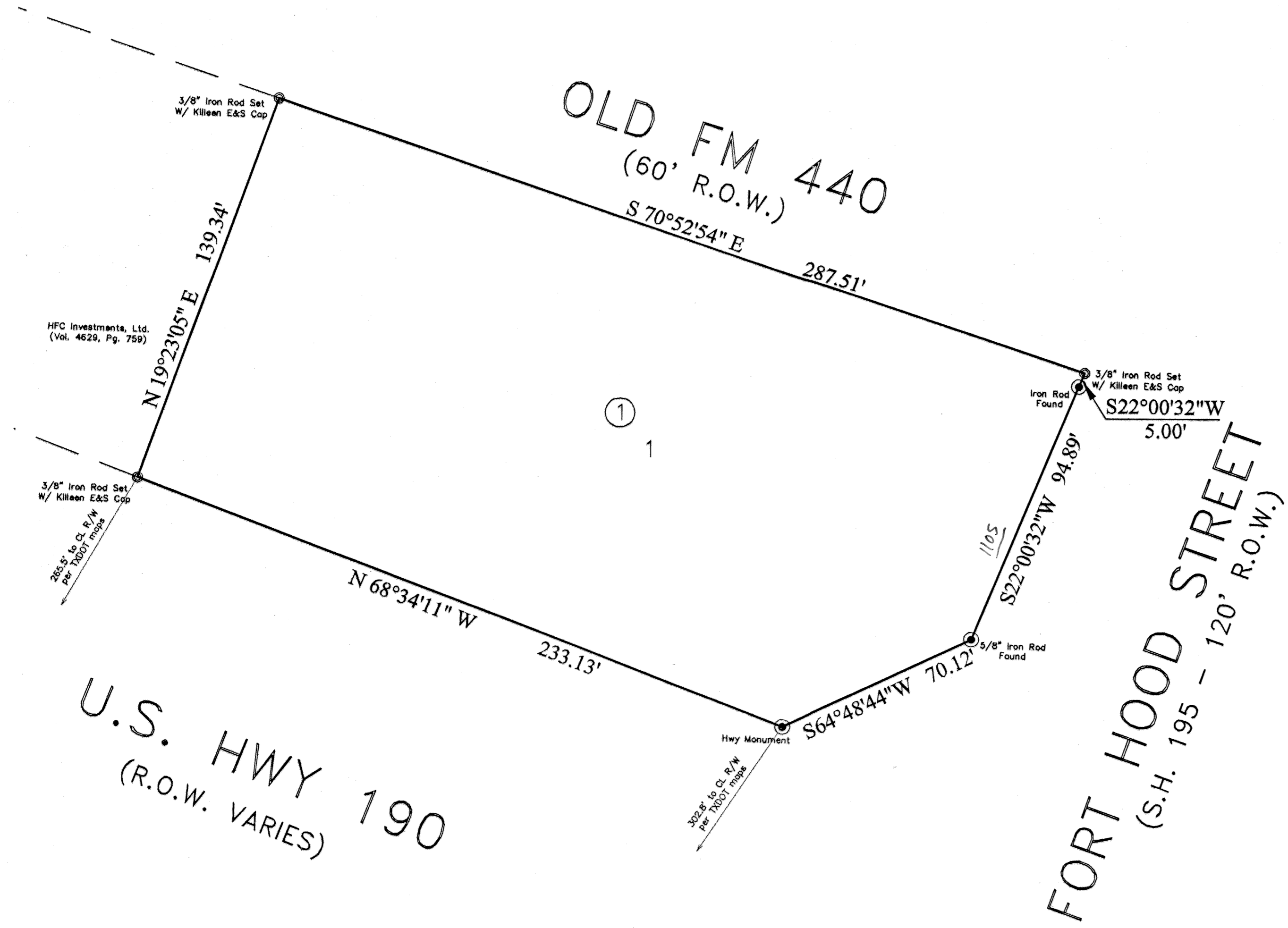
INSET "A"

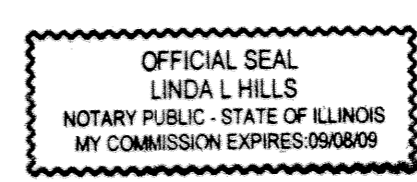

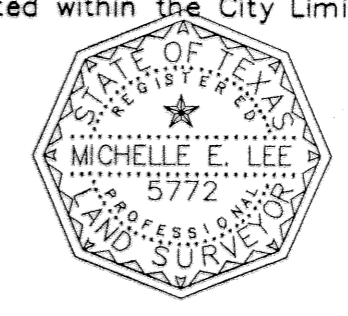

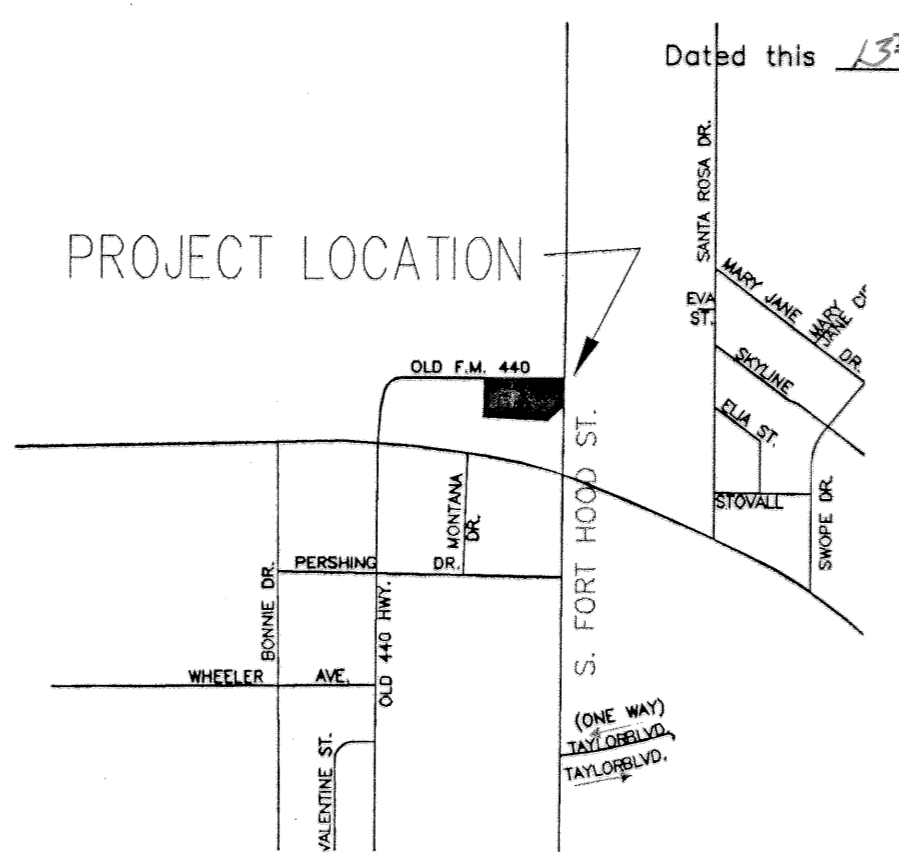
