

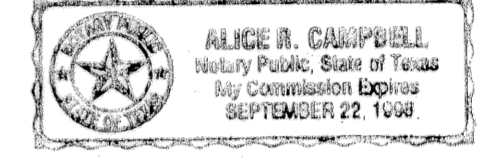

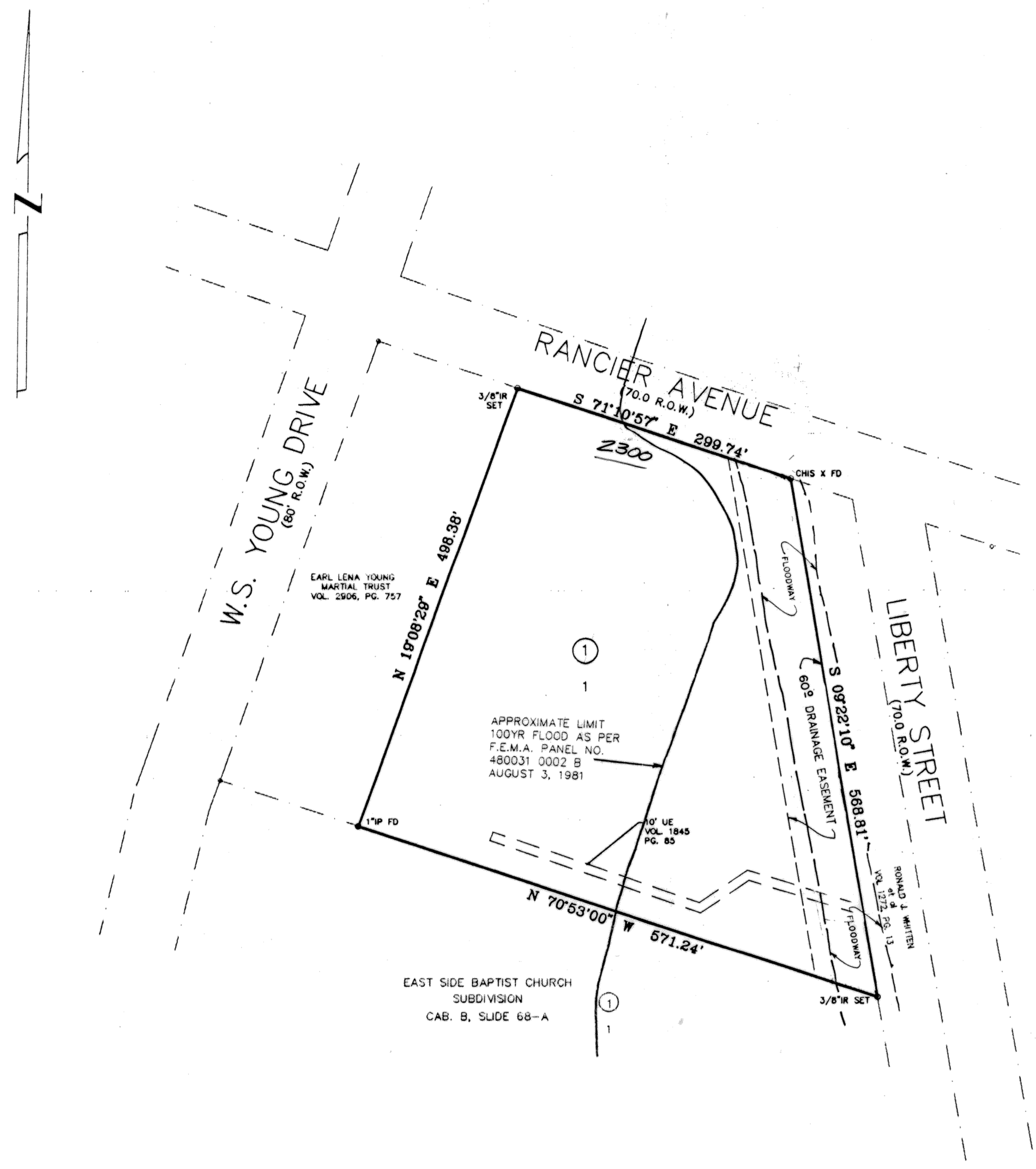

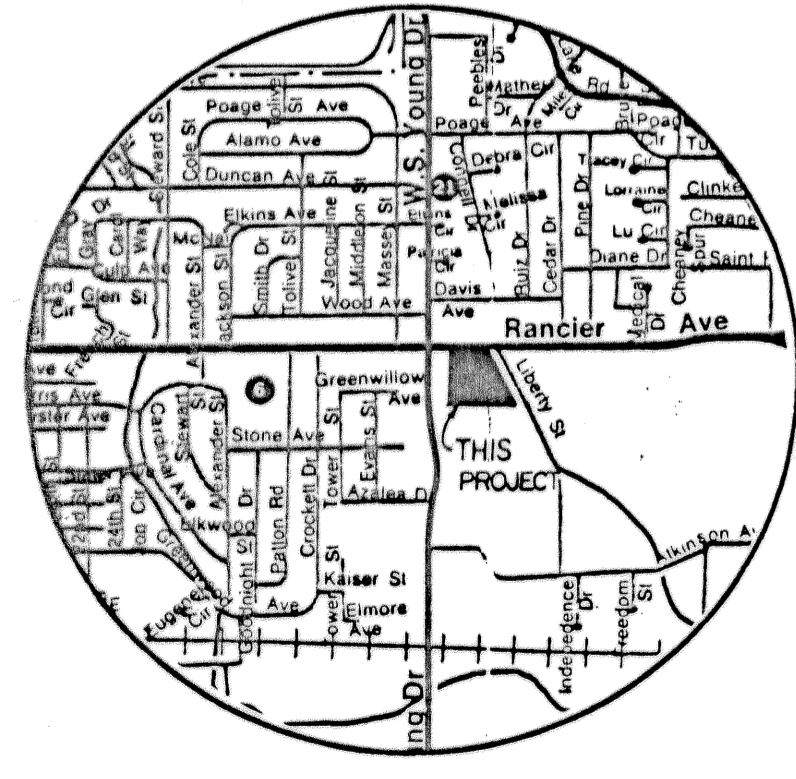

MIN. FIN. FLOOR ELEV. = 820.0

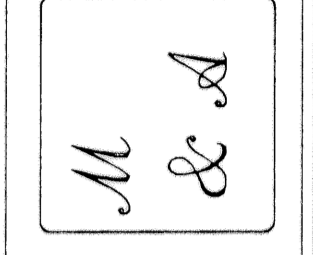


VICINITY MAP
