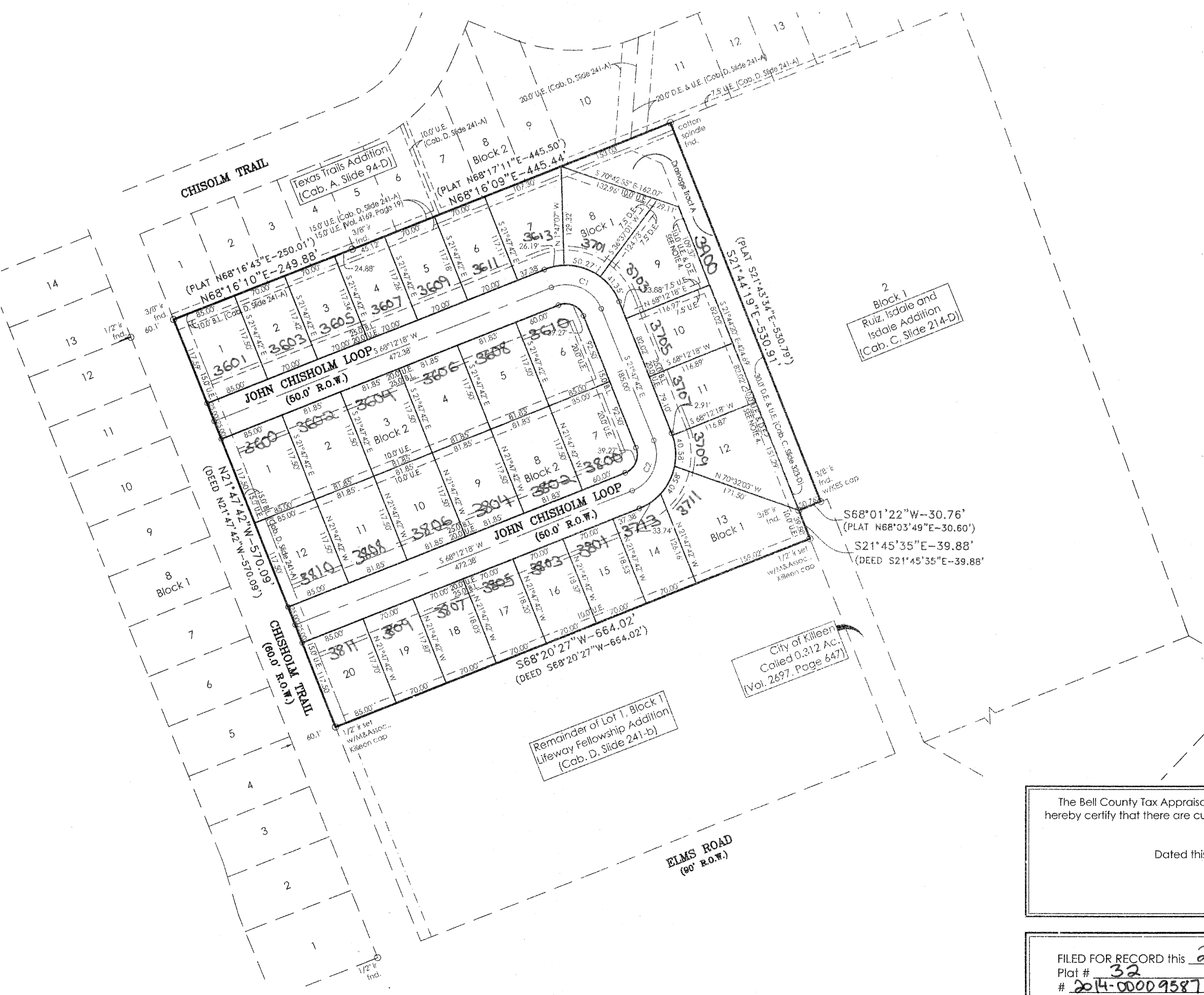
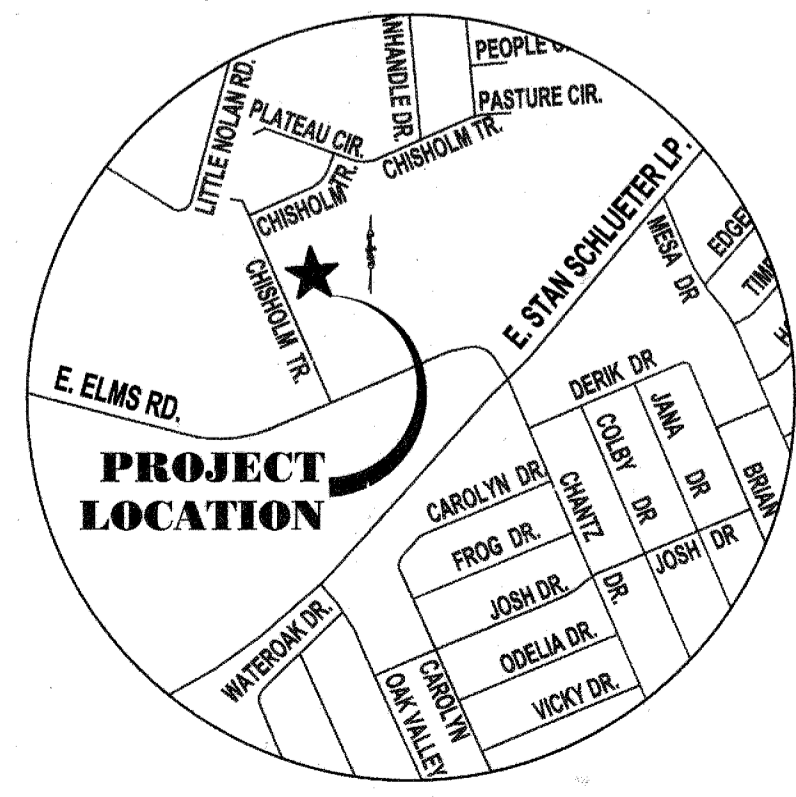


- NOTES:**

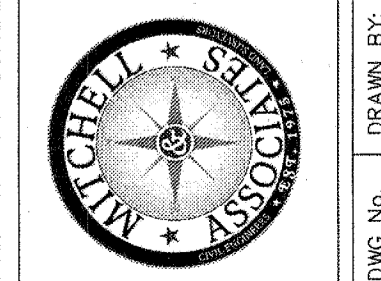
