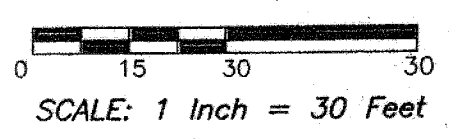

The distances shown are surface distances. The Combined Correction Factor (CCF) for this project is 0.99984450.
