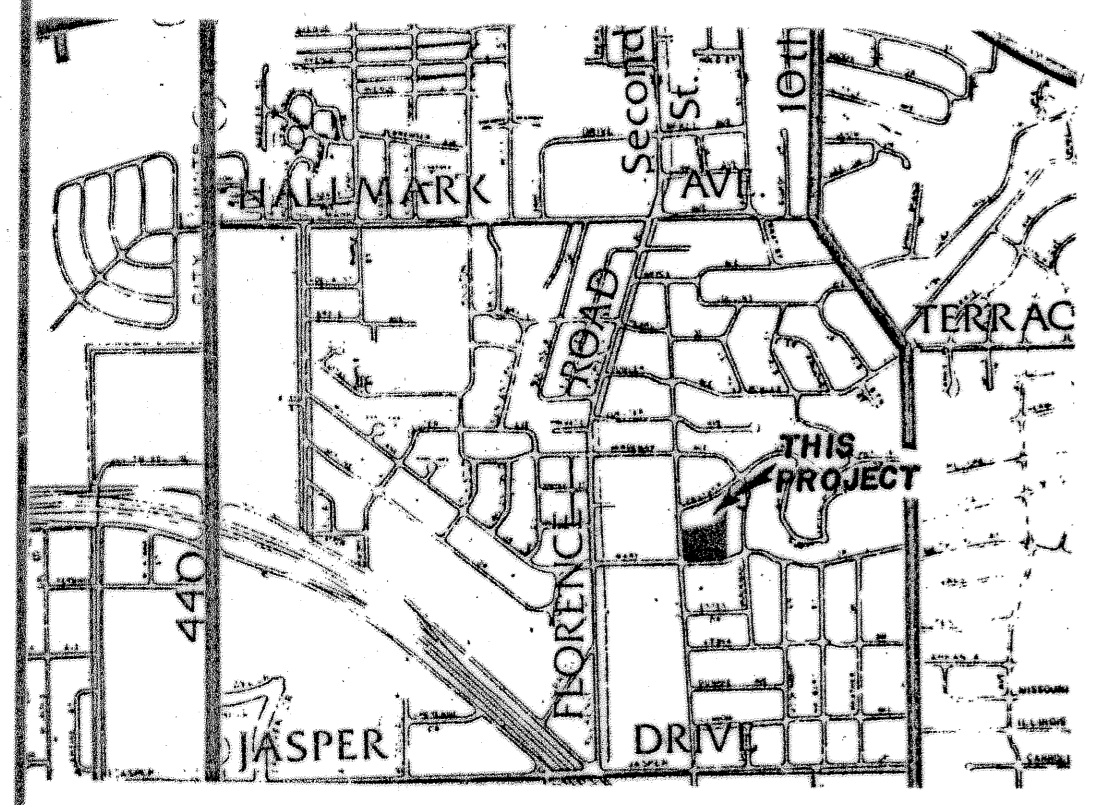
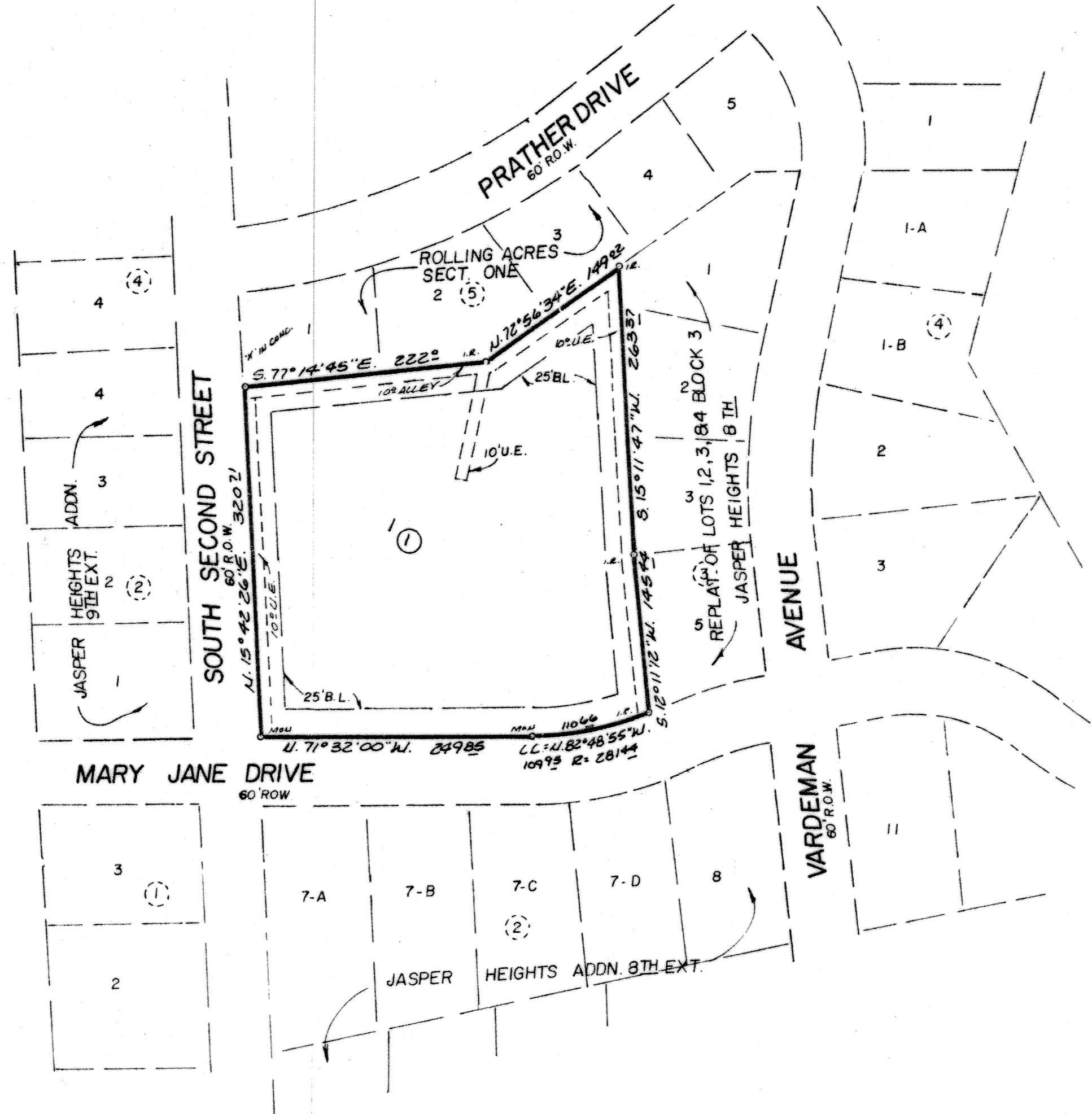


REPLAT OF LOTS 1, 2, 3, & 4 BLOCK 3 JASPER HEIGHTS 8TH



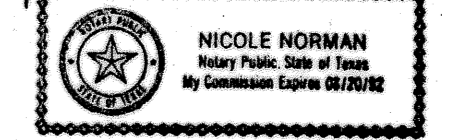
VICINITY MAP
