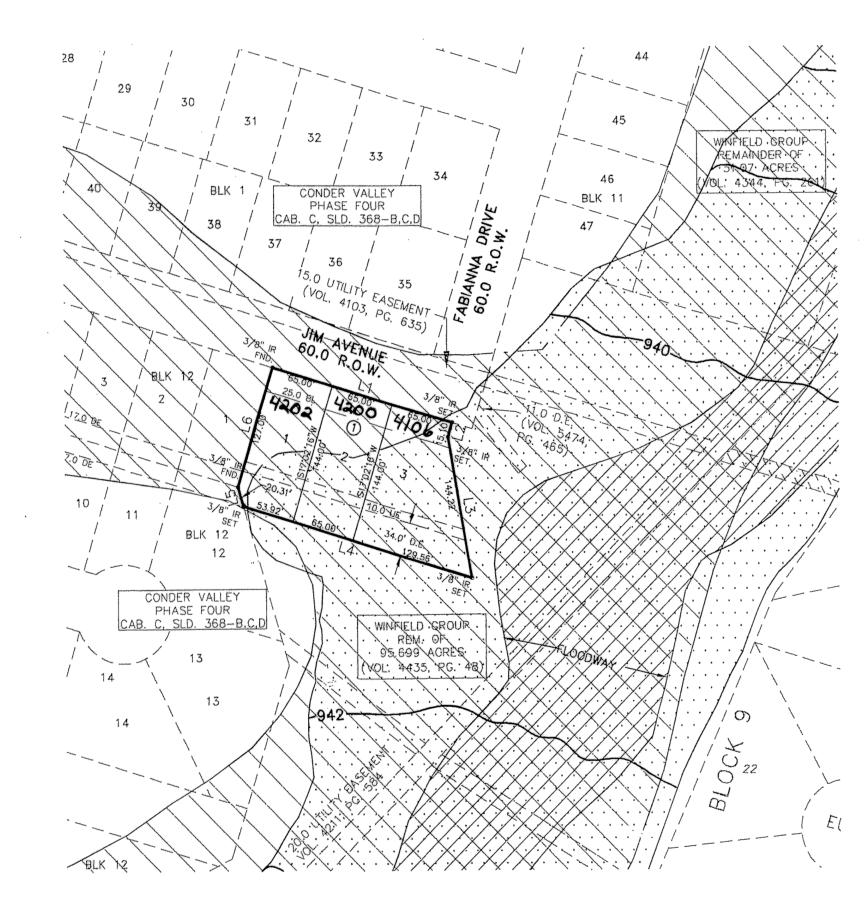
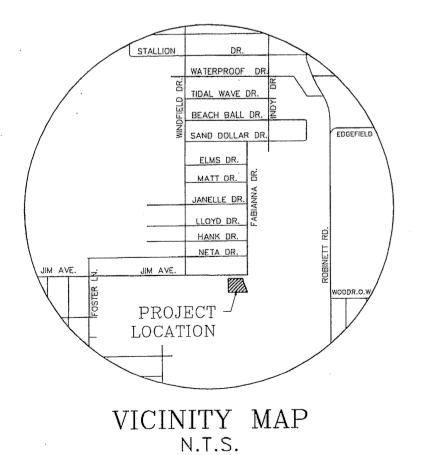


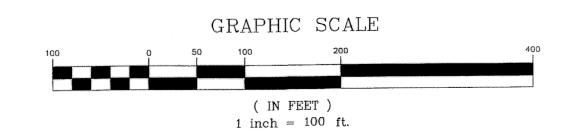
CONDER VALLEY PHASE FOUR (CAB C, SLIDE 386-B,C,D) SCALE: 1"=100'
