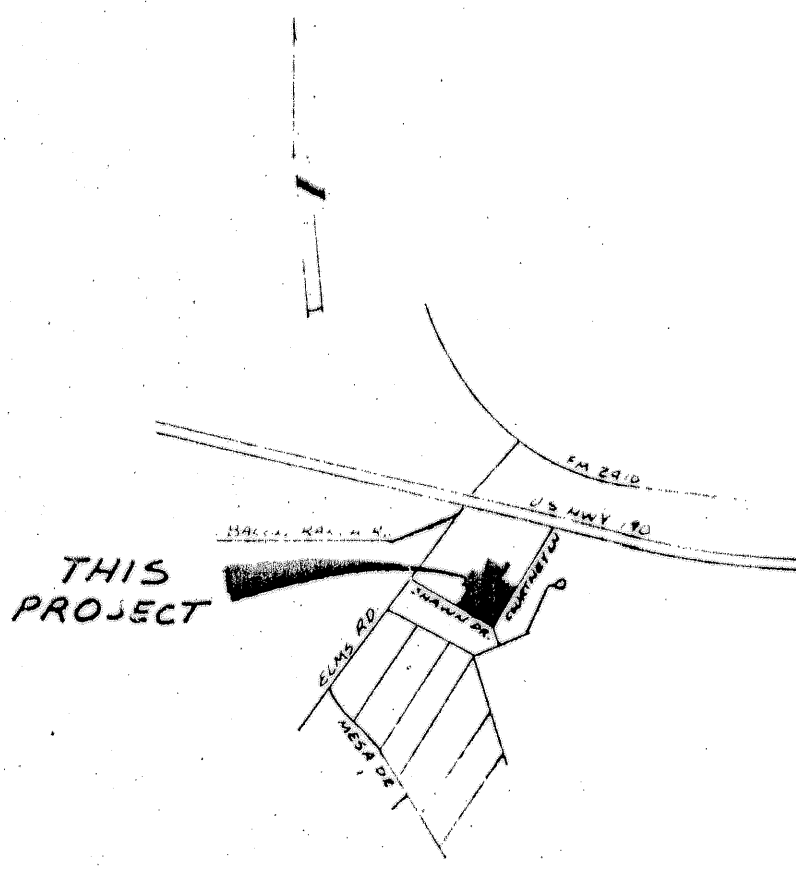
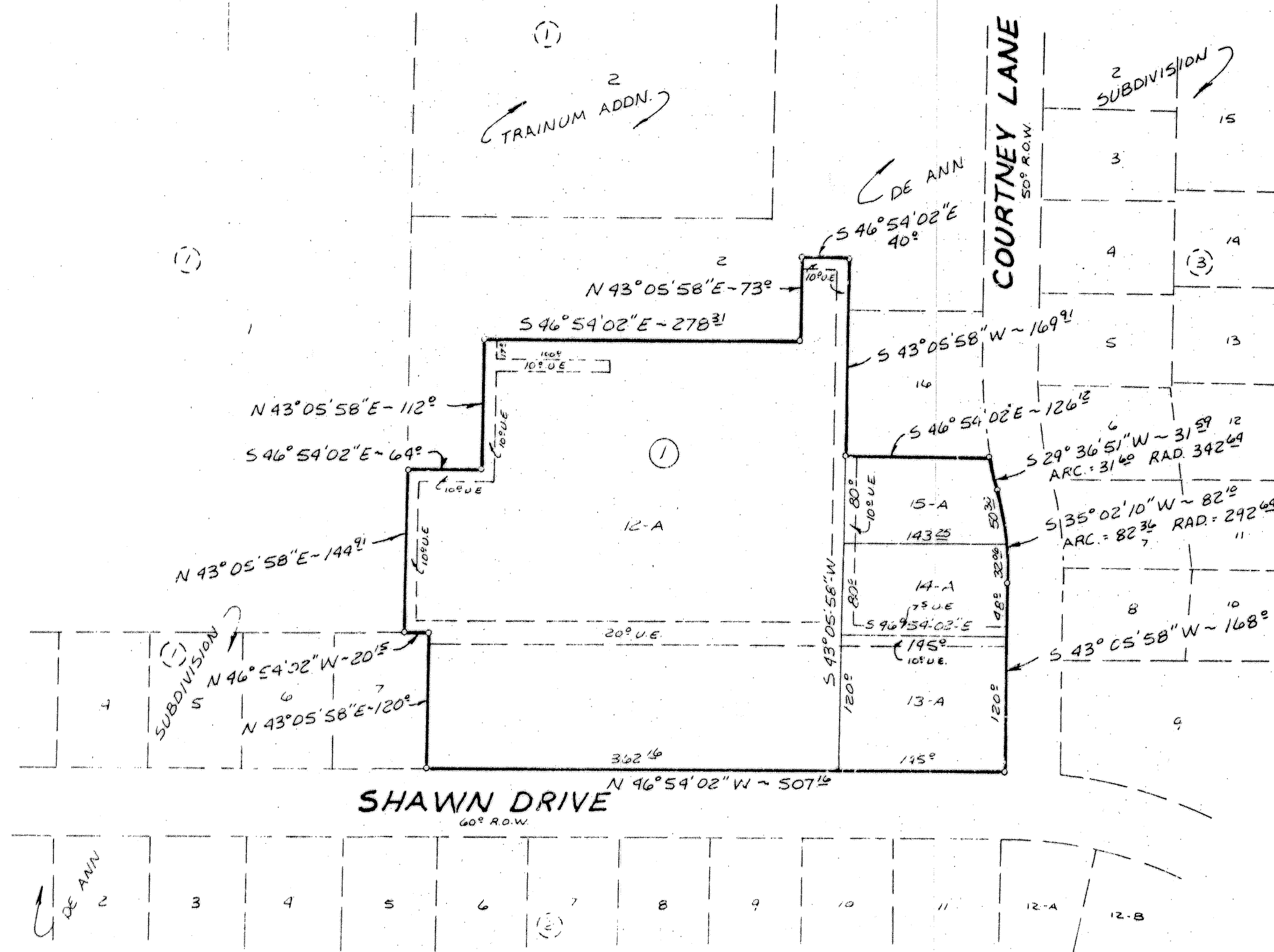
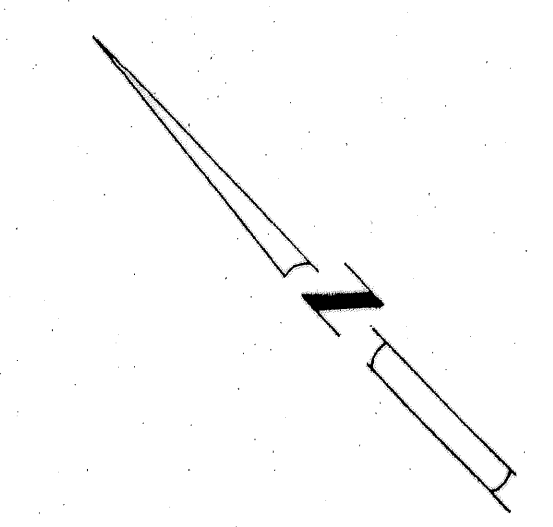


Lots 2 and 8 thru 15 Block 1, De Ann Subdivision
