

Box 10310, Killeen, Texas 76547, being the sole owner of that certain 0.508 acre tract of land in Bell County, Texas, part of the Robert Cunningham Survey, Abstract No. 158, which is more fully described in the dedication of Lots 9A and 9B, Block 3, De Ann Subdivision, being a replat of Lot 9, Block 3, De Ann Subdivision, as shown by the plat hereof, attached hereto, and made a part hereon, and approved by the Planning Commission of the City of Killeen, Bell County, Texas, and Michael R.
