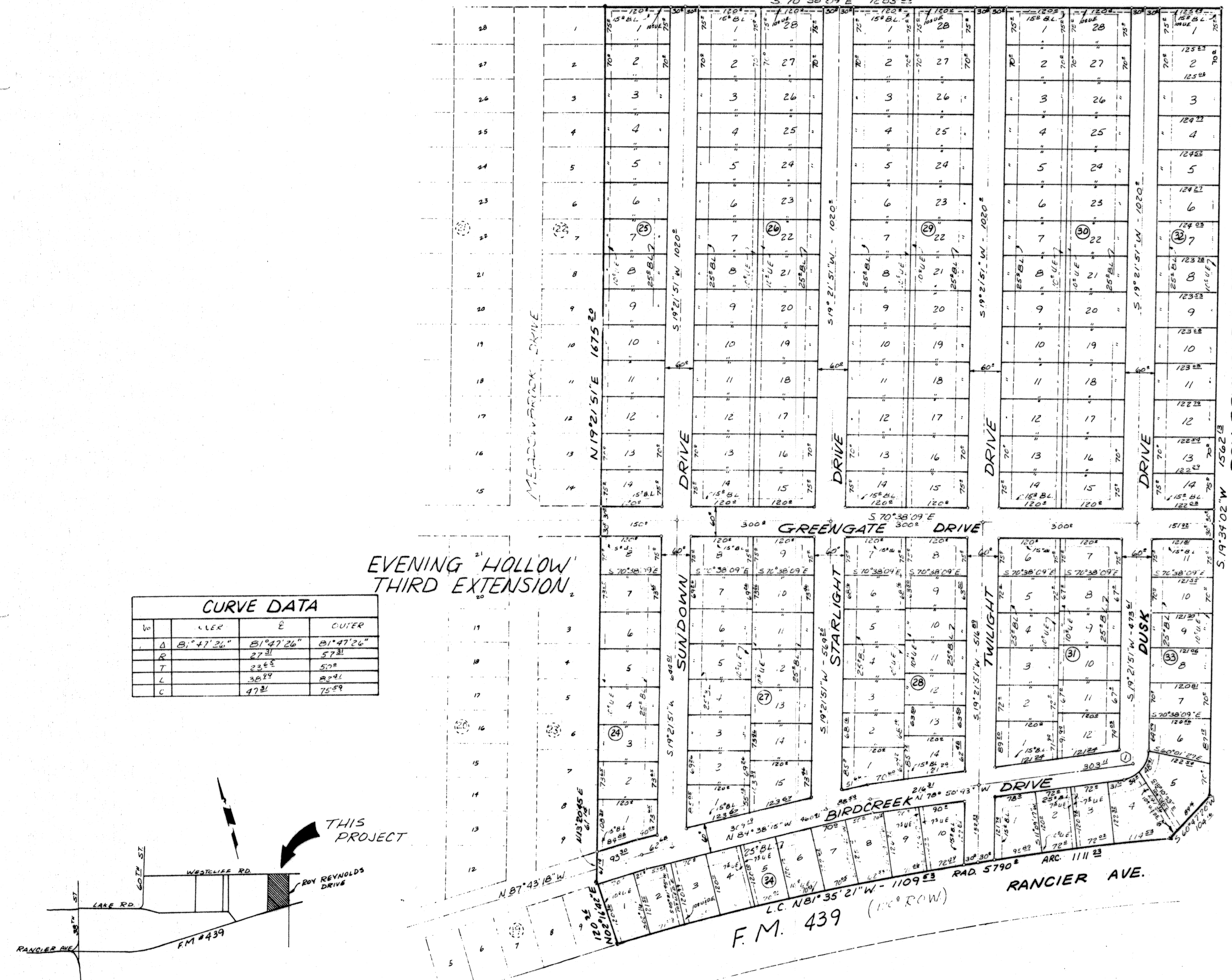
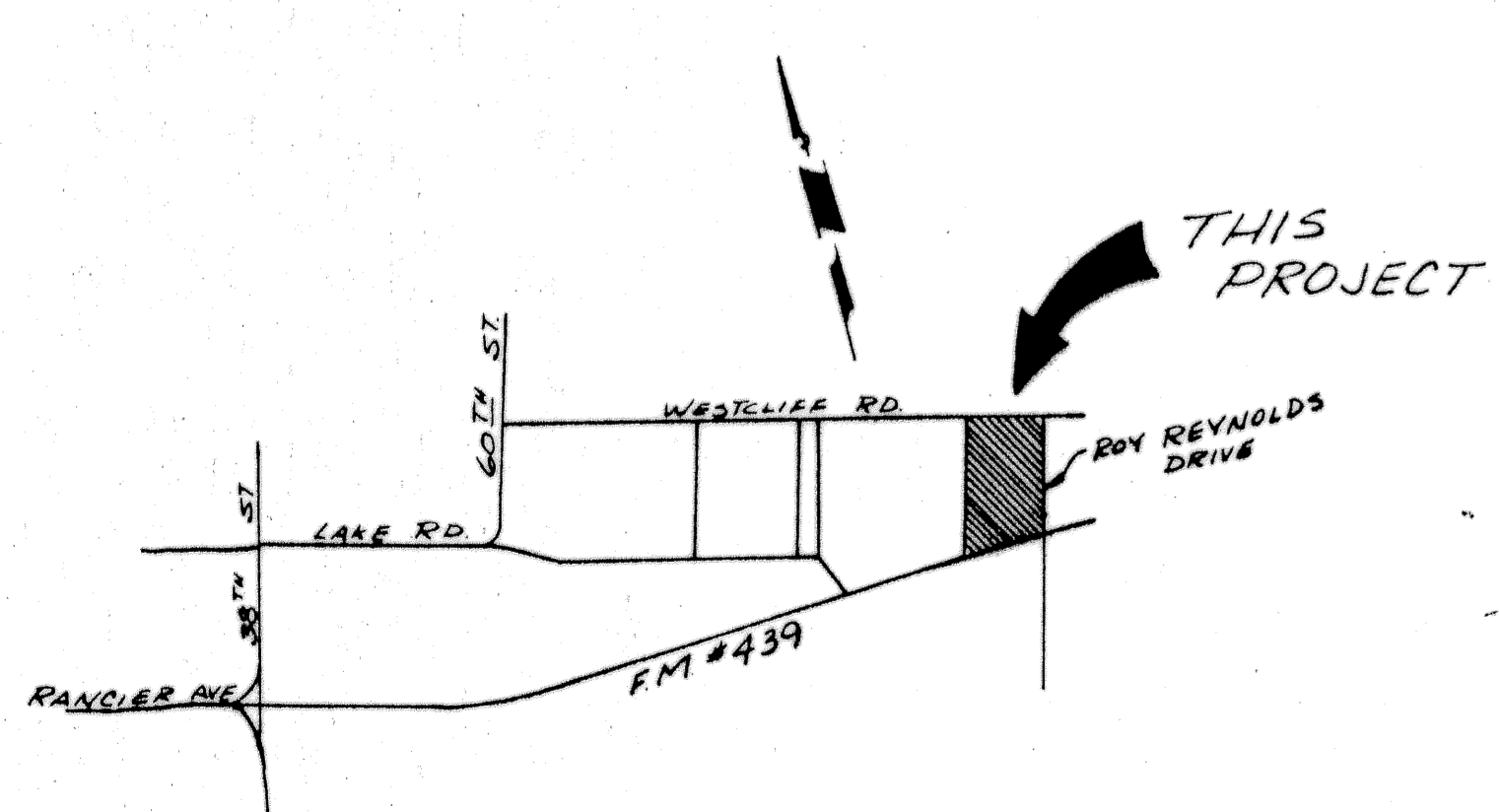


WESTCLIFF ROAD (70° R.O.W.)
