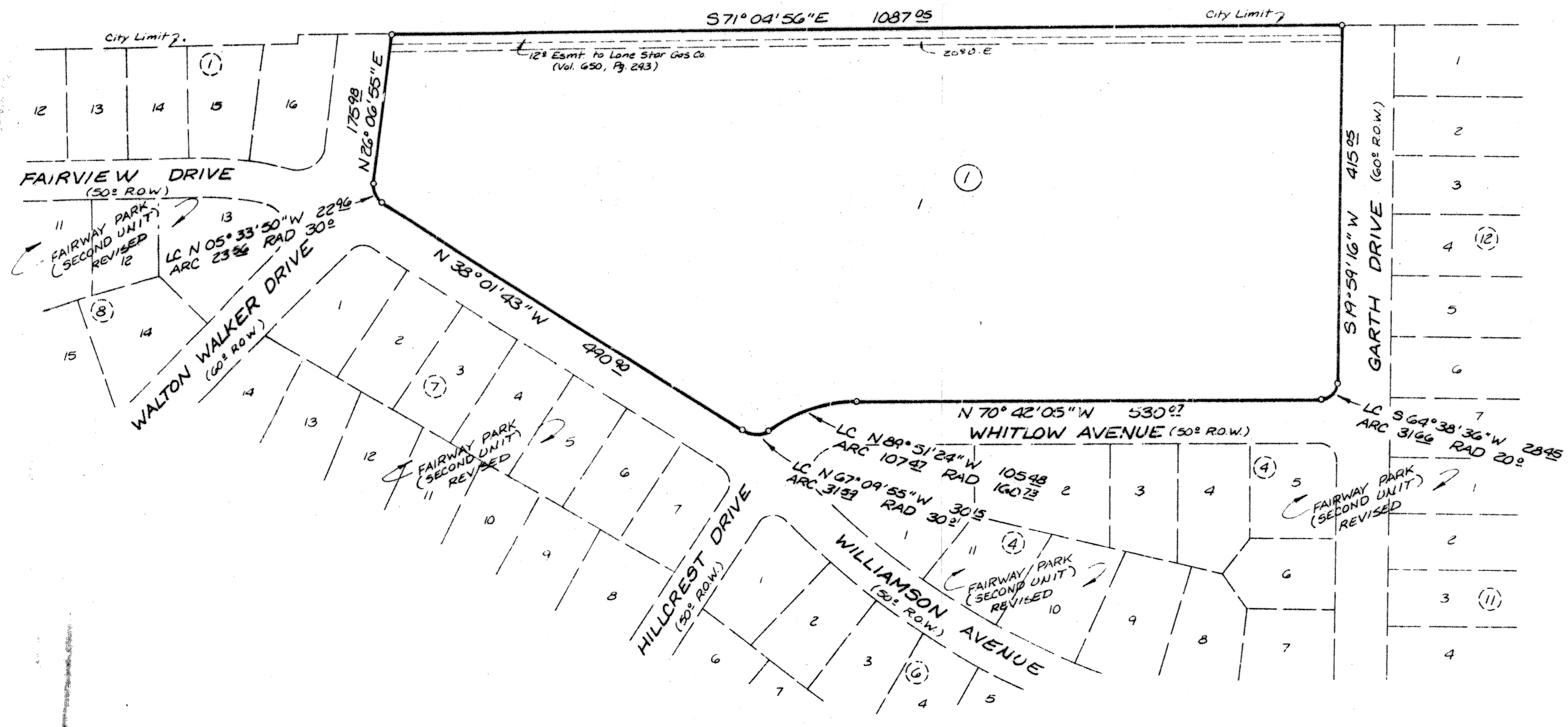
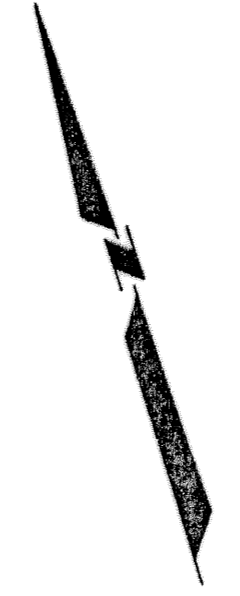

KNOW ALL MEN BY THESE PRESENTS, that the KILLEEN INDEPENDENT SCHOOL DISTRICT, whose address is P.O. Box 967, Killeen, TX 76540, being the sole owners of that certain 9.953 acre tract out of the Barnett Maser Survey, Abstract No. 616, which is more fully described in the Dedication of FAIRWAY MIDDLE SCHOOL ADDITION, BEING A REPLAT OF BLOCKS 2 AND 3, AND ALL OF KATHY AVENUE, FAIRWAY PARK (SECOND UNIT) REVISED, as shown by the plat hereof, attached hereto, and made a part hereon, and approved by the City Council of the City of Killeen, Bell County, Texas, and the KILLEEN INDEPENDENT SCHOOL DISTRICT does hereby adopt said FAIRWAY MIDDLE SCHOOL ADDITION, BEING A REPLAT OF BLOCKS 2 AND 3, AND ALL OF KATHY AVENUE, FAIRWAY PARK (SECOND UNIT) REVISED, as an addition to the City of Killeen, Bell County, Texas, and hereby dedicates to said City all streets, avenues, roads, drives and alleys shown on said plat, the same to be used as public thoroughfares and for the installation and maintenance of public utilities when and as authorized by the City of Killeen. The utility easements shown on said plat are dedicated to said City for the installation and maintenance of any and all public utilities, which the City may install or permit to be installed or maintained.

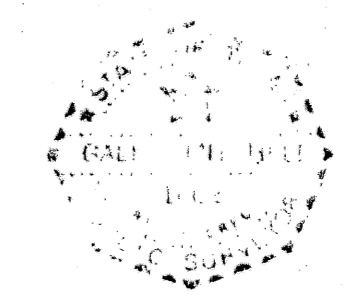
