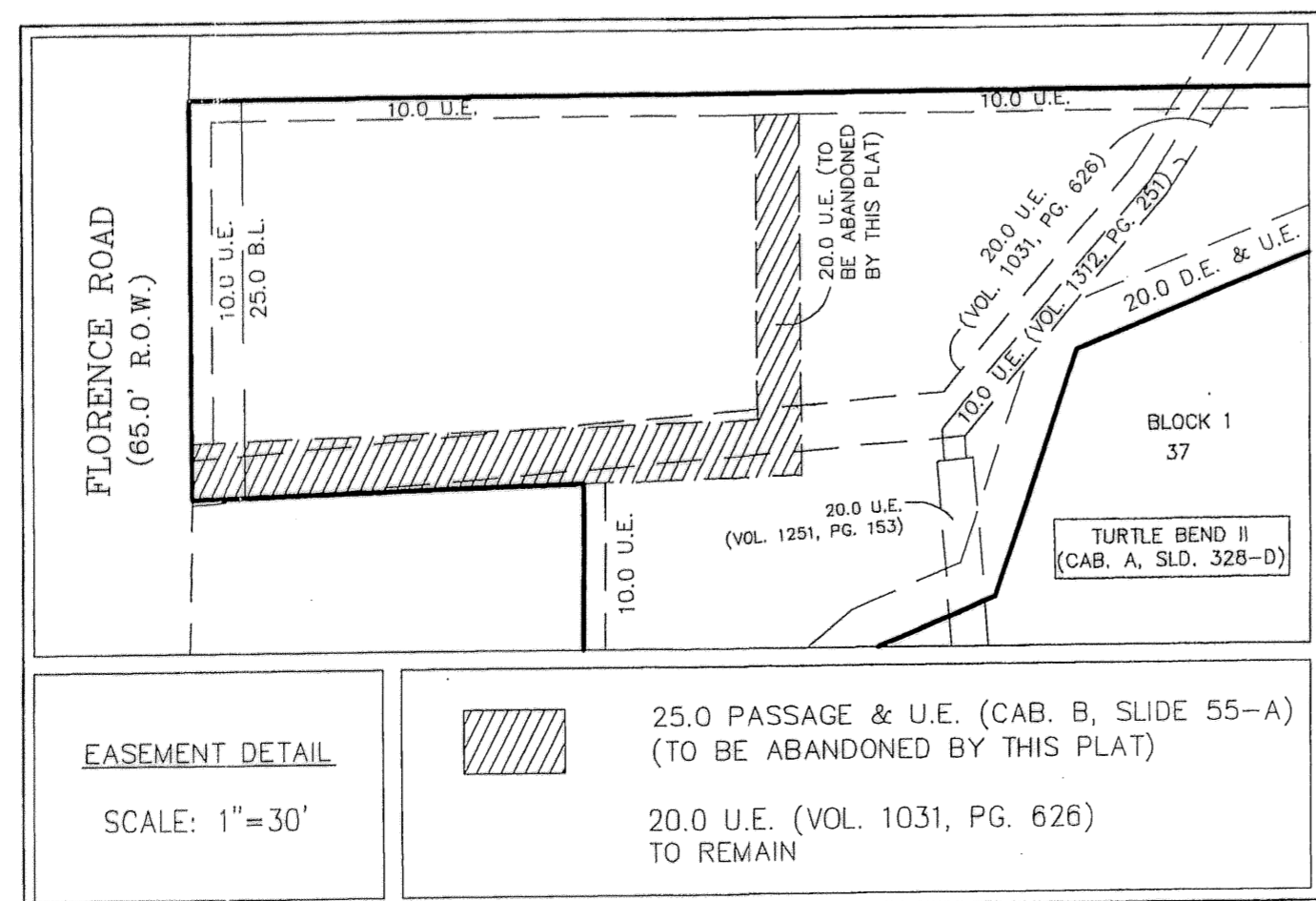
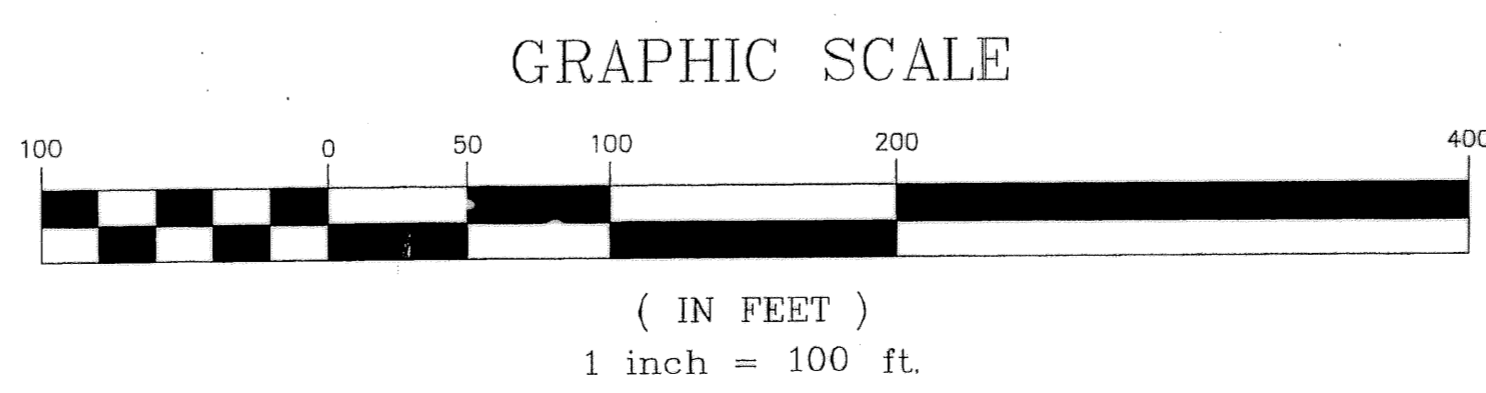


VICINITY MAP
