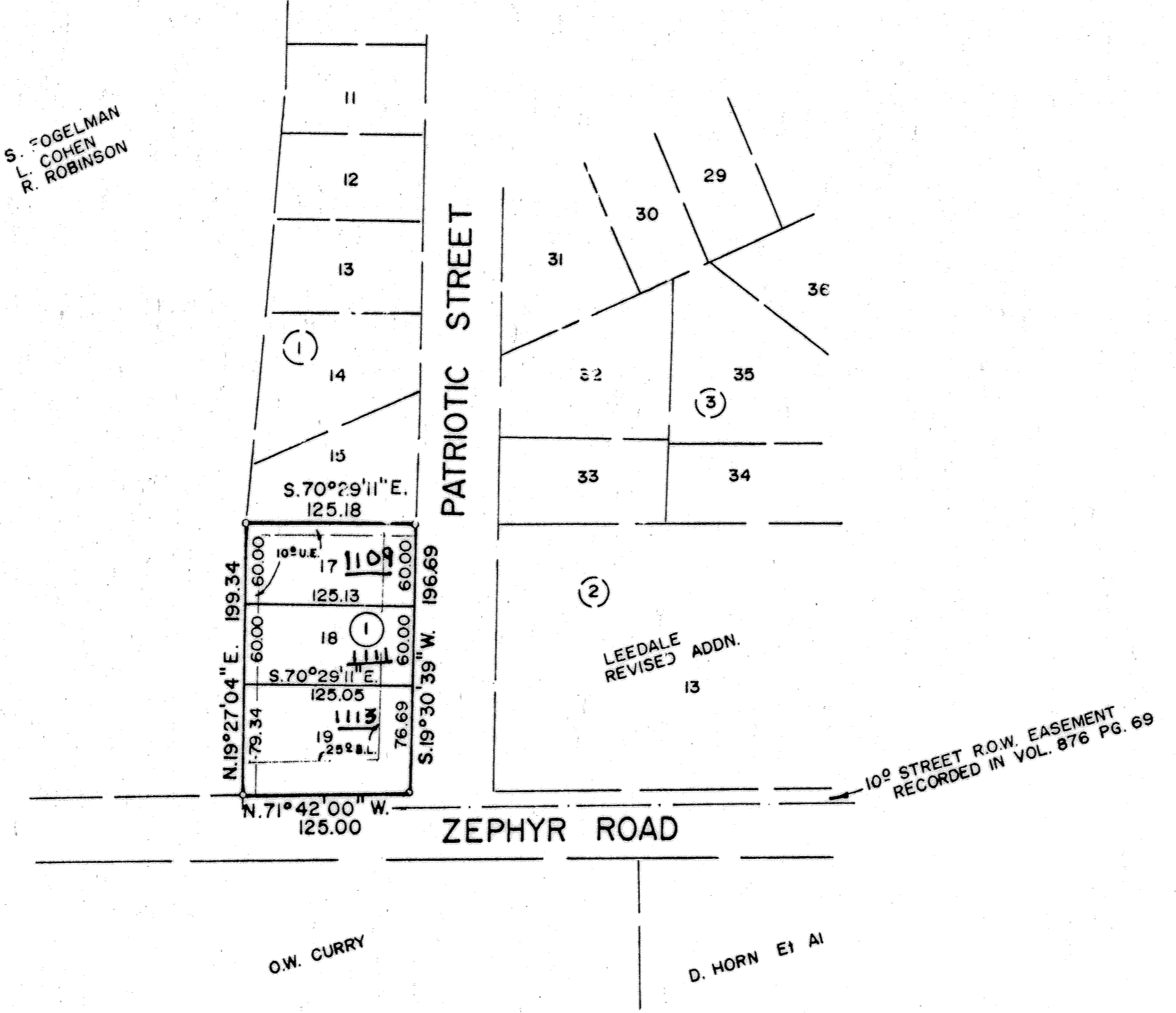
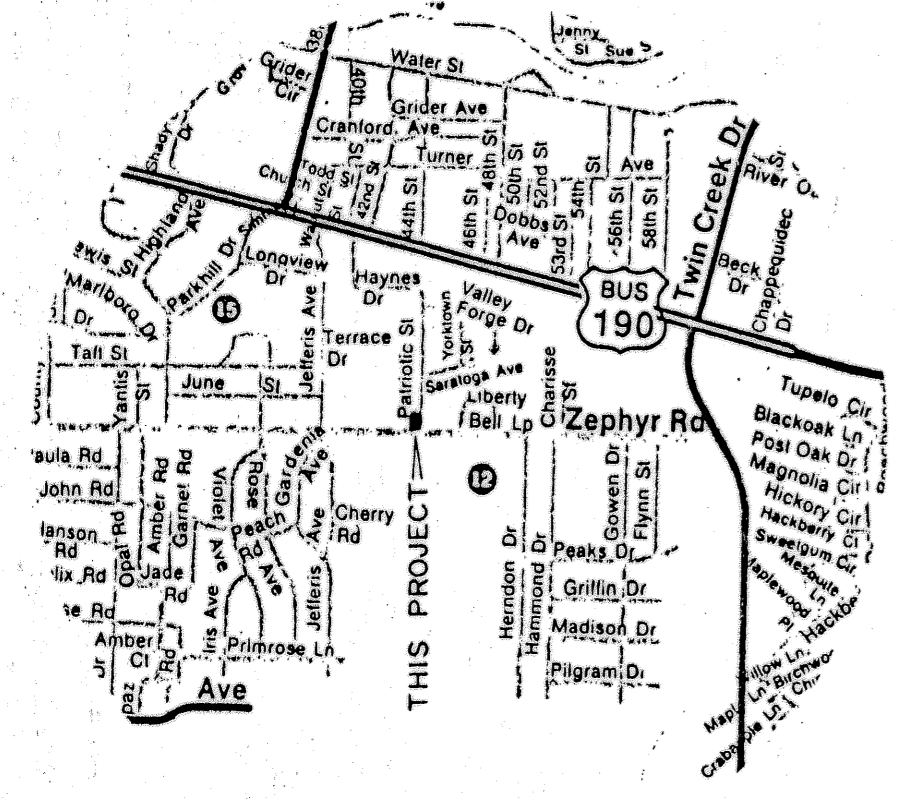


LOT 16 BLOCK 1 FREEDOM VALLEY SUBDIVISION

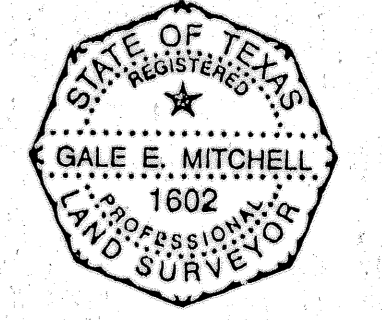
