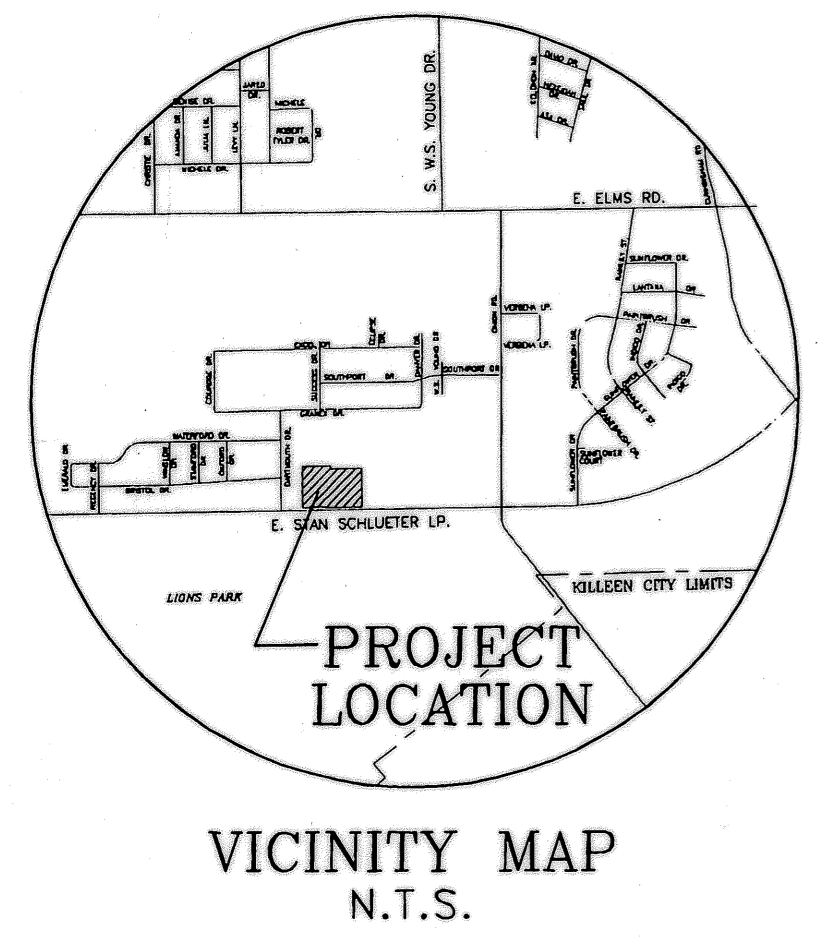


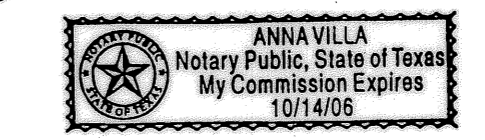
RUNOFF WATER ONTO AND ACCESS CONNECTION TO FM 3470 REQUIRES TxDOT PERMIT

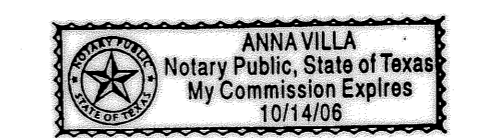
