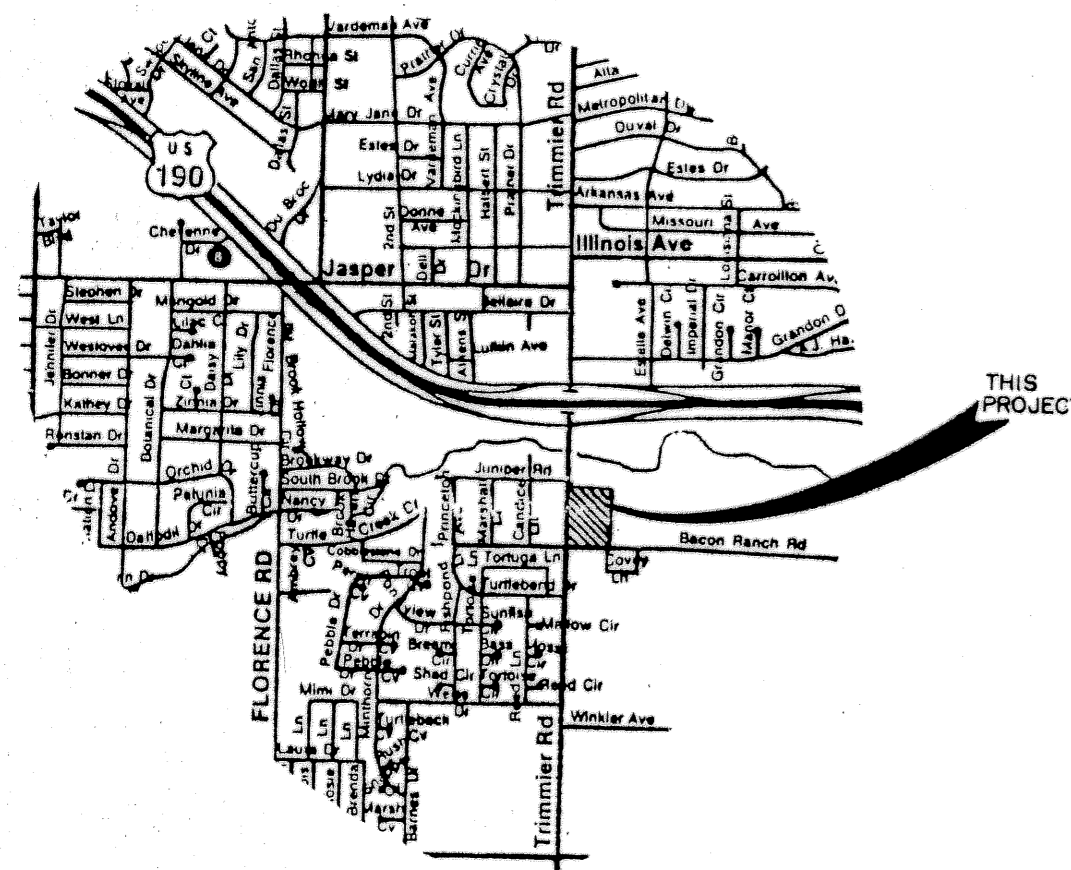
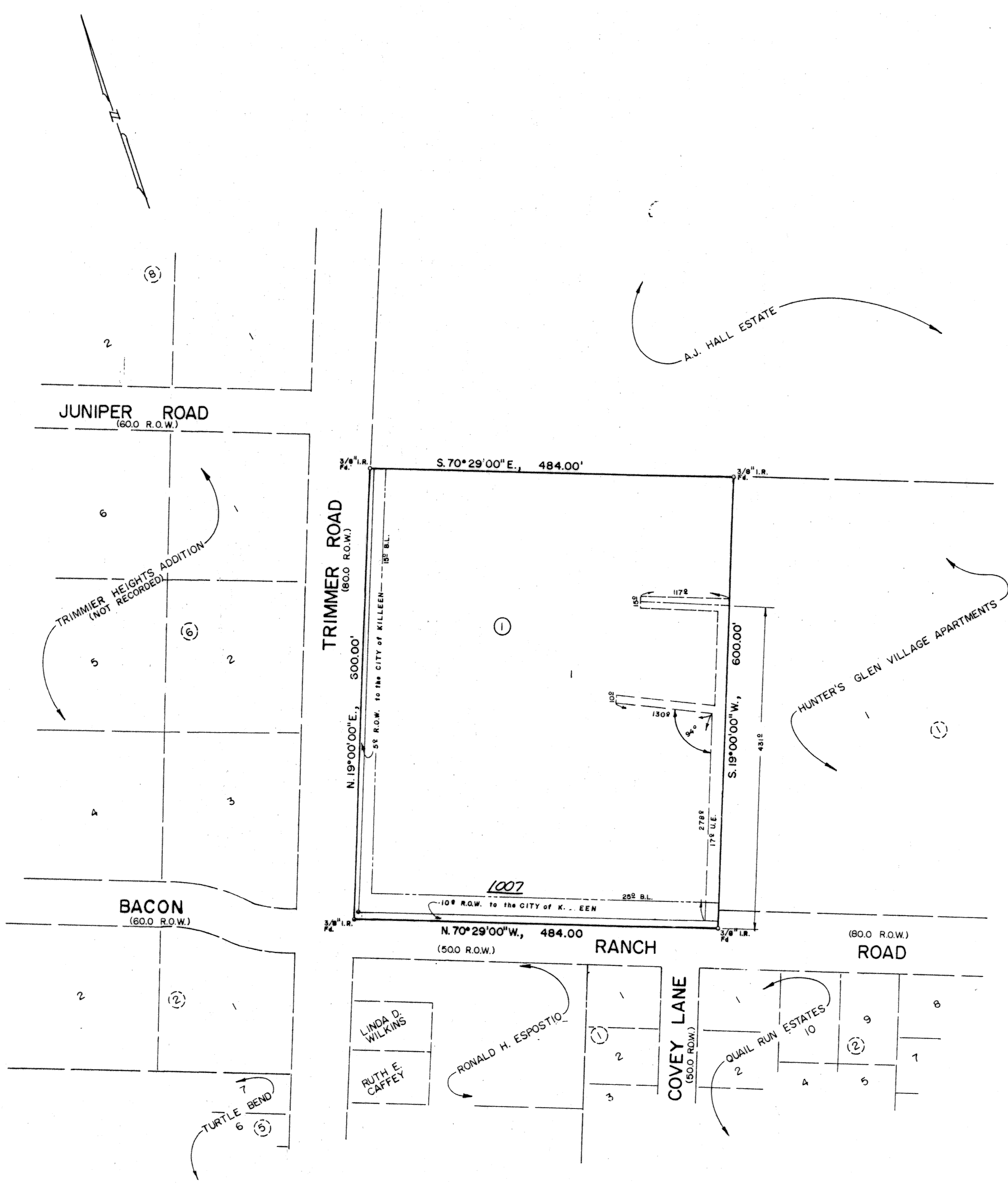


FLOOD MAP

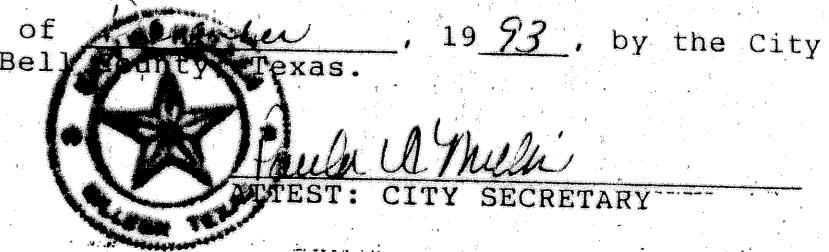
