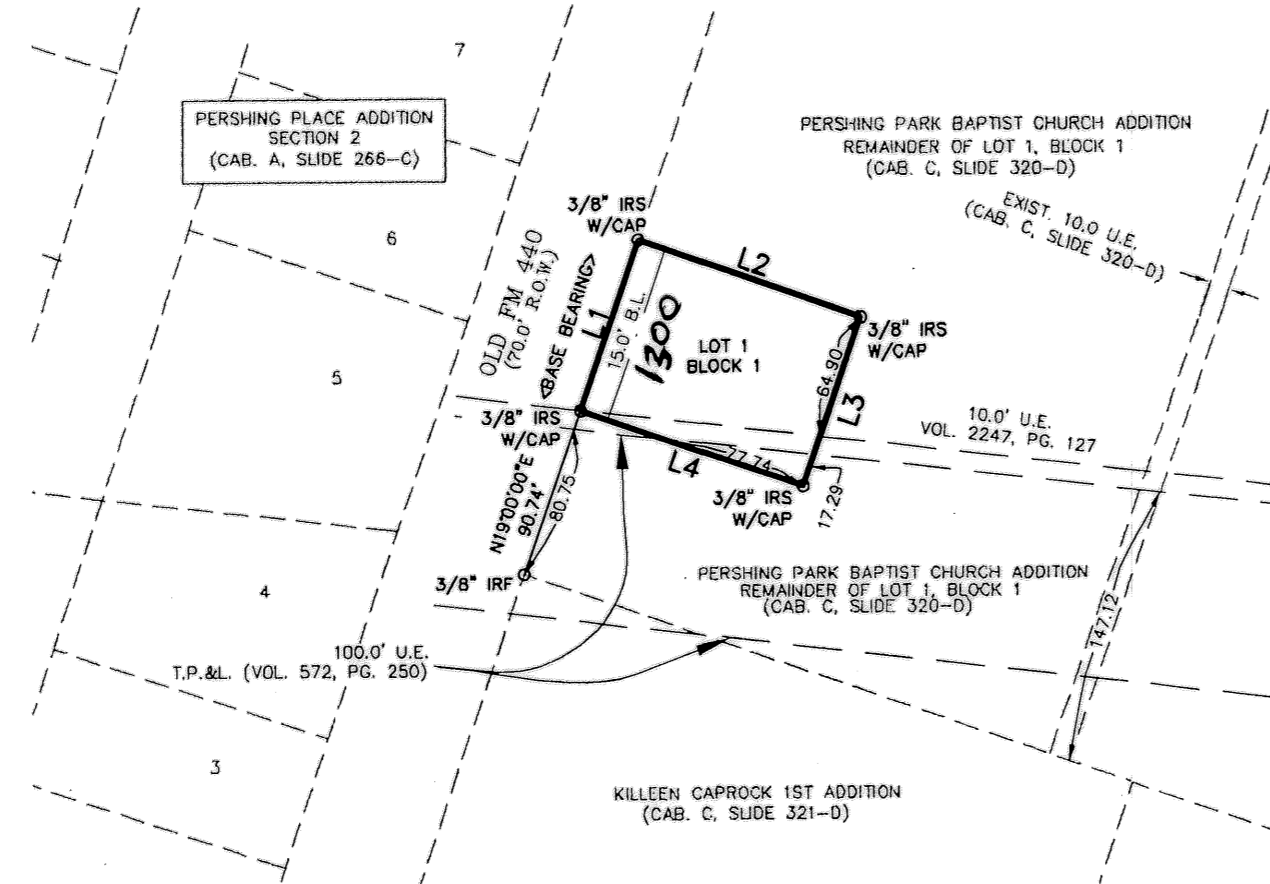
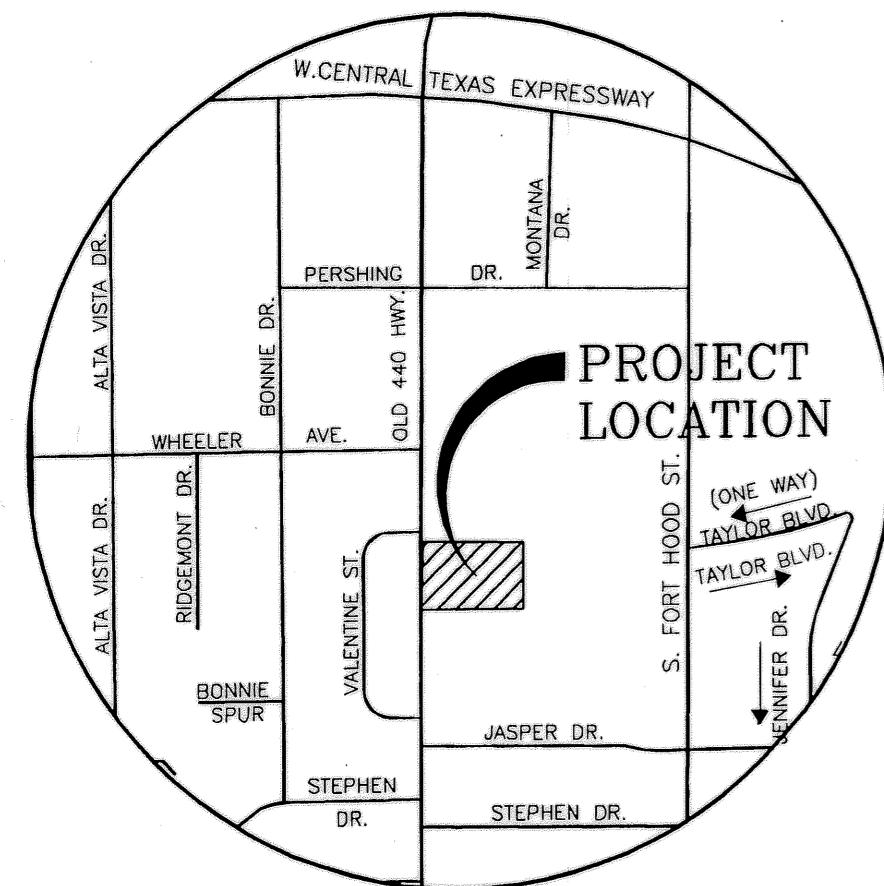


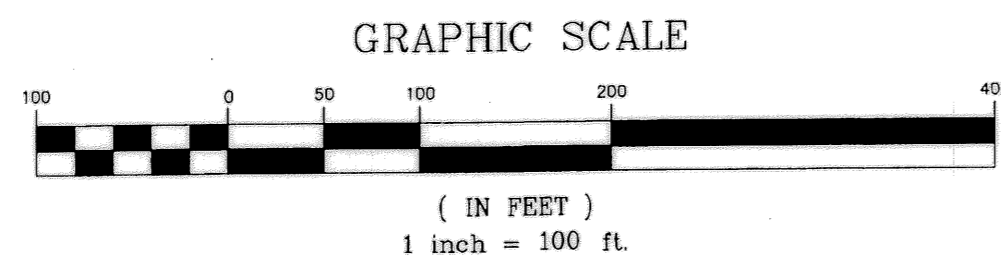
PERSHING PARK BAPTIST CHURCH ADDITION

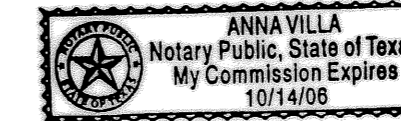
