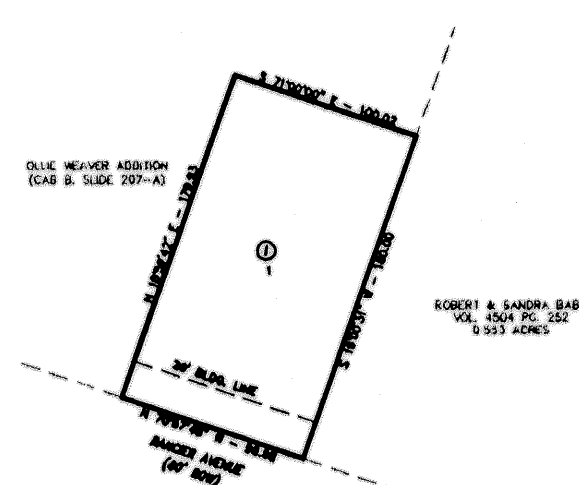


INSET "A"

(CAB B, SLIDE 207-A)



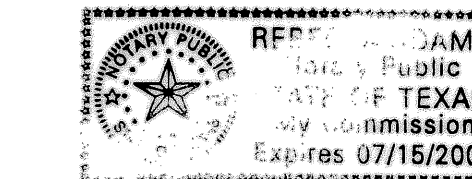

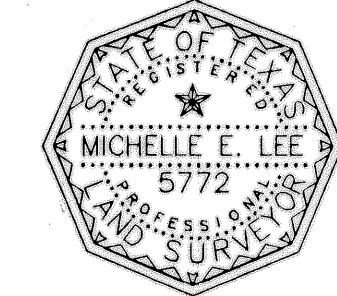

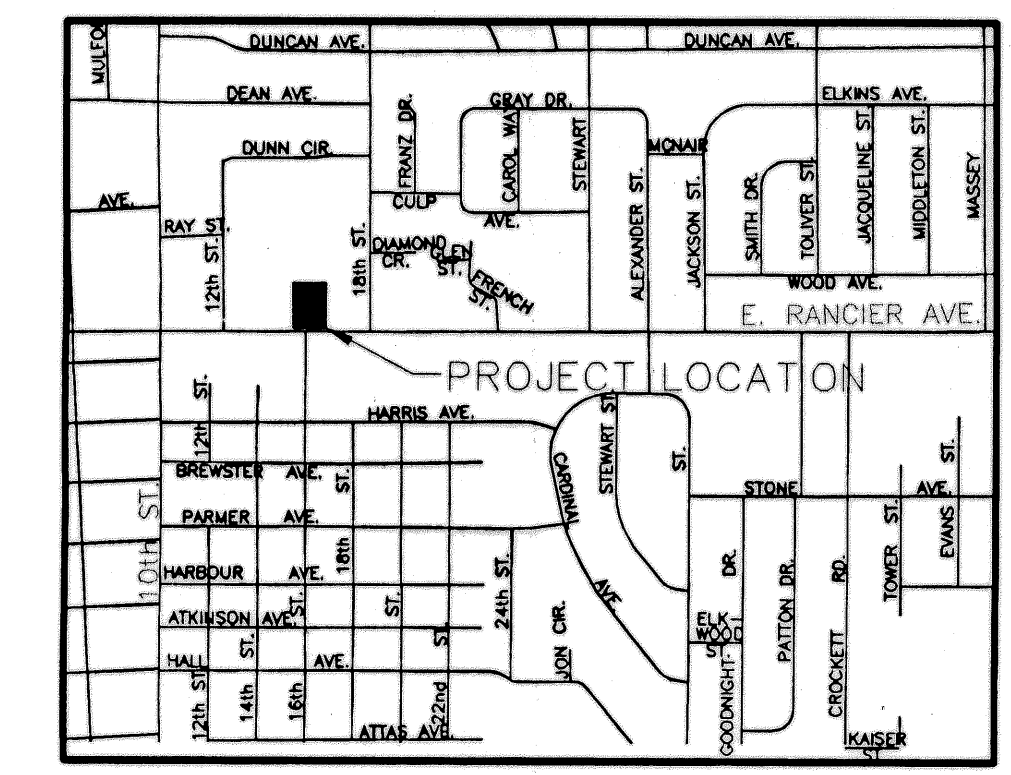
