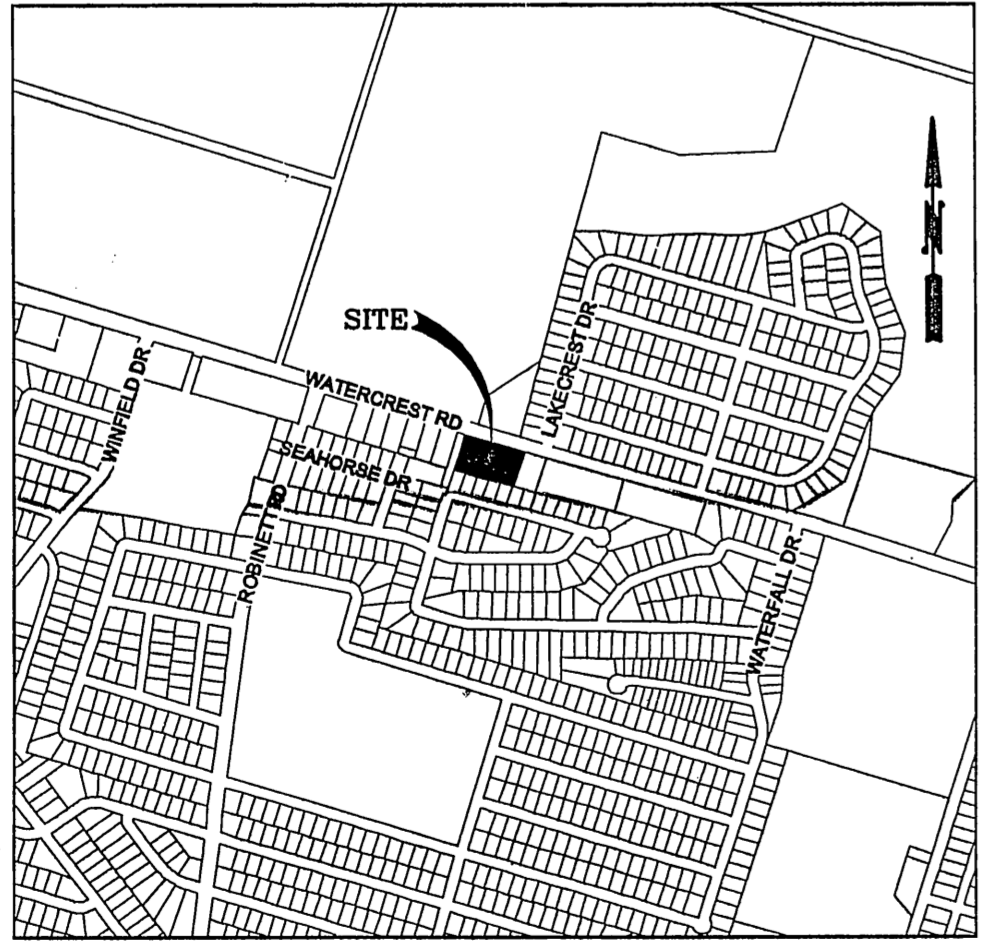
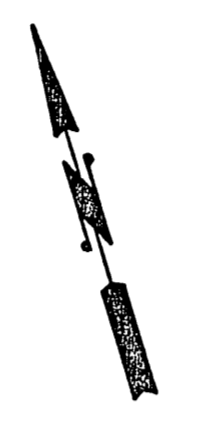

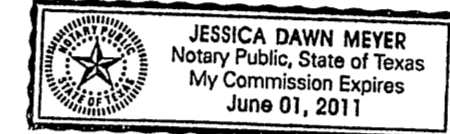
VICINITY MAP
