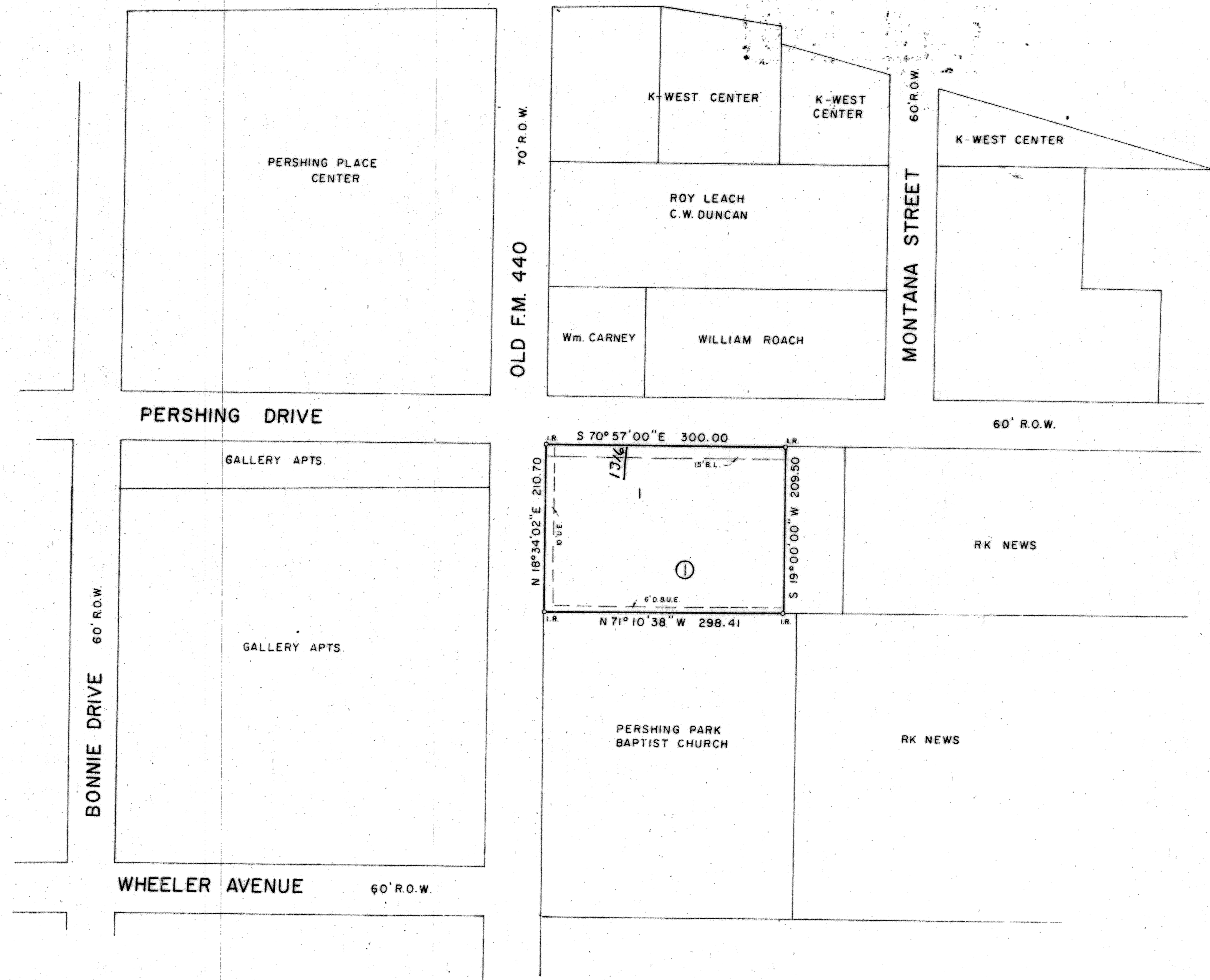


CENTRAL TEXAS EXPRESSWAY

R.O.W. VARIES

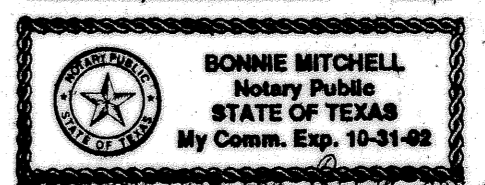

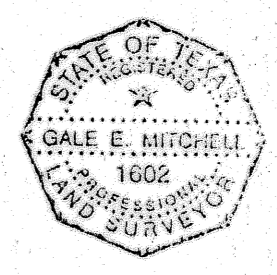

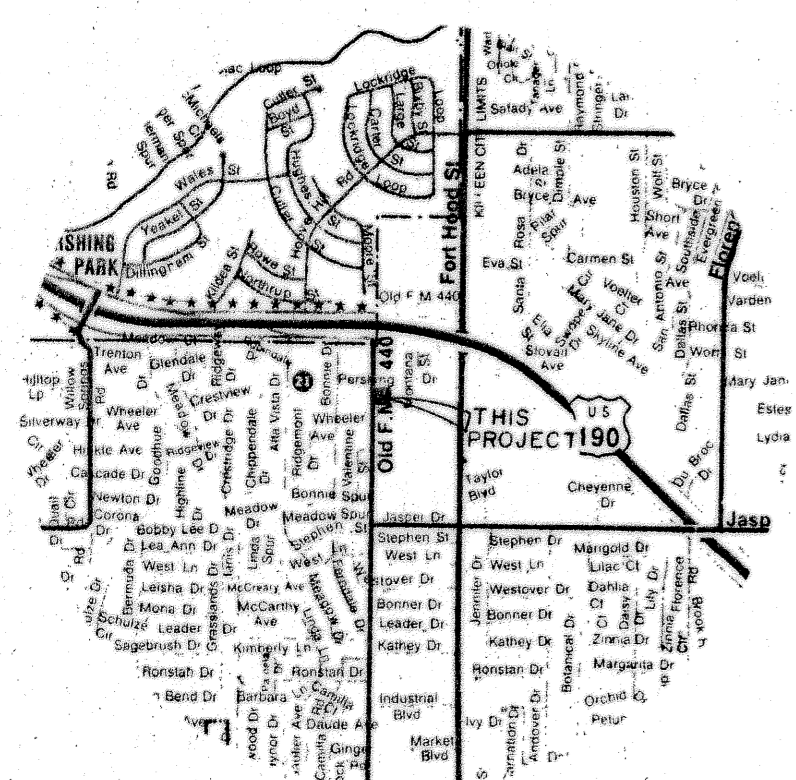
