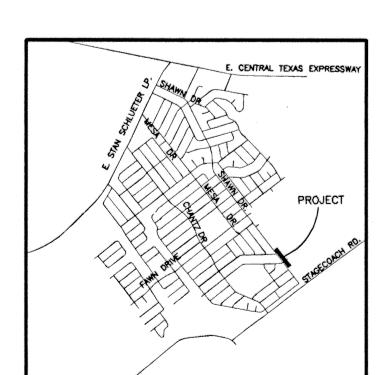


HYMESA ESTATES PHASE SEVEN, SECTION THREE (CAB. C, SLIDE 95-D & 96-A)
