KNOW ALL MEN BY THESE PRESENTS: that we Curtis Chafin and wife Charlotte A. 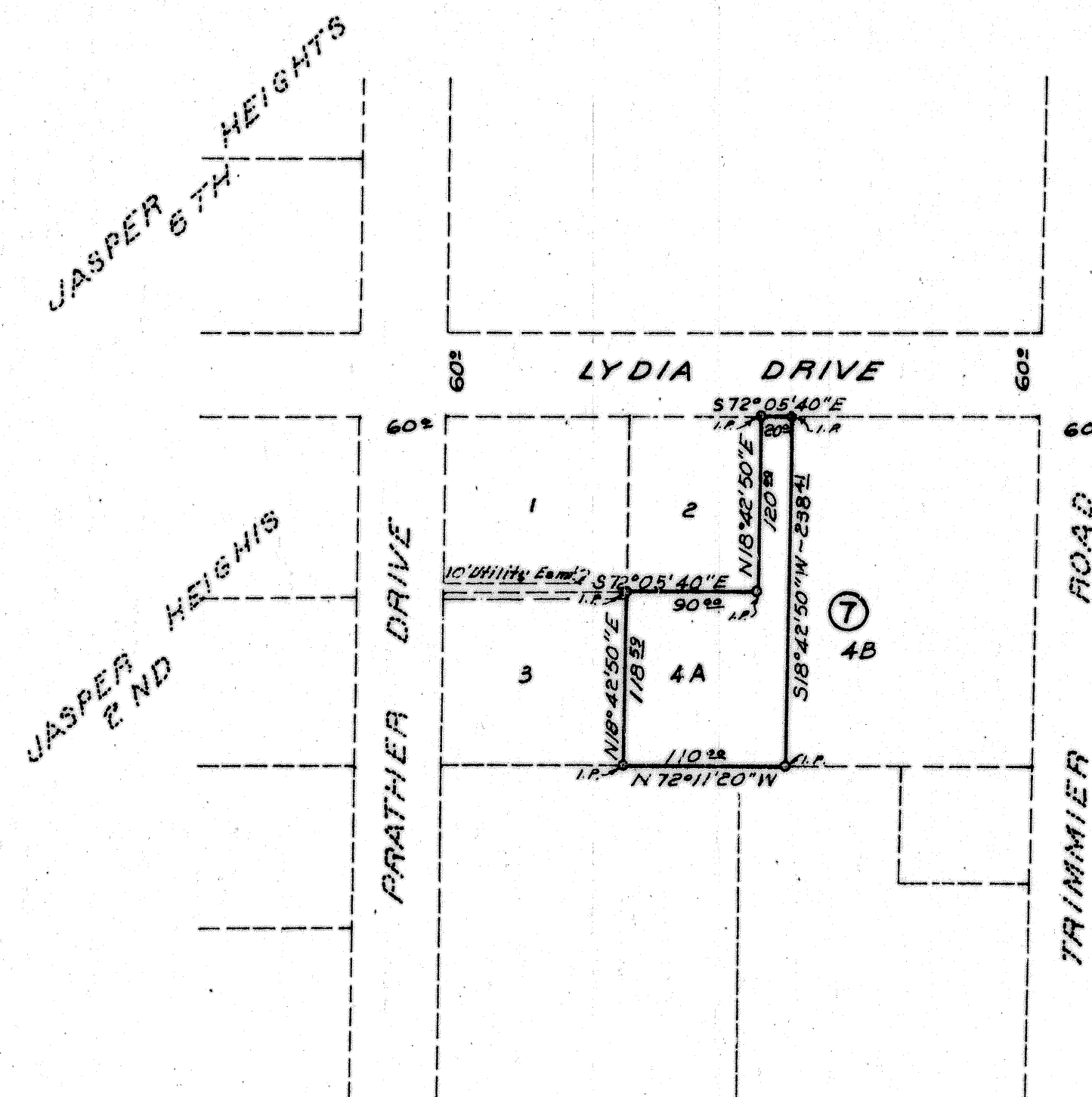

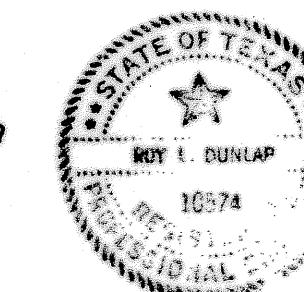
