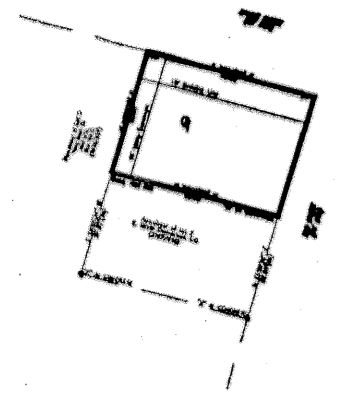
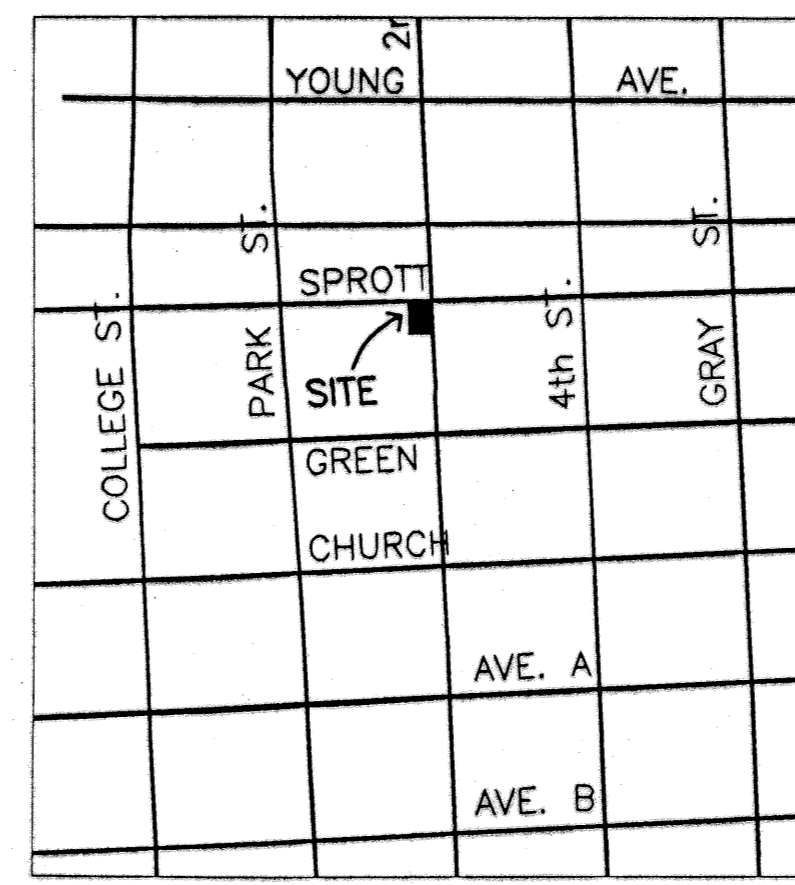
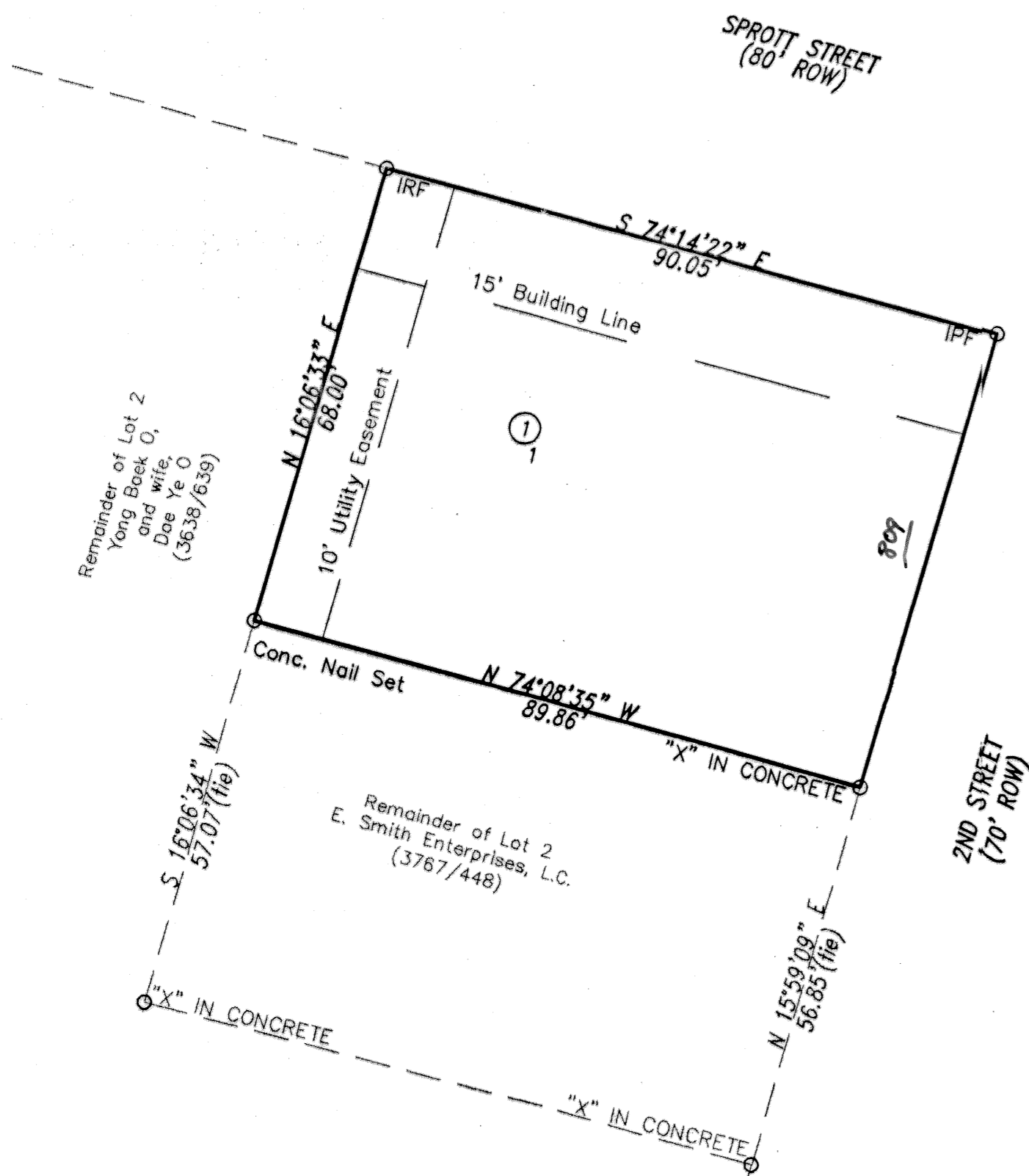
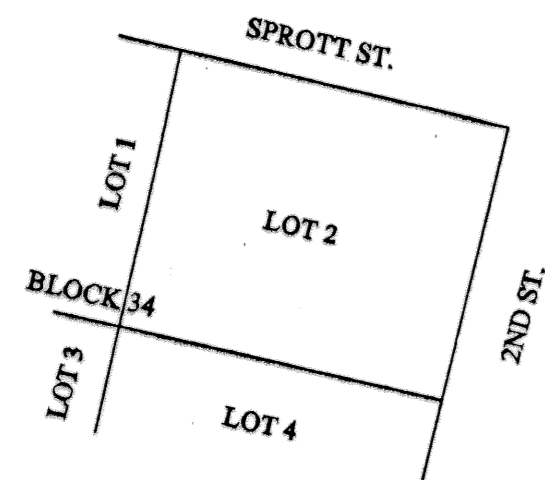


Inset A

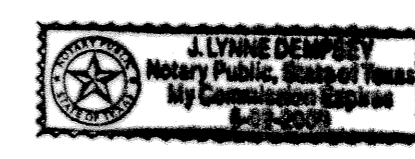

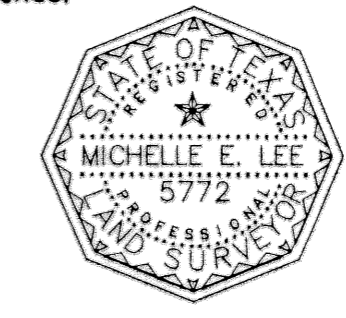
