



Box 579, Killeen, Texas, 76540, being the sole owner of that certain 1.598 acre tract out of the Alex Thompson Survey, Abstract No. 813, which is more fully described in the Dedication of a REPLAT OF LOTS 1 AND 2, BLOCK 59, ORIGINAL TOWN OF KILLEEN, as shown by the plat hereof, attached hereto, and made a part hereon, and approved by the Planning and Zoning Commission of the City of Killeen, Bell County, Texas, and K. B. C. CORPORATION does hereby adopt said REPLAT OF LOTS 1 AND 2, BLOCK 59, ORIGINAL TOWN OF KILLEEN, as an Addition to the City of Killeen, Bell County, Texas, and hereby dedicates to said City of Killeen all streets, avenues, roads, drives and alleys shown on said plat, the same to be used as public thoroughfares and for the installation and maintenance of public utilities when and as authorized by the City of Killeen. The utility easements shown on said plat are dedicated to said City for the installation and maintenance of any and all public utilities, which the City may install or permit to be installed or maintained.


