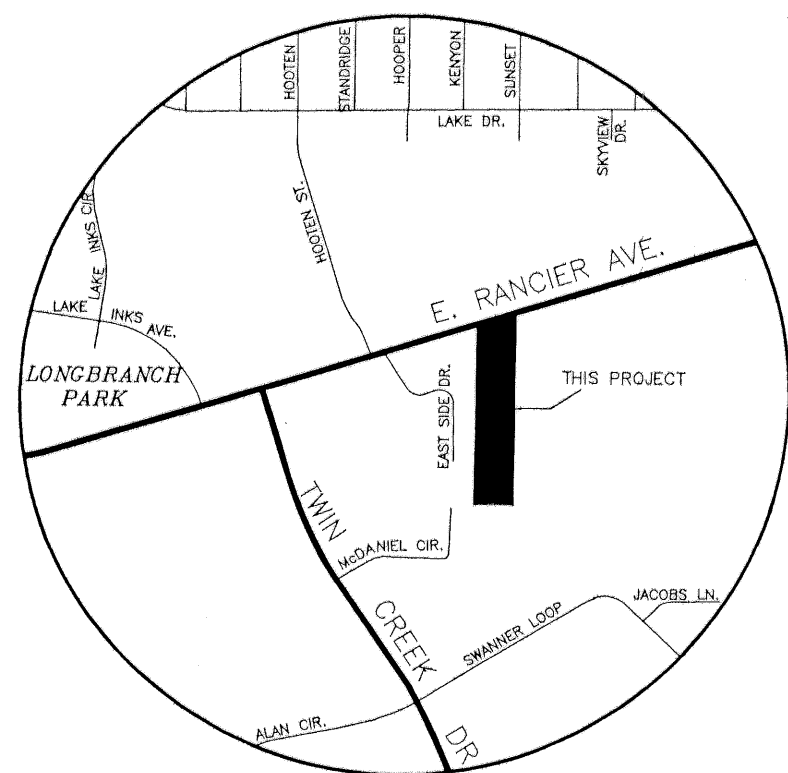
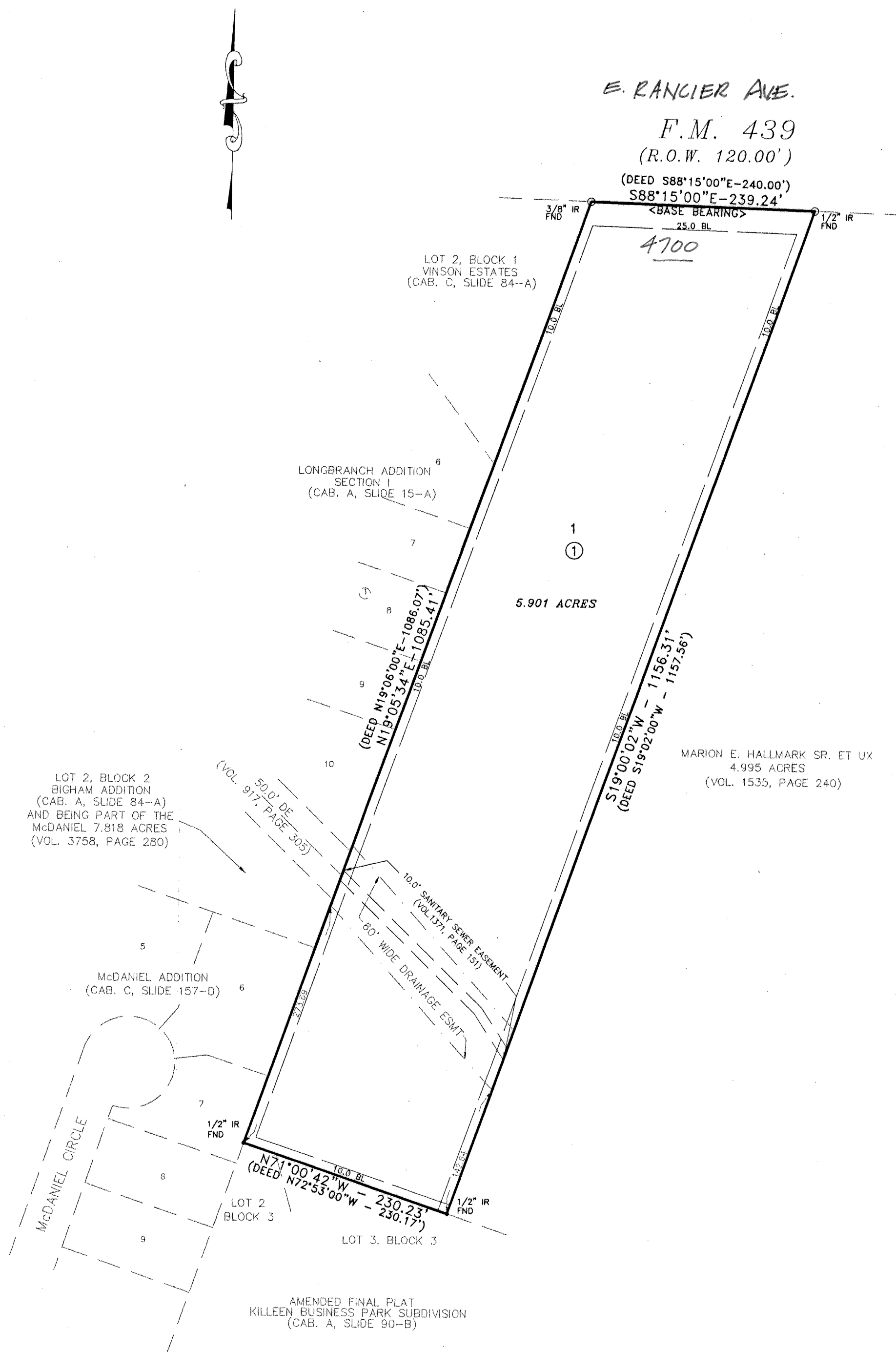


EASEMENT DETAIL

N.T.S.

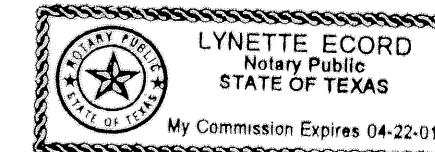

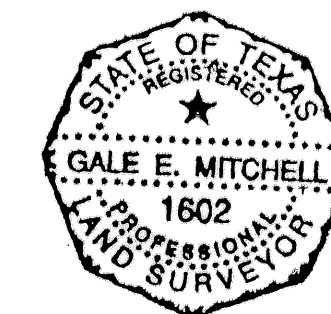
