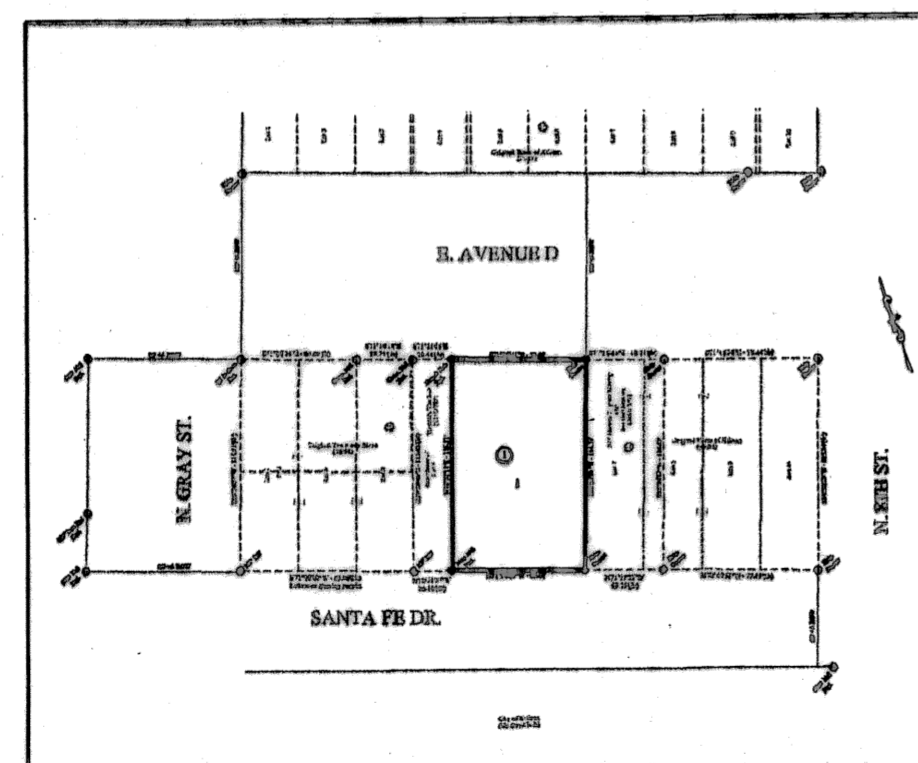
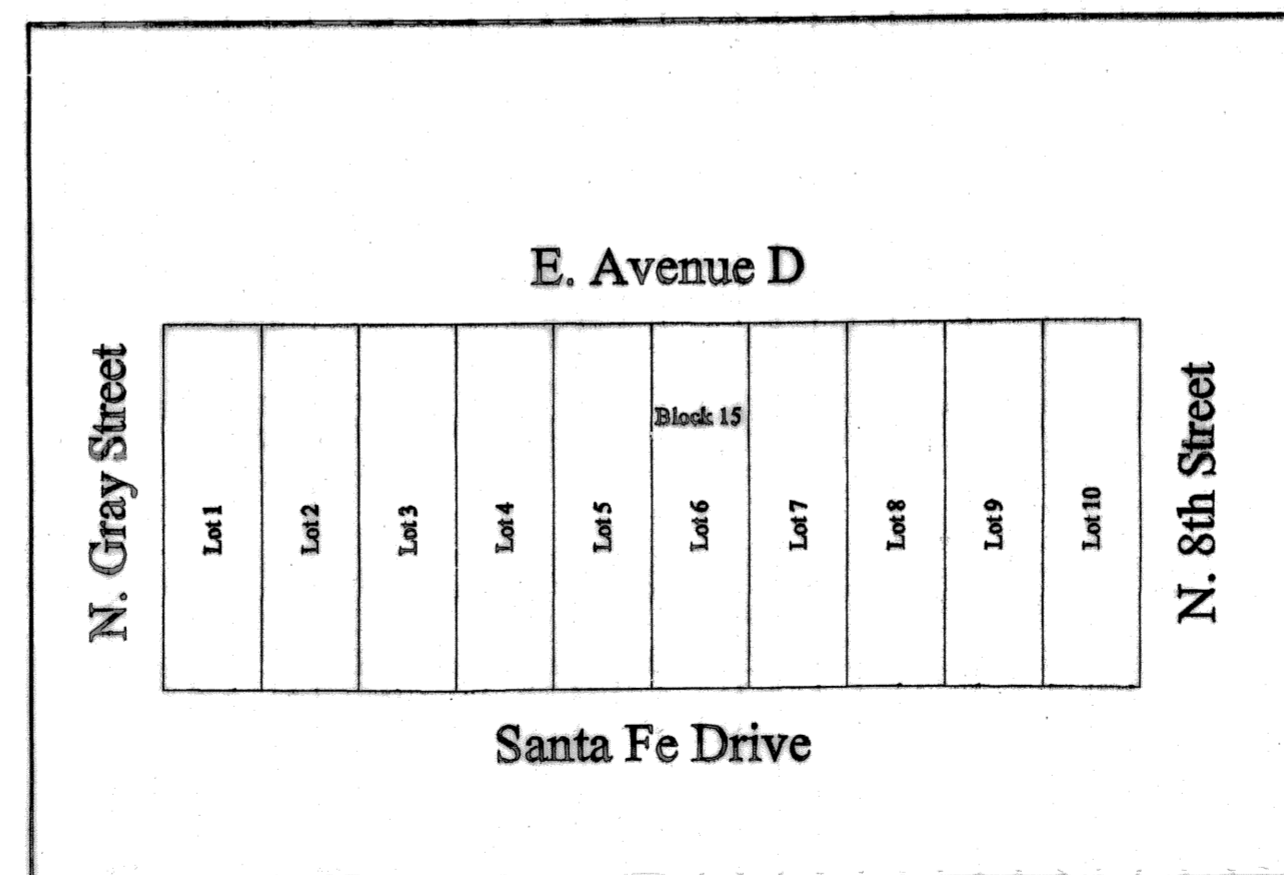


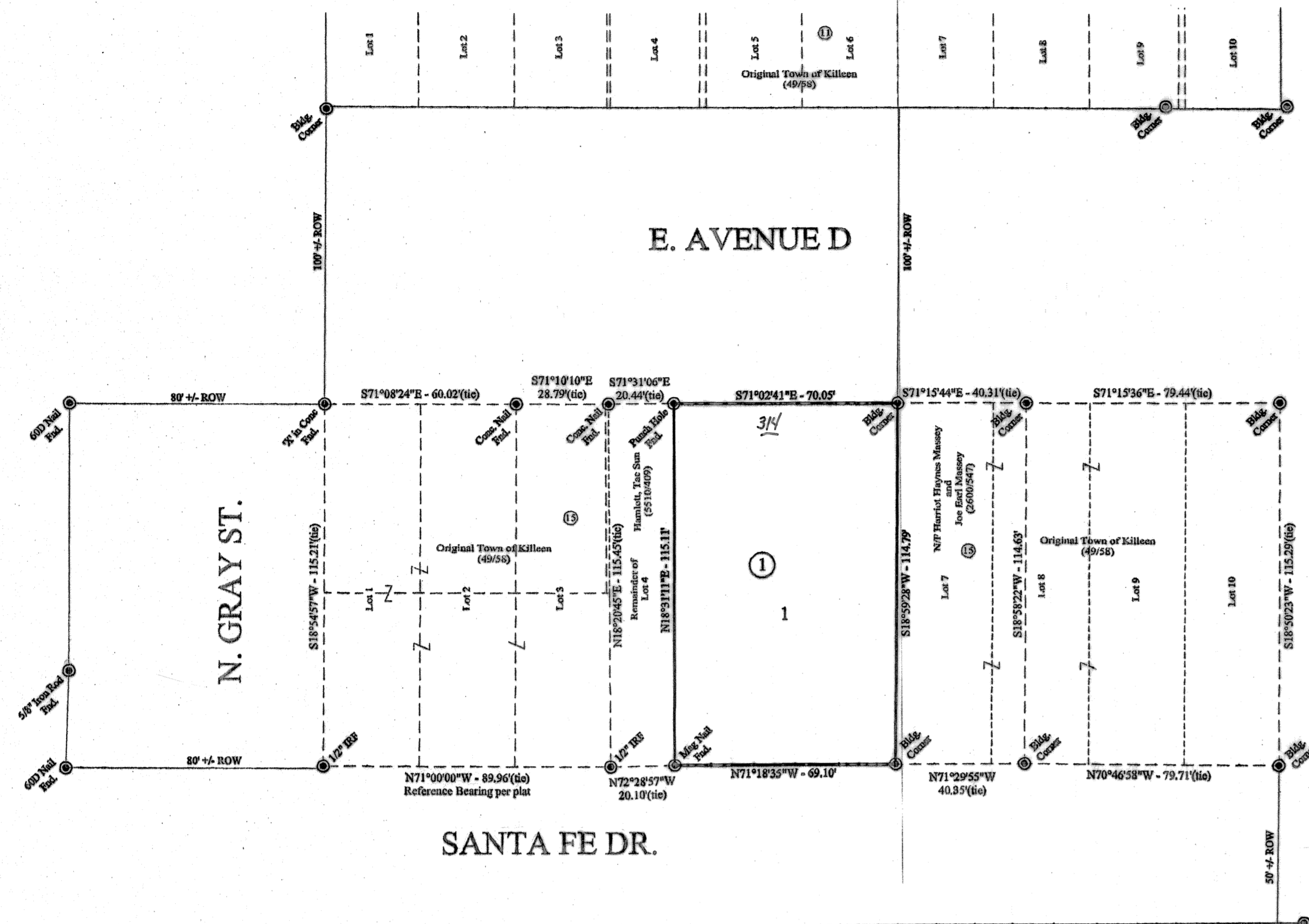
VICINITY MAP

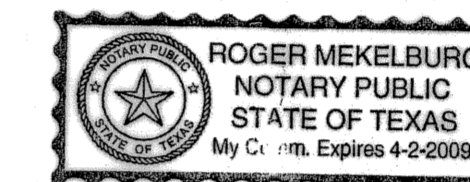

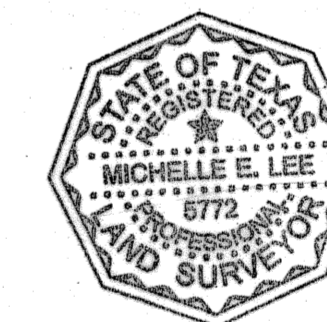
