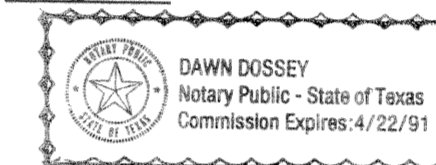

Cole Survey, Abstract No. 150, which is more fully described in the Dedication of KILLEEN UNITED KOREAN BAPTIST CHURCH SUBDIVISION, as shown by the plat hereof, attached hereto, and made a part hereof, and approved by the City Council of the City of Killeen, Bell County, Texas, and the KILLEEN UNITED KOREAN BAPTIST CHURCH does hereby adopt said KILLEEN UNITED KOREAN BAPTIST CHURCH SUBDIVISION, as an Addition to the City of Killeen, Bell County, Texas, and hereby dedicates to said City all streets, avenues, roads, drives, alleys, and associated potable water, sanitary sewer and storm sewer systems, as shown on said plat and final construction drawings, the same to be used as public thoroughfares and public utilities, when and as authorized by the City of Killeen. The utility easements shown on said plat are dedicated to said City for the installation and maintenance of any and all public utilities, which the City may install or permit to be installed or maintained.

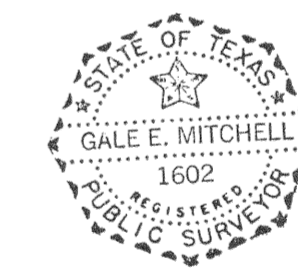
