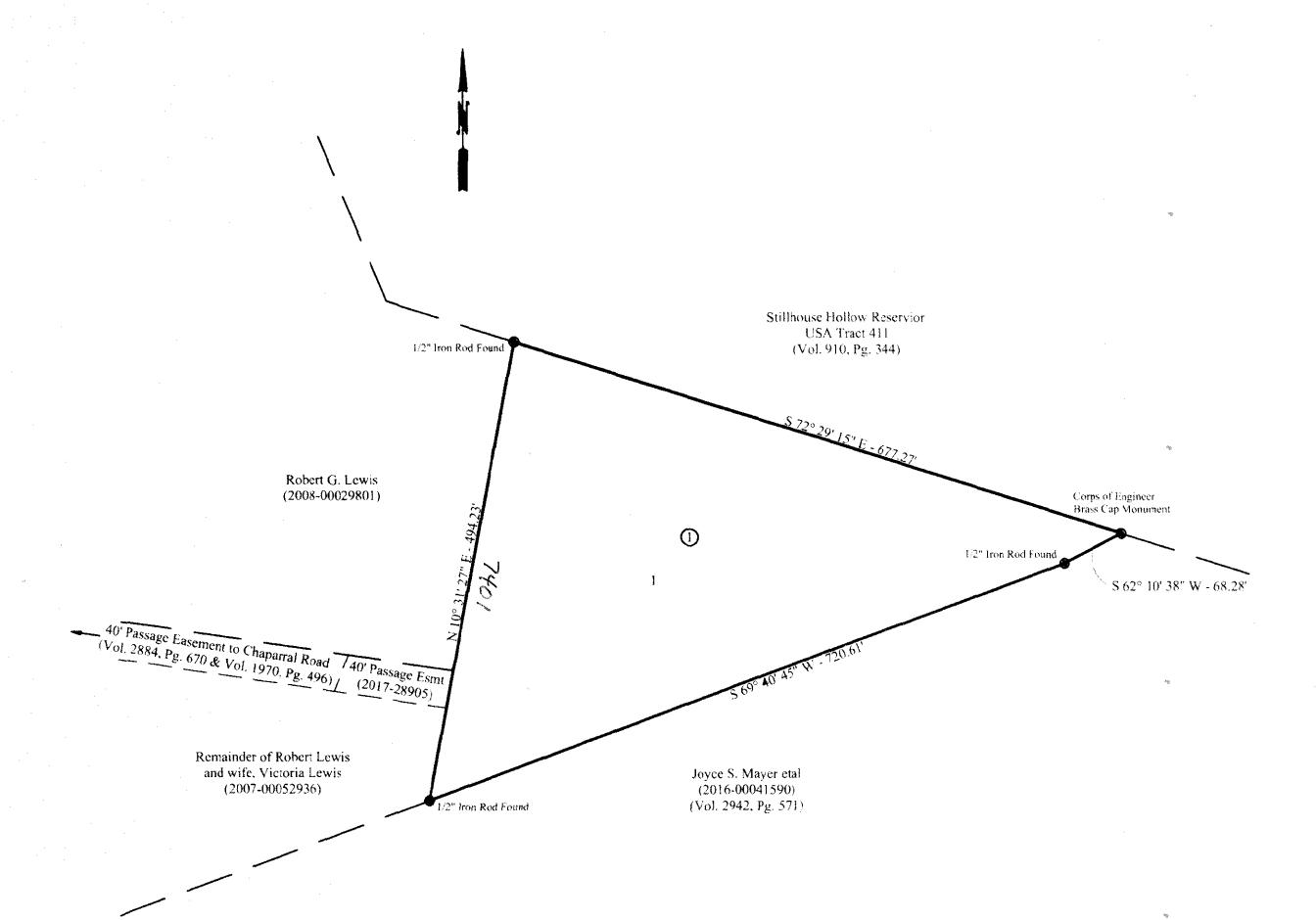
- 2. "DISTRICT RULES BASED ON CHAPTER 36 "TEXAS GROUNDWATER CODE" PREVENT THE DRILLING OF EXEMPT WELLS ON TRACTS OF LAND PLATTED TO LESS THAN 10 ACRES AFTER MARCH 1ST 2004. PERMITTING OF WELLS ON TRACTS LESS THAN 10 ACRES AND GREATER THAN 2 ACRES IS POSSIBLE UNDER DISTRICT RULES IF THE PURPOSE IS OF THE WELL MEETS THE DEFINITION OF BENEFICIAL USE. PER DISTRICT RULES AND CHAPTER 36, ALL DRILLING OF WELLS ON TRACTS OF LAND PLATTED TO LESS THAN 2 ACRES AFTER MARCH 1ST 2004, IS NOT POSSIBLE".
- 3. "PERMITS ARE RENEWED ANNUALLY BY STAFF IF THE SPECIAL CONDITIONS AND PROVISIONS CONTINUE TO REMAIN IN PLACE BY THE WELL OWNER. ANY CHANGE IN USE AND OR FAILURE TO PROVIDE ACCESS TO THE WELL FOR STATIC WATER LEVEL MEASUREMENTS AND/OR WATER QUALITY ASSESSMENT COULD NULLIFY THE PERMIT."

**DOMESTIC USE" MEANS THE USE OF GROUNDWATER BY AN INDIVIDUAL OR A HOUSEHOLD TO SUPPORT DOMESTIC ACTIVITY. SUCH USE MAY INCLUDE WATER FOR DRINKING, WASHING, OR CULINARY PURPOSES; FOR IRRIGATION OF LAWNS, OR FOR A FAMILY GARDEN AND/OR ORCHARD; WATER USE FOR DOMESTIC ANIMALS; AND FOR WATER RECREATION INCLUDING AQUATIC AND WILDLIFE ENJOYMENT. DOMESTIC USE DOES NOT INCLUDE WATER USED TO SUPPORT ACTIVITIES FOR WHICH CONSIDERATION IS GIVEN OR RECEIVED OR FOR WHICH THE PRODUCT OF THE ACTIVITY IS SOLD. 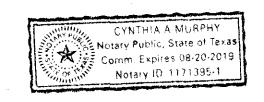
