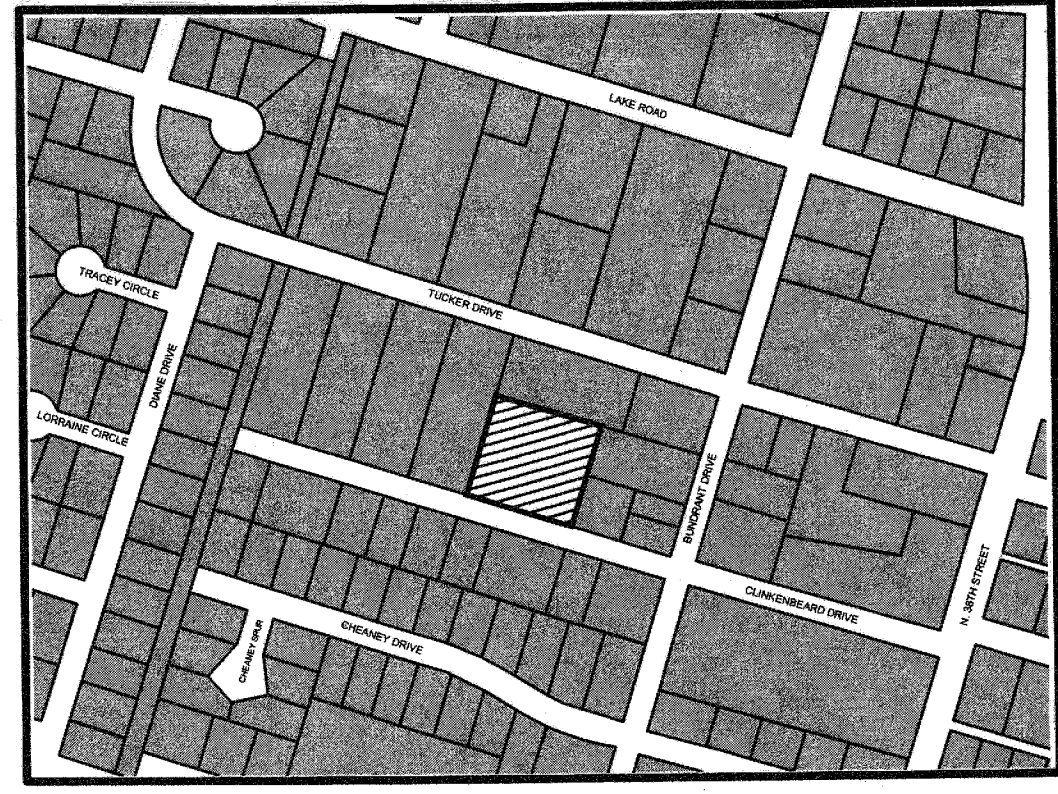
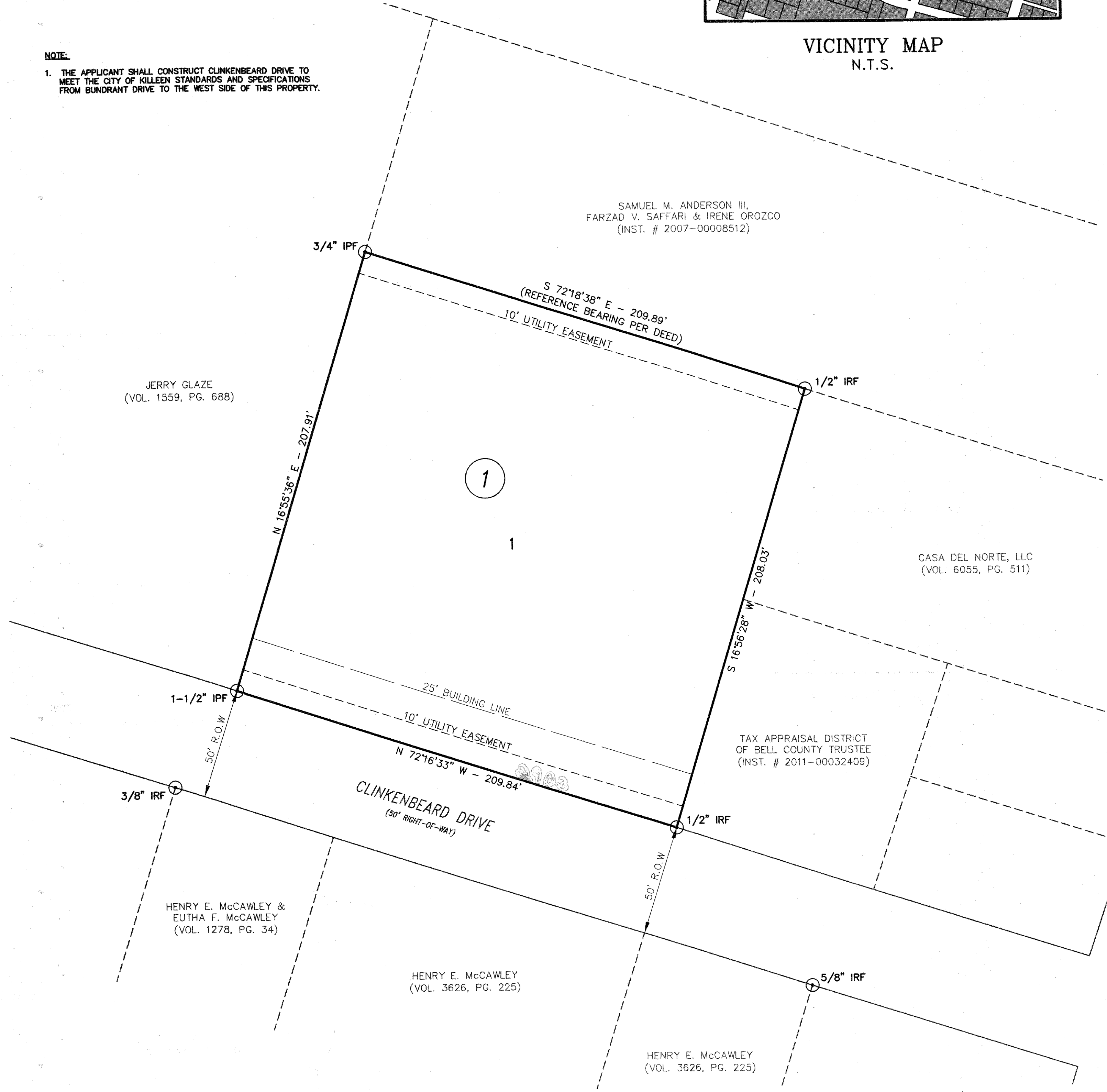


NOTE:

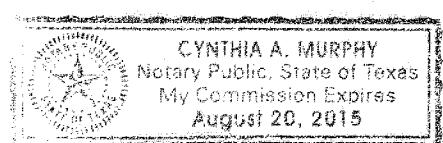

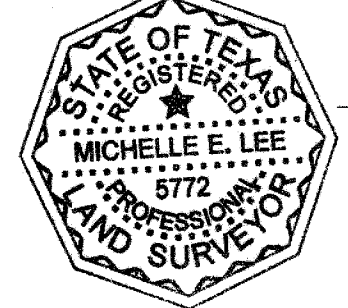
