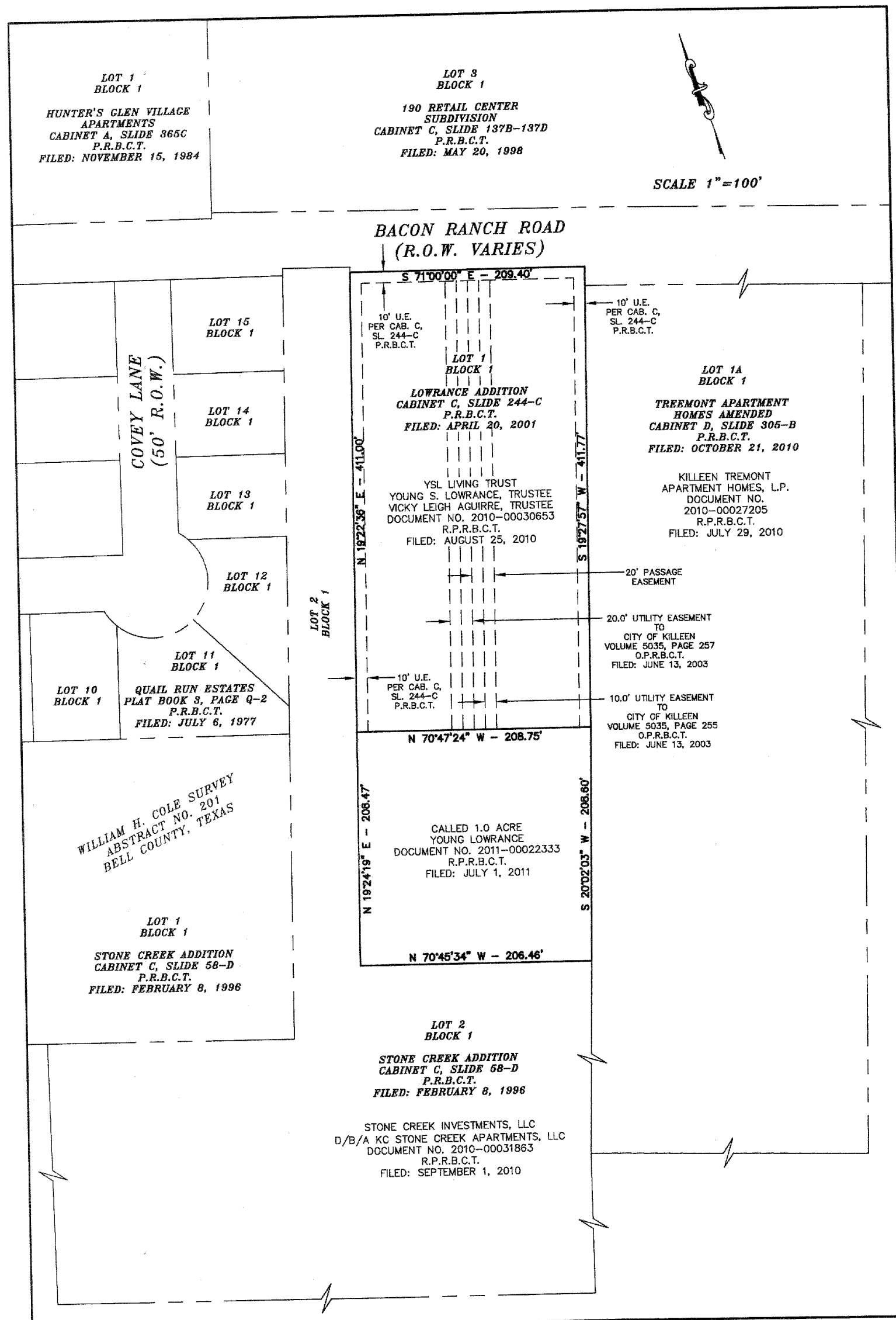
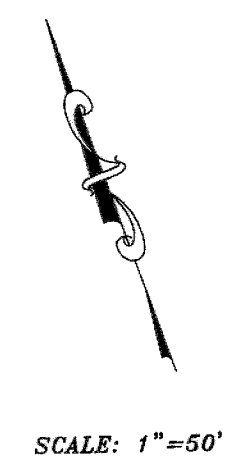
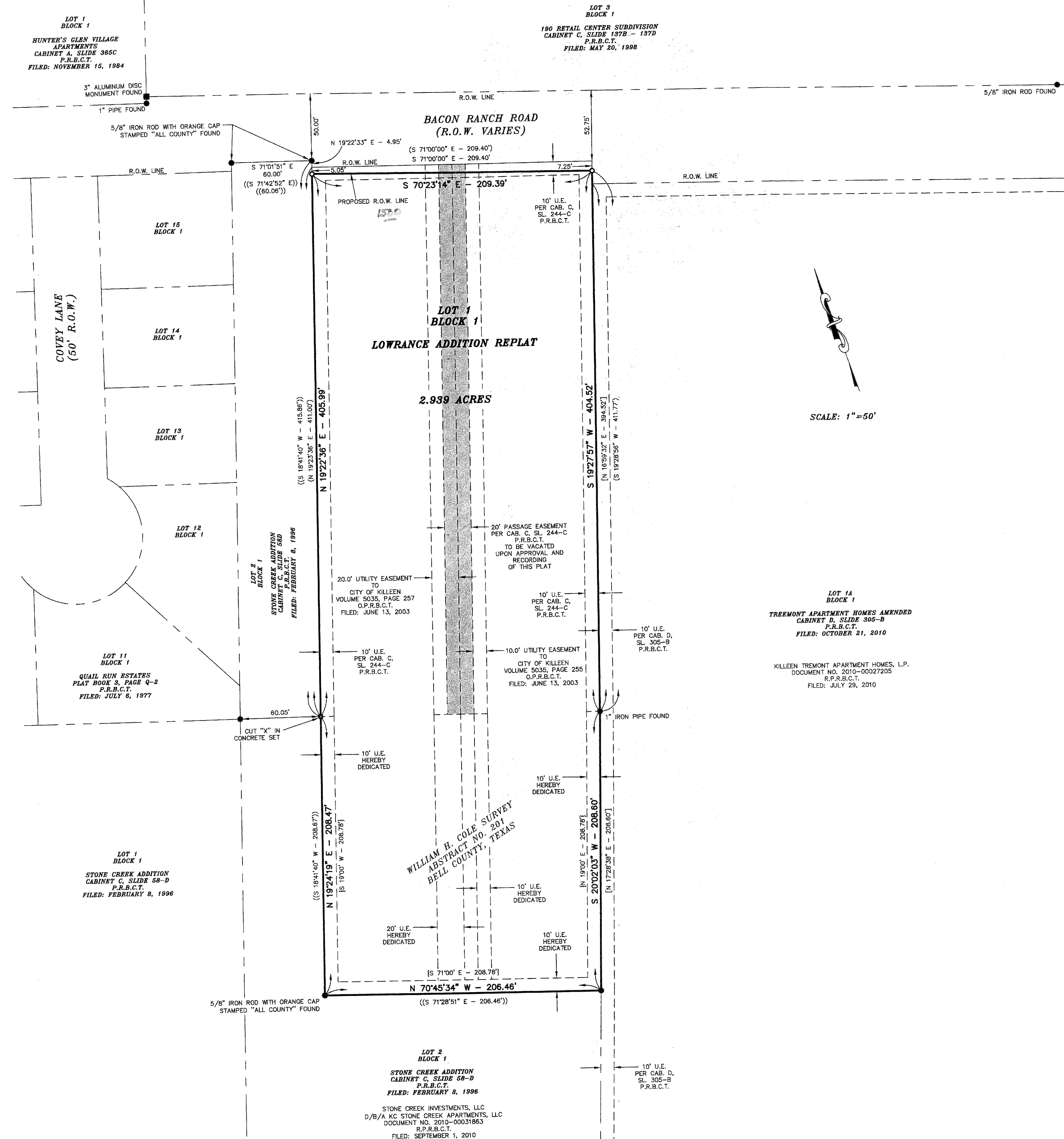


VICINITY MAP

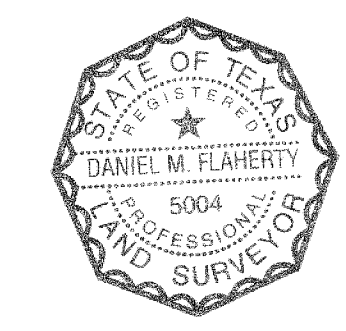
