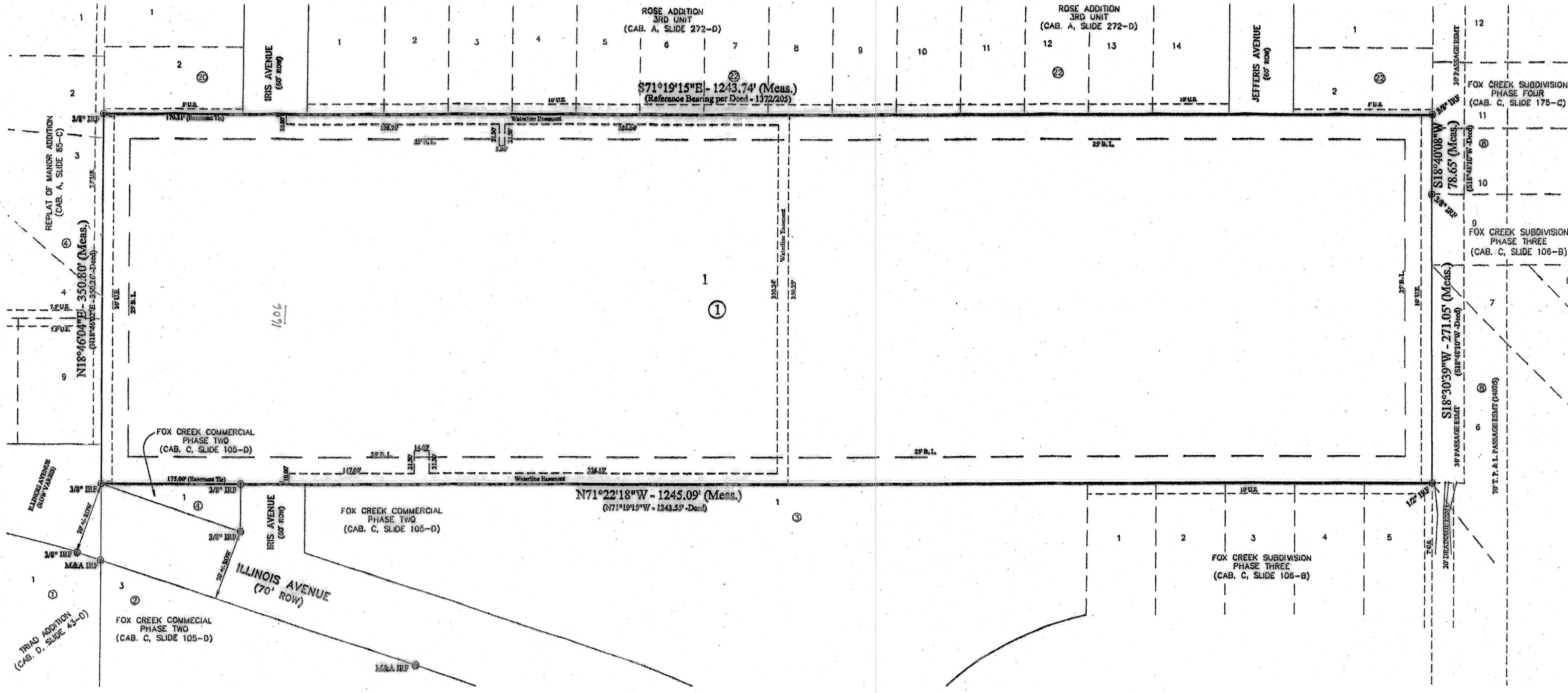


VICINITY MAP

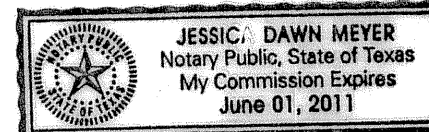
