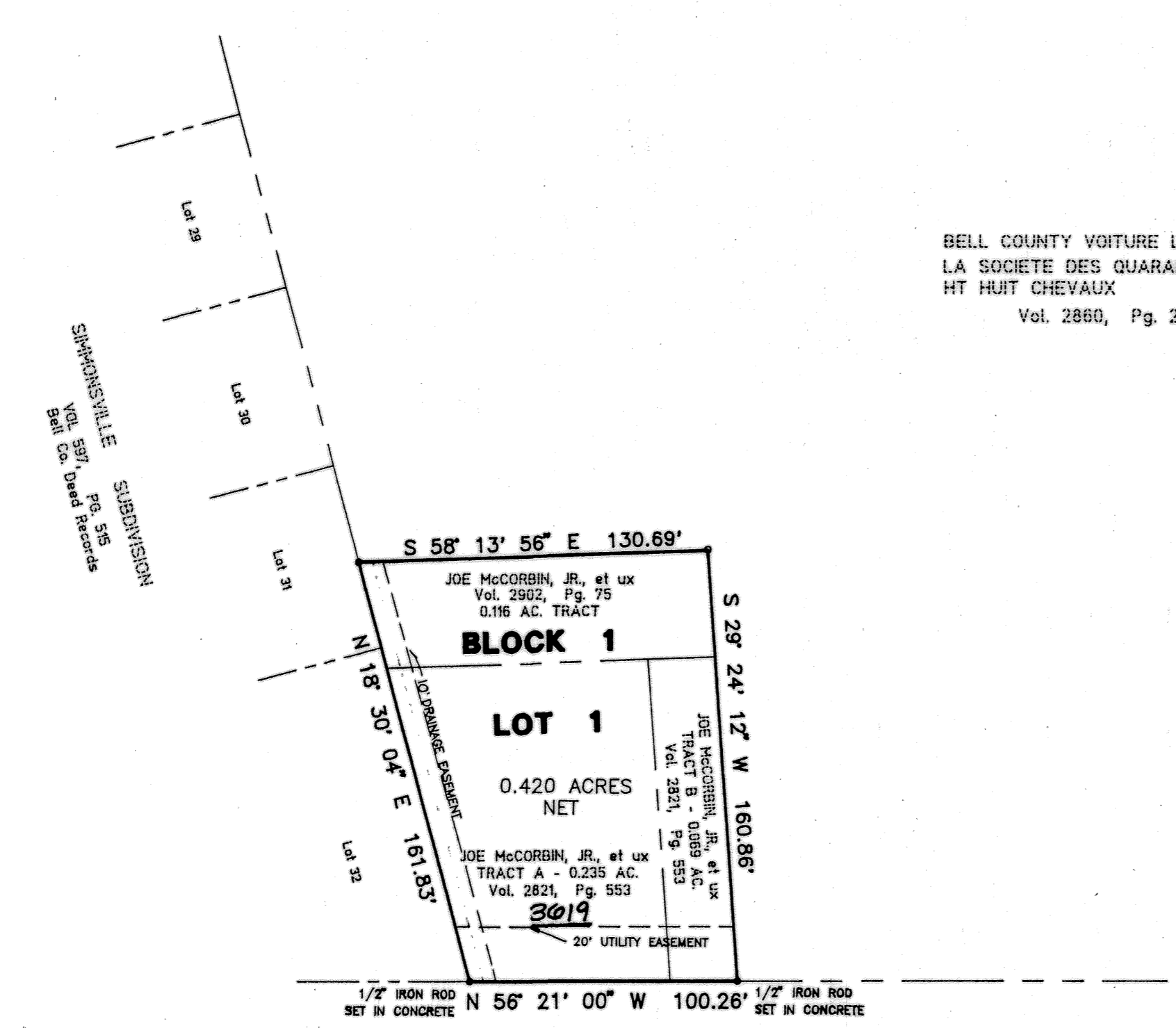


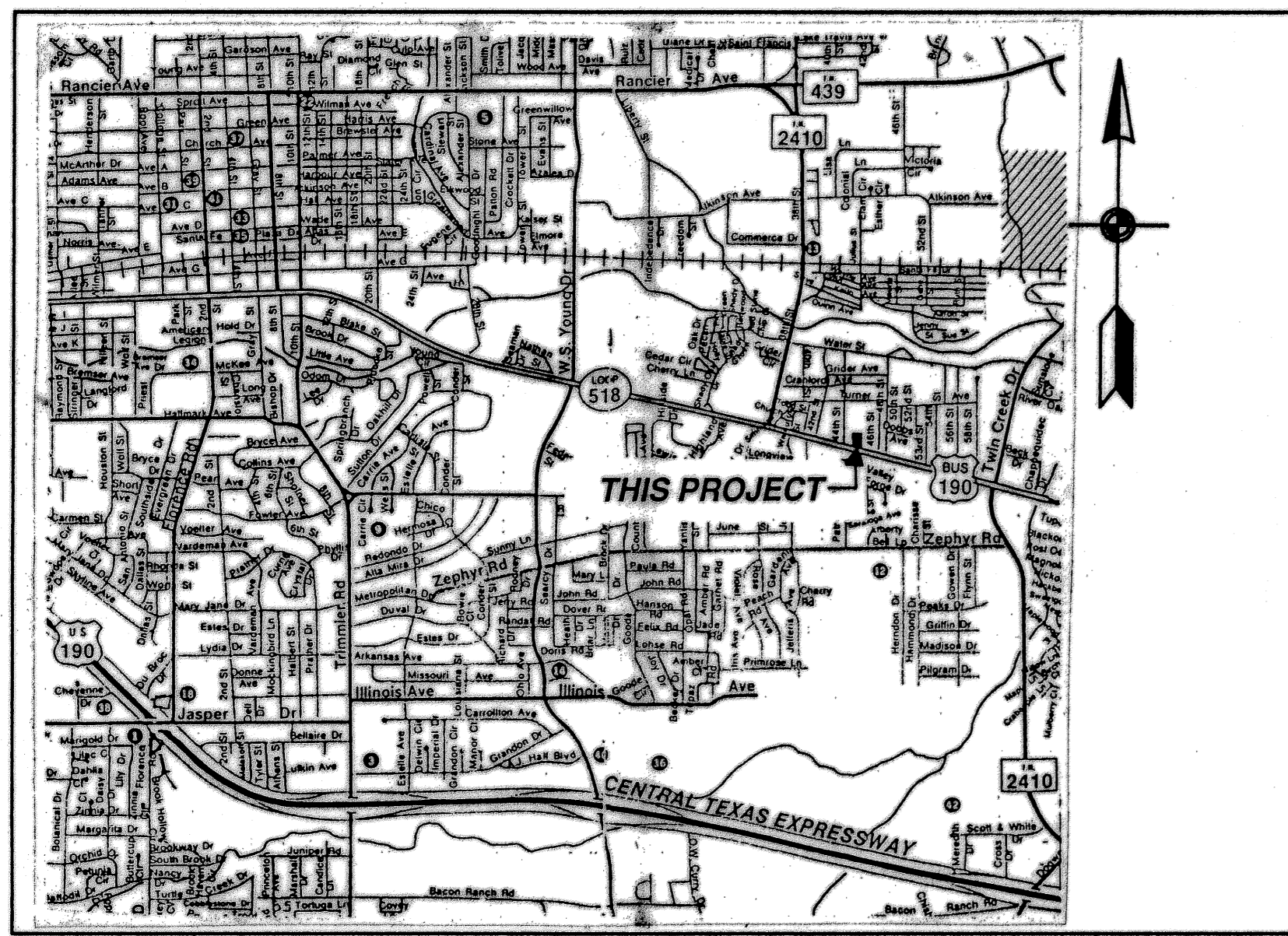

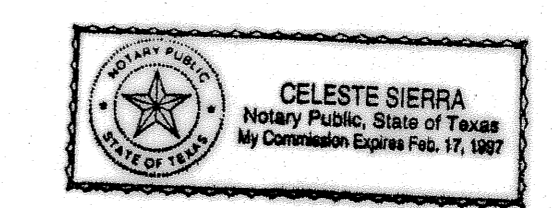
VICINITY MAP

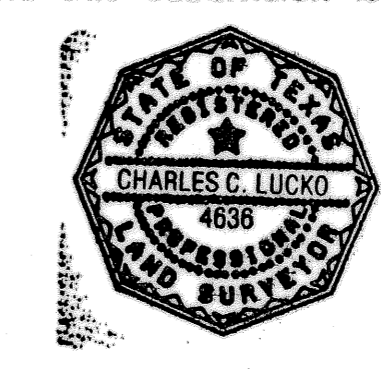
