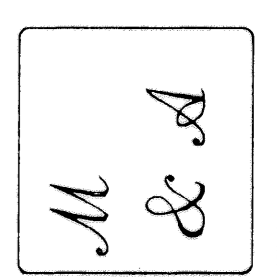

KILLEEN, BELL COUNTY, TEXAS

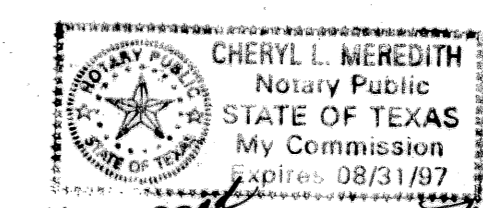
FINAL PLAT

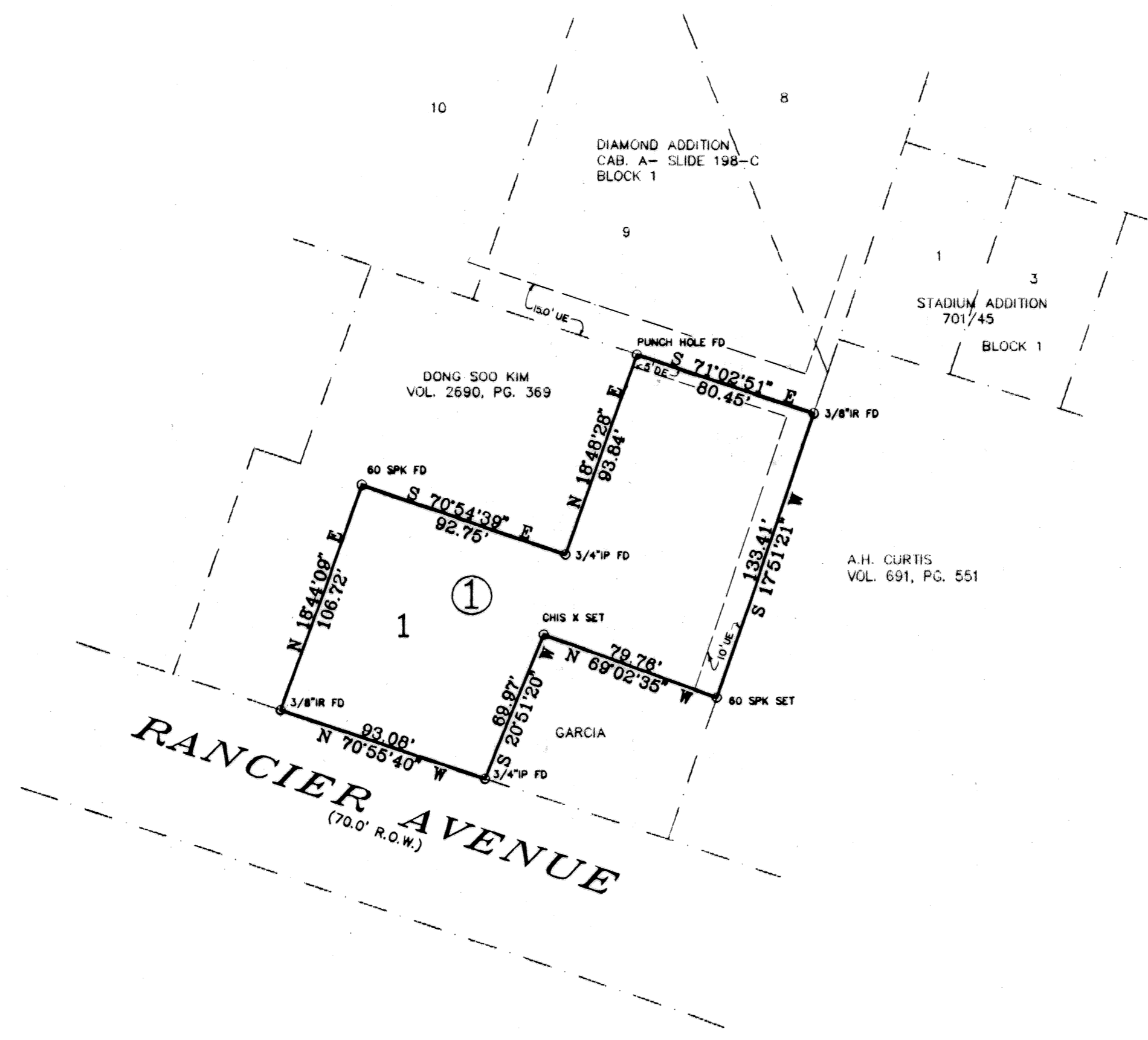
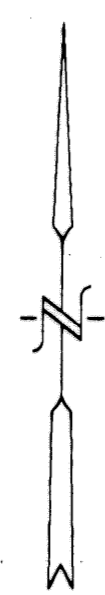
