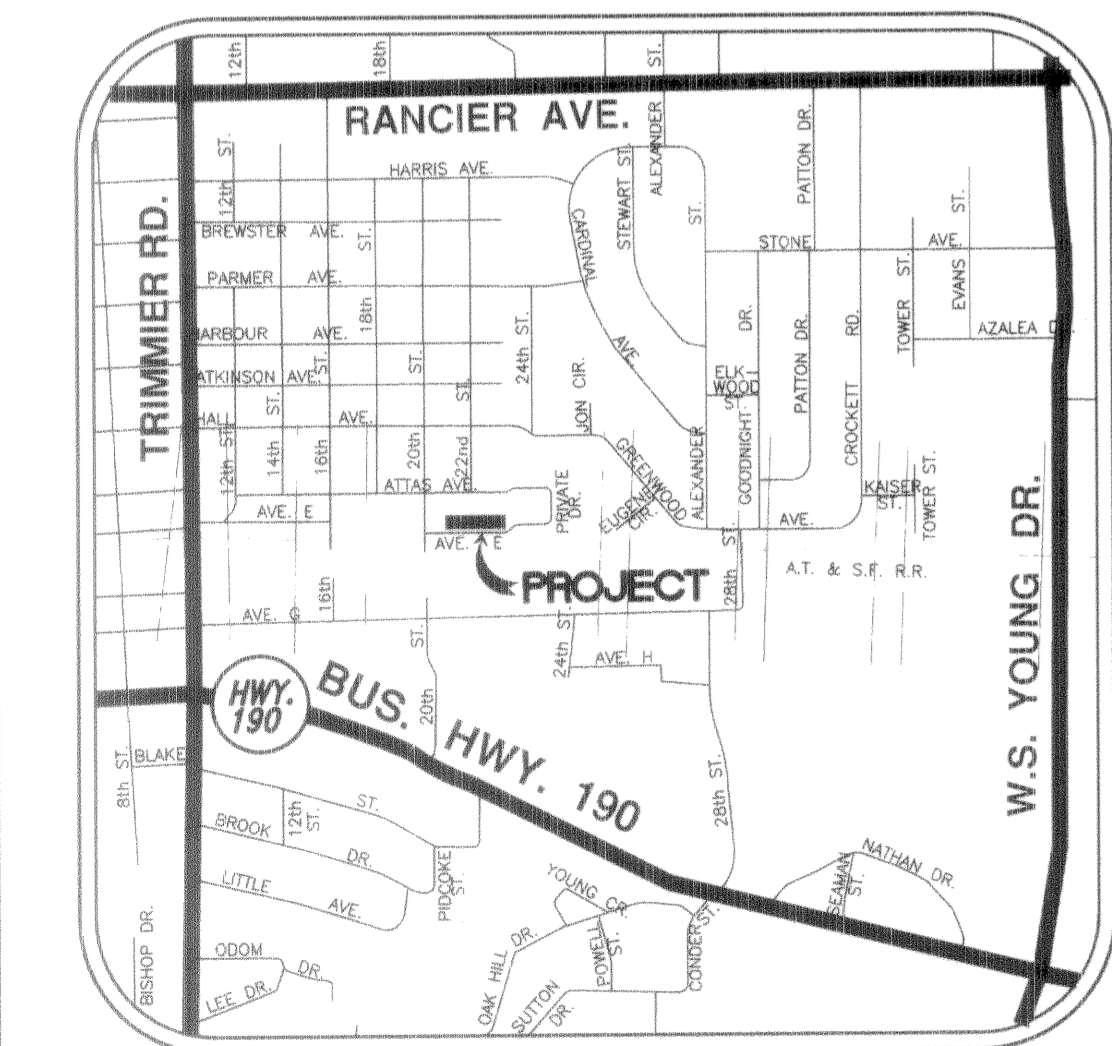


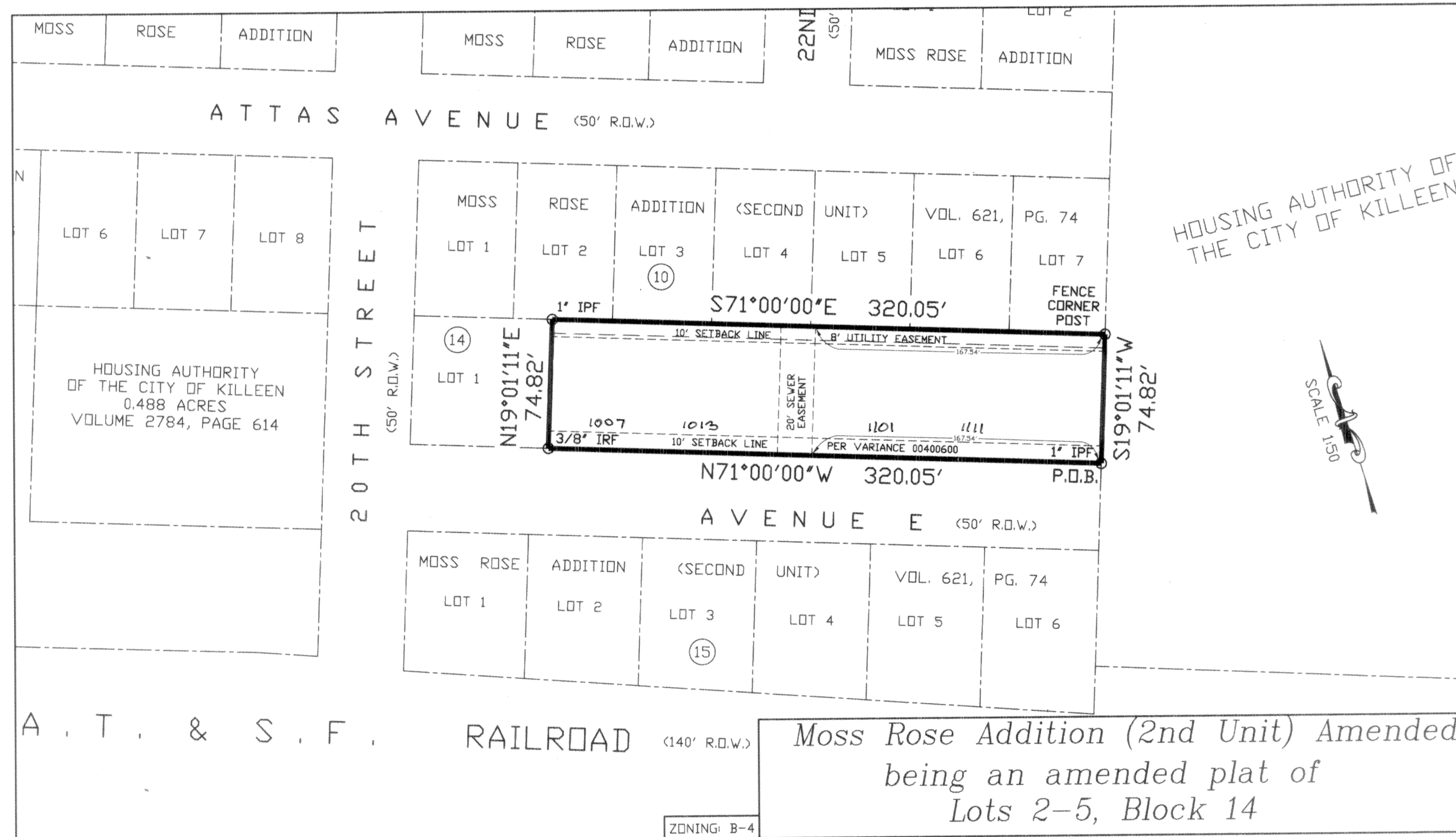
HOUSING AUTHORITY OF THE CITY OF KILLEEN

KNOW ALL MEN BY THESE PRESENTS THAT Arthur H. Trujillo, acting herein as representative of the Housing Authority of the City of Killeen, being the sole and only owner of that certain 0.550 acres of land in Bell County, Texas, which is more fully described in the dedication of MOSS ROSE ADDITION (2ND UNIT) AMENDED, being an amended plat of Lots 2-5, BLOCK 14 as shown by the plat hereof, attached hereto, and made a part hereof, incorporated herein for all purposes, does hereby subdivide the herein property into lots and blocks, according to the plat hereof, to be known as MOSS ROSE ADDITION (2ND UNIT) AMENDED, being an amended plat of Lots 2-5, BLOCK 14, to the City of Killeen, Bell County, Texas as shown by that plat hereof, attached hereto, and made a part hereof, approved by the Planning and Zoning Commission of the City of Killeen, Bell County, Texas. HOUSING AUTHORITY OF THE CITY OF KILLEEN does hereby adopt the MOSS ROSE ADDITION (2ND UNIT) AMENDED, being an amended plat of Lots 2-5, BLOCK 14 as an addition to the City of Killeen, Bell County, Texas, and for the purpose of incorporating four lots into one lot, one block with reference thereto and for the property development of said land by its owners and for all purposes; and does hereby dedicate to the City of Killeen, all streets, avenues, roads, drives, alleys and associated potable water, sanitary sewer, and storm systems as shown on said plat, and final construction drawings the same to be used as public thoroughfares and public utilities when and as authorized by the City of Killeen, Bell County, Texas. The utility easements shown on said plat are dedicated to the City of Killeen for installation and maintenance of any and all public utilities, which the City may elect to install and maintain or permit to be installed and maintained.

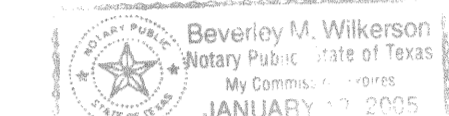

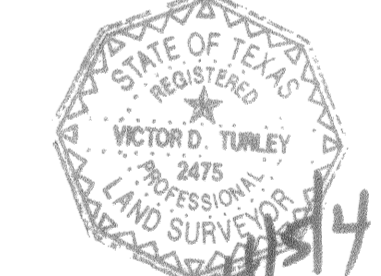
