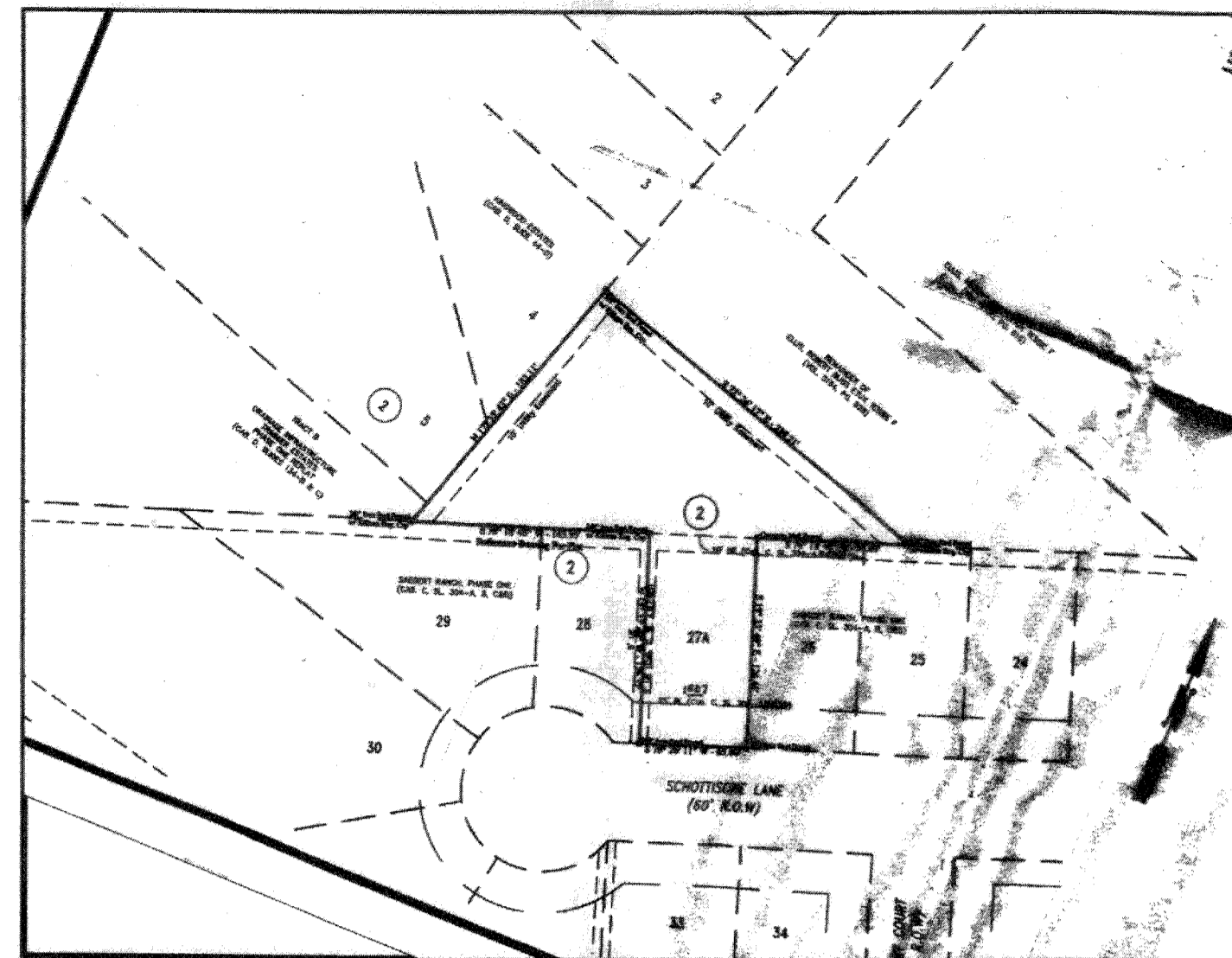


VICINITY MAP

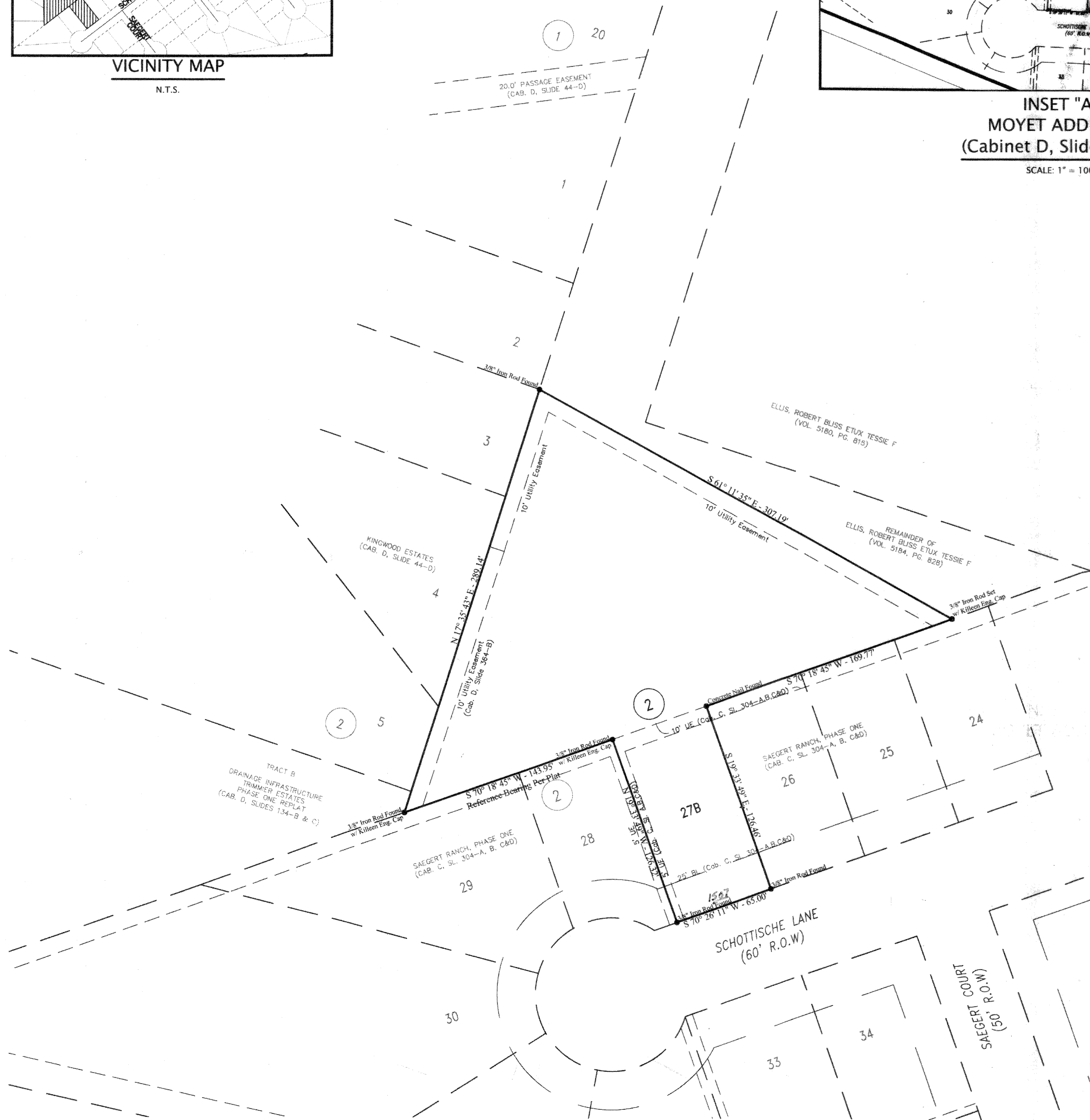

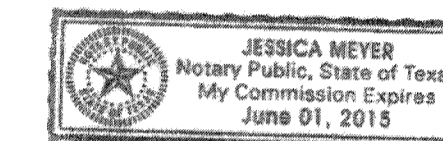

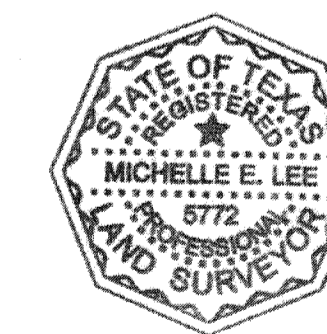
