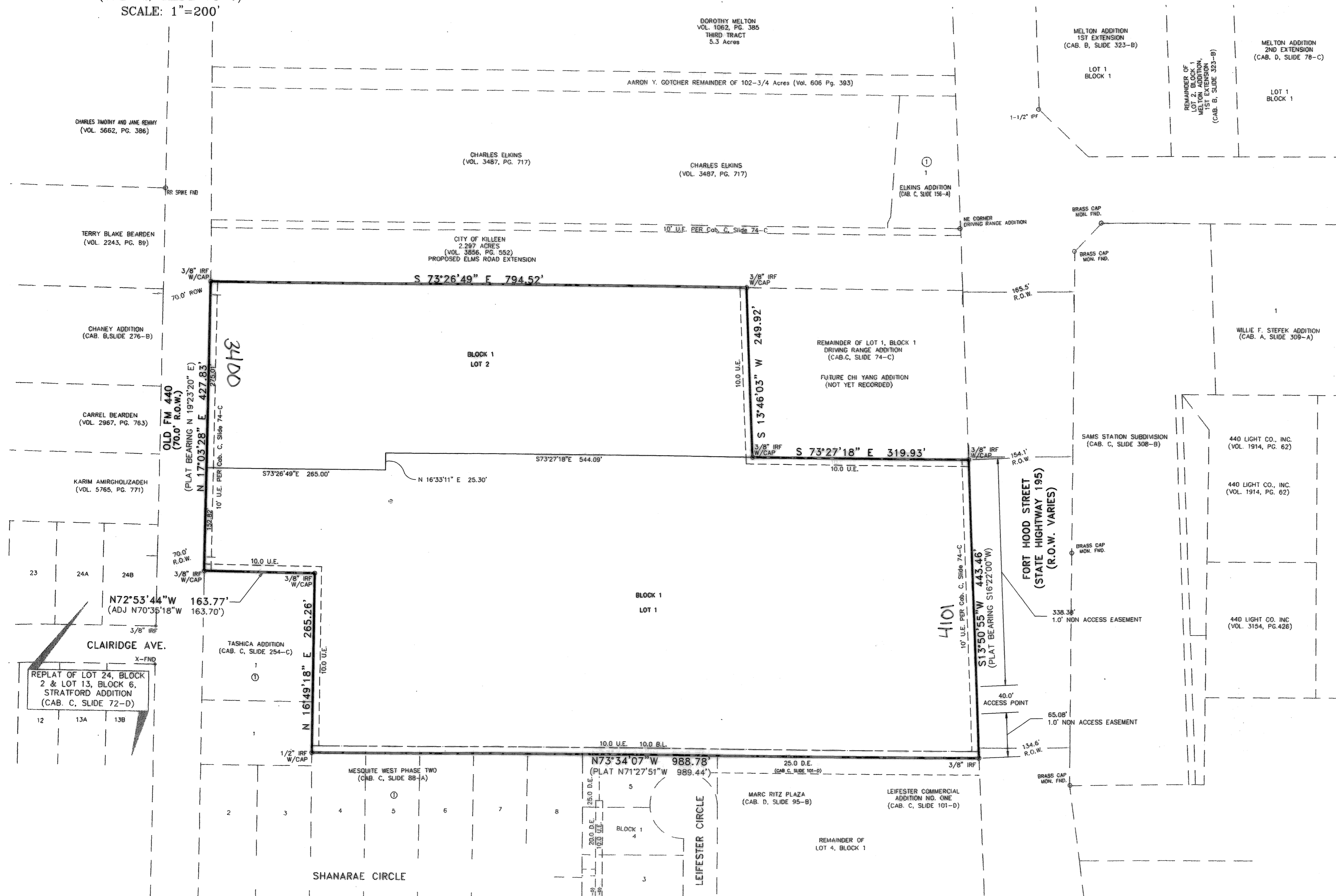
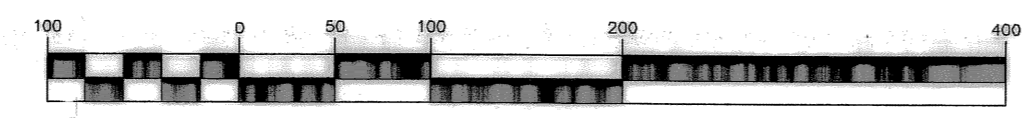


DRIVING RANGE ADDITION

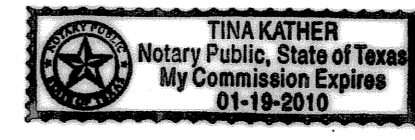
