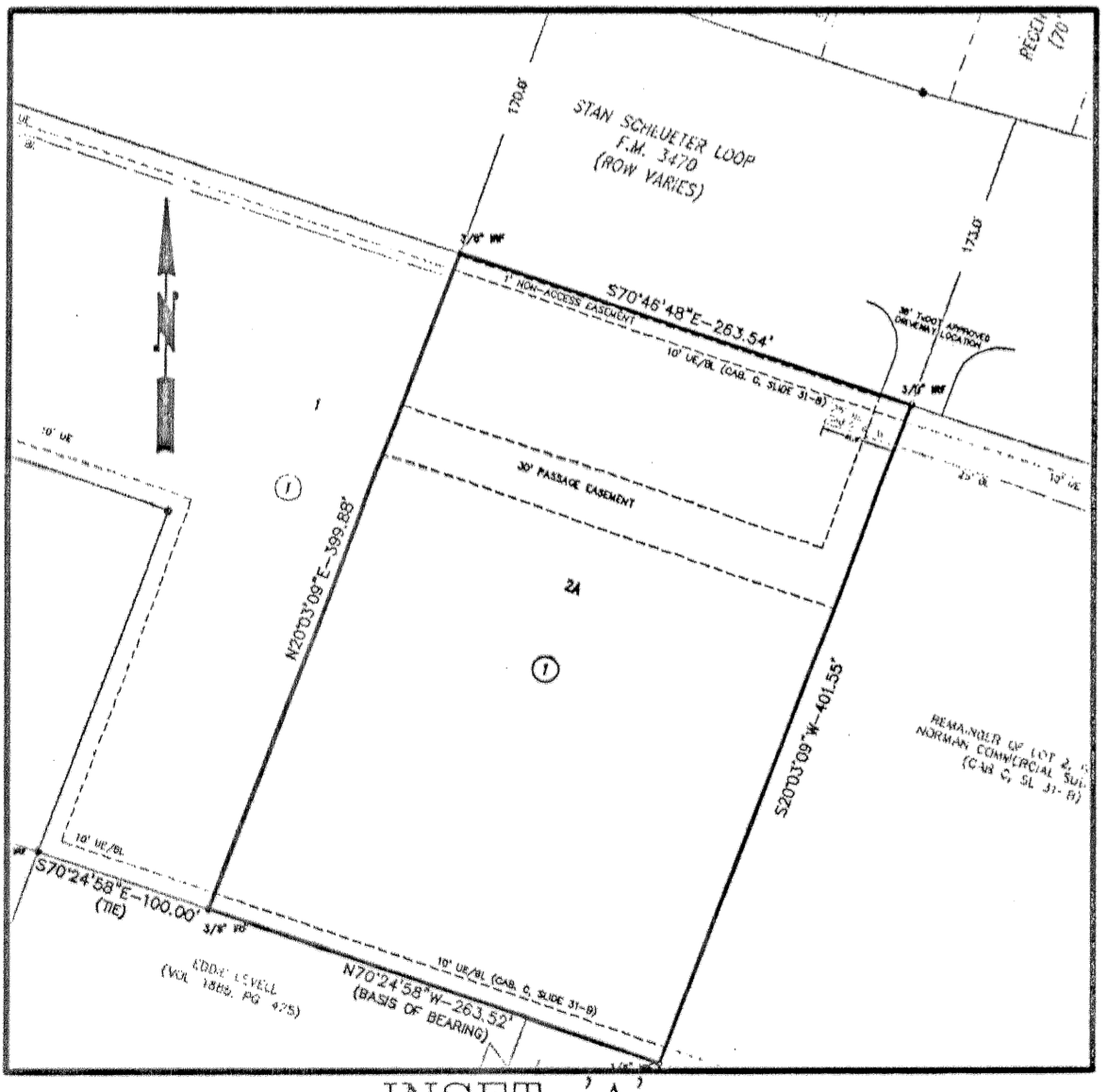
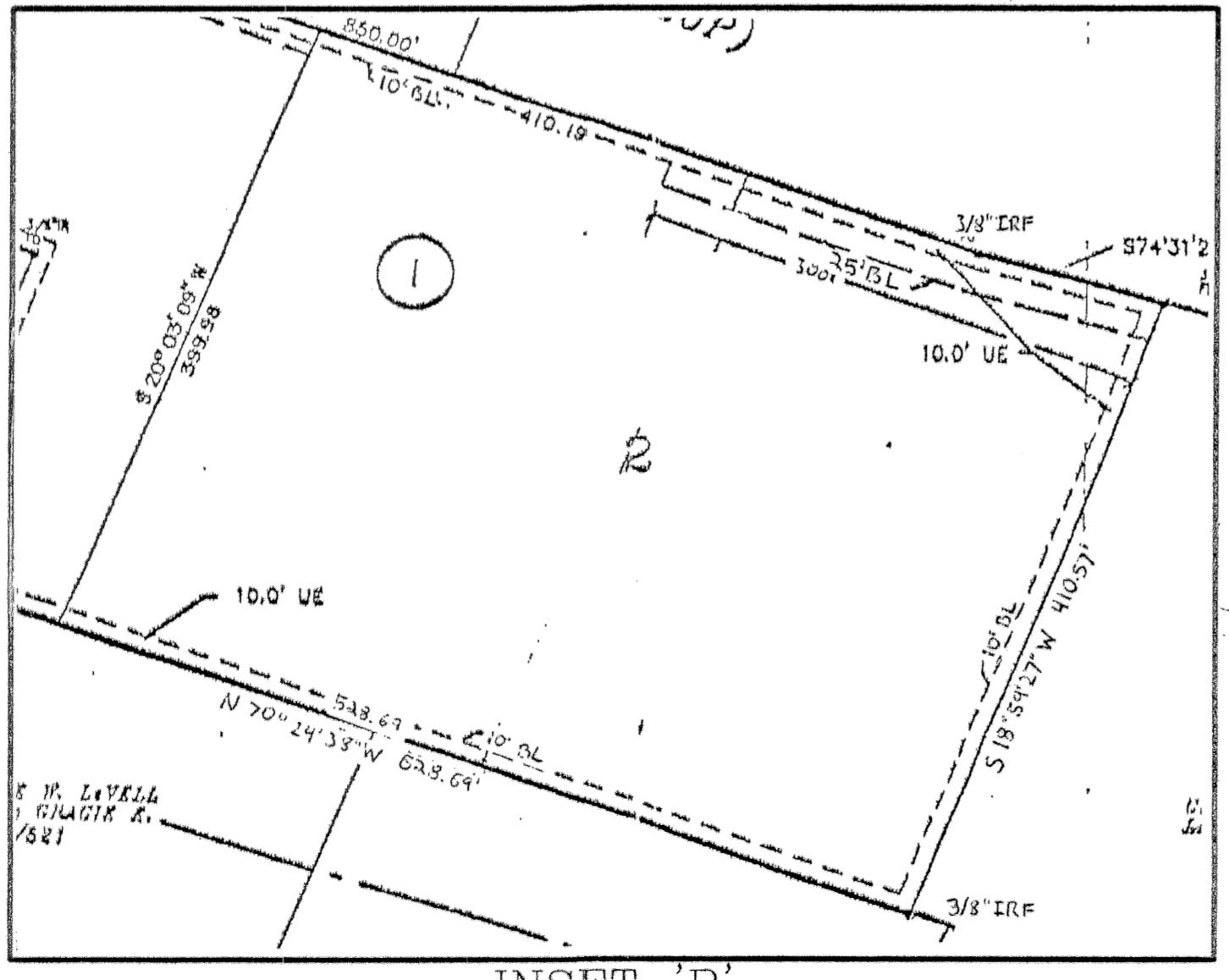


VICINITY MAP

1"=100'

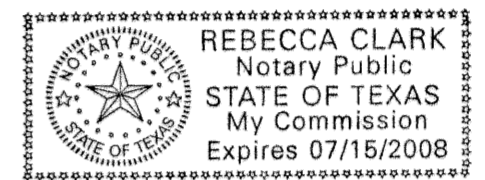


INSET 'B'
