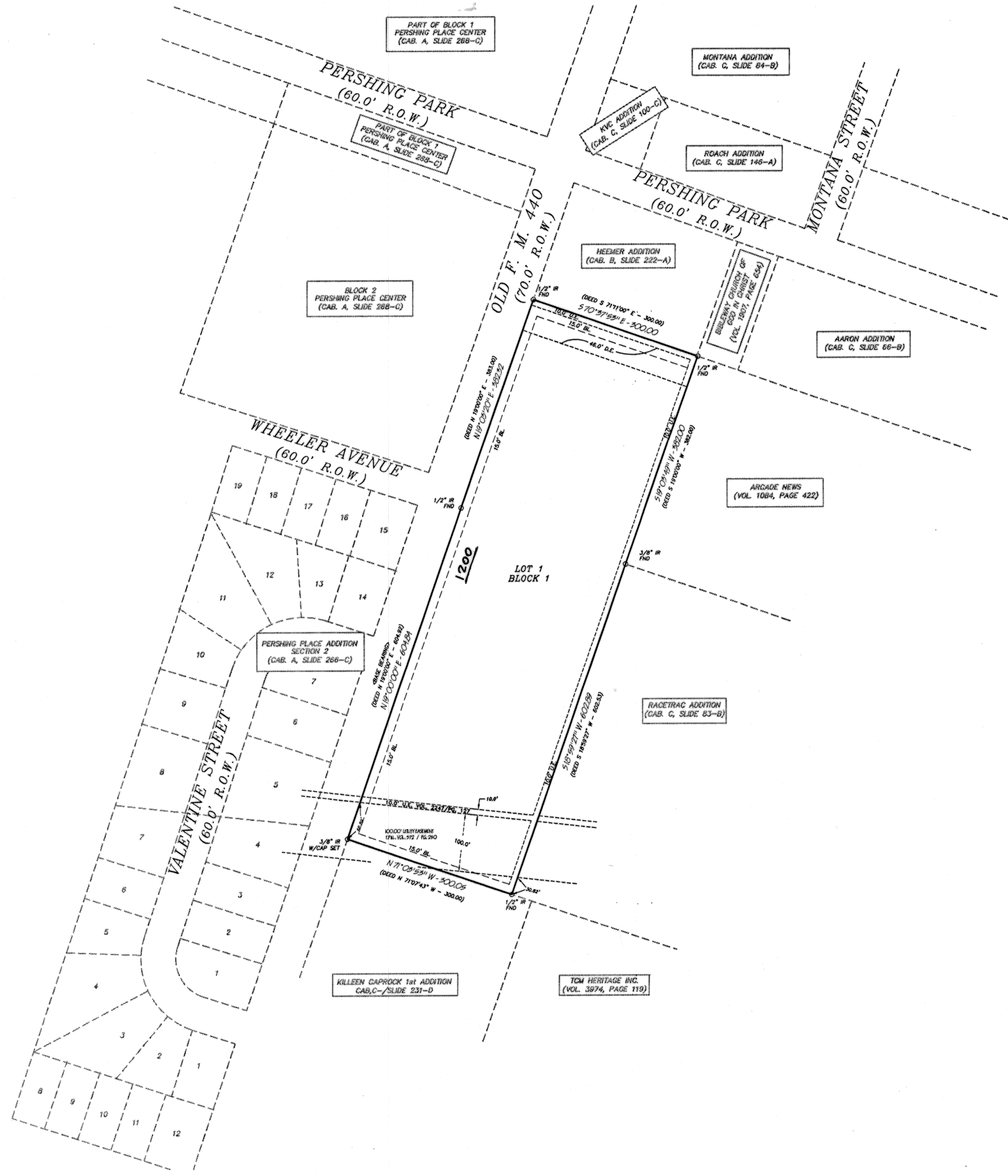


VICINITY MAP

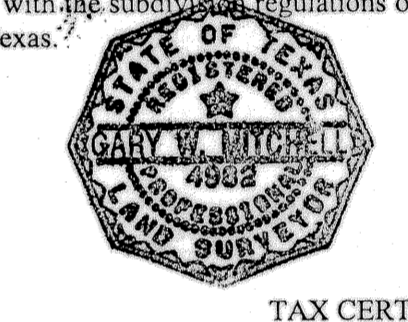
