



Bearings for Survey are referenced to City of Killeen Monuments No. 5 and No. 6, established in 1994. (NAD-83)

## LEGAL DESCRIPTION

Being 6.374 acres of land, more or less, out of the John Goslin Survey, Abstract No. 344, Bell County, Texas, same being part of a 12.271 acre tract of land and a 0.470 acre tract of land as described in Deed Recorded in Volume 883, Page 549, Deed Records of Bell County, Texas, and being more particularly described as follows:

Commencing at the Northwest corner of the said 0.470 acre tract, a found 1/2"

Thence S 72° 17' 07" E, 299.95 feet along the Northerly line of the said 0.470 acre tract and the said 12.271 acre tract to a 3/8" iron rod found, and the POINT OF BEGINNING:

Thence S 72° 17' 25" E, 580.85 feet along the Northerly line of the said 12.271 acre tract to a 1/2" iron pipe found in the Westerly line of State Highway 195, a variable width right-of-way, said corner also being the Southeast corner of Pizza Hut addition according to the Plat recorded at Cabinet B, Page 290A, Plat Records, Bell County, Texas;

Thence S 17° 22' 48" W, 272.77 feet along the Westerly line of State Highway 195 to a set 1/2" iron rod, the Northeast corner of a tract of land described in Volume 1621, Page 291, Deed Records, Bell County, Texas;

Thence N 85° 17' 28" W, 150.04 feet to a found 1" iron pipe, the Northwest corner of the aforesaid tract:

Thence S 17° 13' 08" W, 102.26 feet to a found 60D nail, the Southwest corner of the aforesaid tract:

Thence N 84° 57' 43" W, 156.01 feet to a found 3/8" iron rod, the Northwest corner of a tract of land described in Volume 3214, Page 375, Deed Records, Bell County, Texas:

Thence S 14° 08' 03" W. 157.84 feet to a found 3/8" iron rod, the Southwest corner of the aforesaid tract;

Thence N 72° 39' 44" W, 291.02 feet along the Easterly line of a tract of land described in Volume 1573, Page 560, Deed Records, Bell County, Texas, to a found 3/8" iron rod, said corner also being the Southeast corner of a tract of land described in Volume 2690, Page 595, Deed Records, Bell County, Texas:

Thence N 17° 21' 20" E, 602.43 feet along the Easterly line of the aforesaid tract to the POINT OF BEGINNING, and containing 277,659 square feet or 6.374 acres of land, more or less.

## DEDICATION


