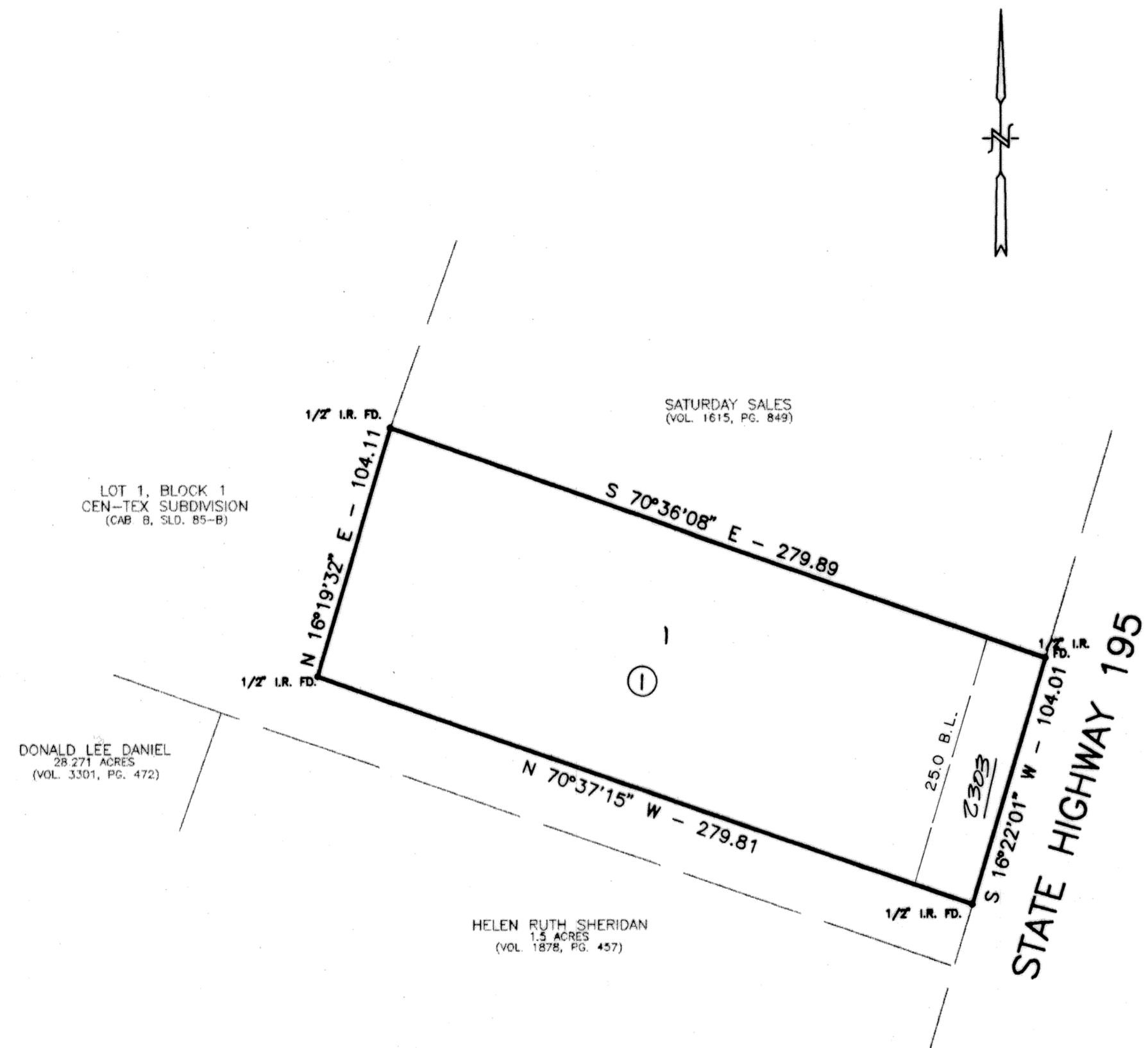


VICINITY MAP

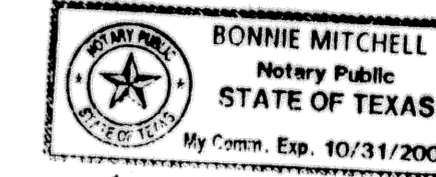

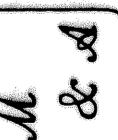
