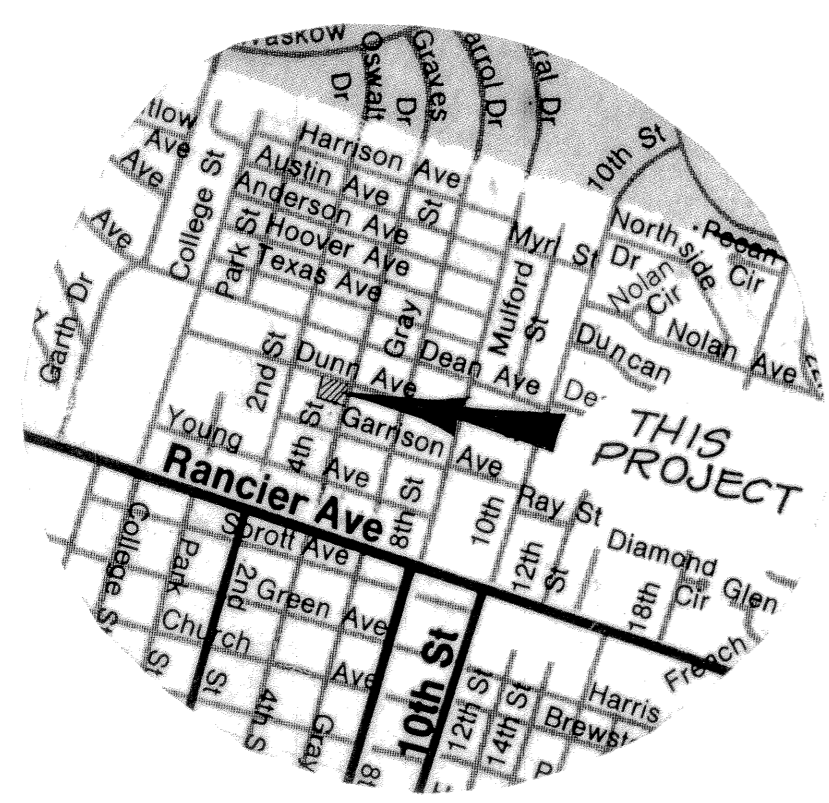
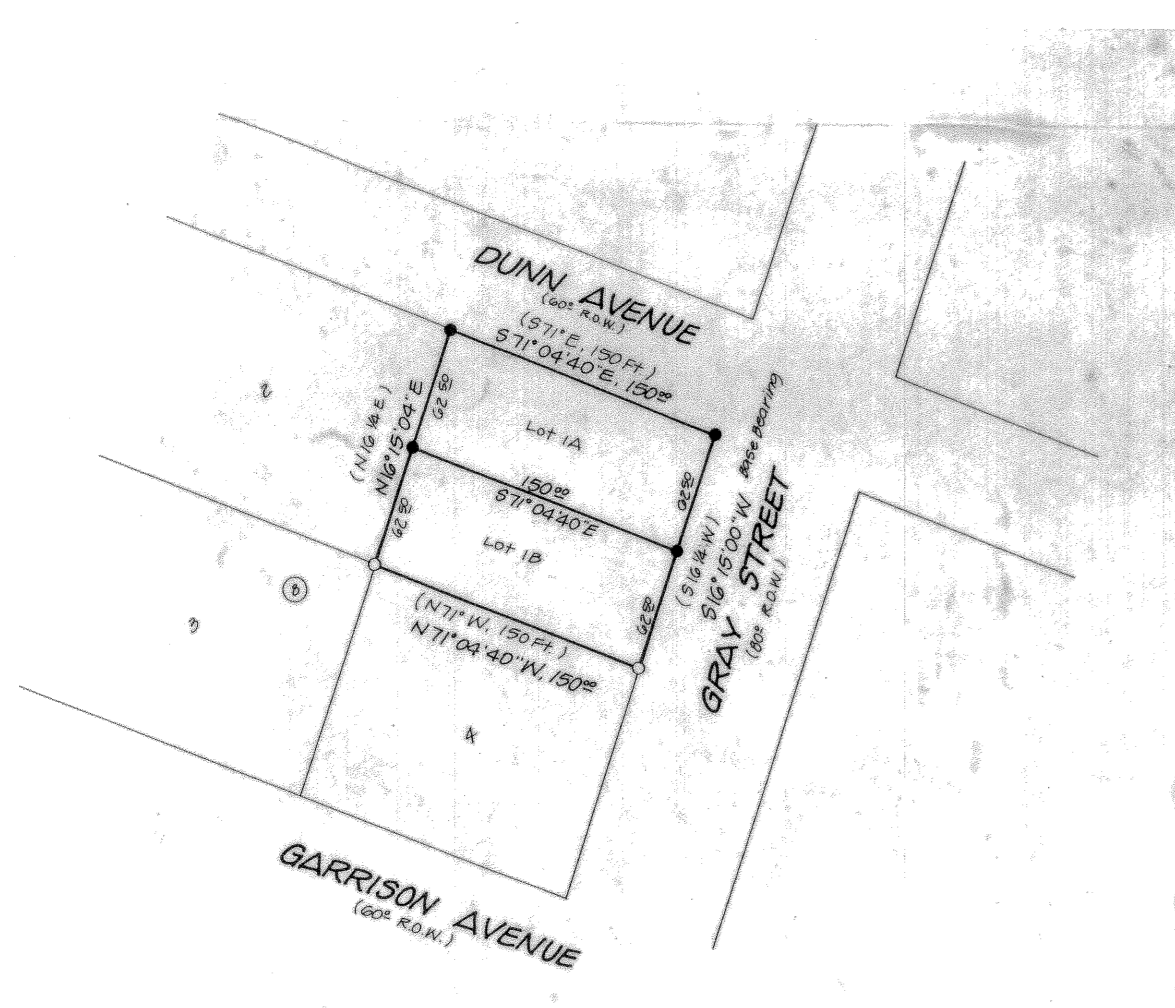


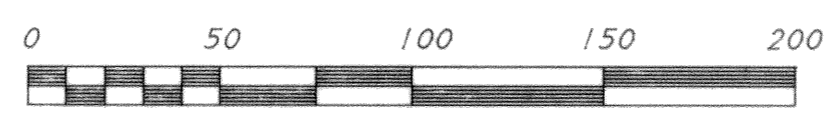
ORIGINAL LOT LAYOUT

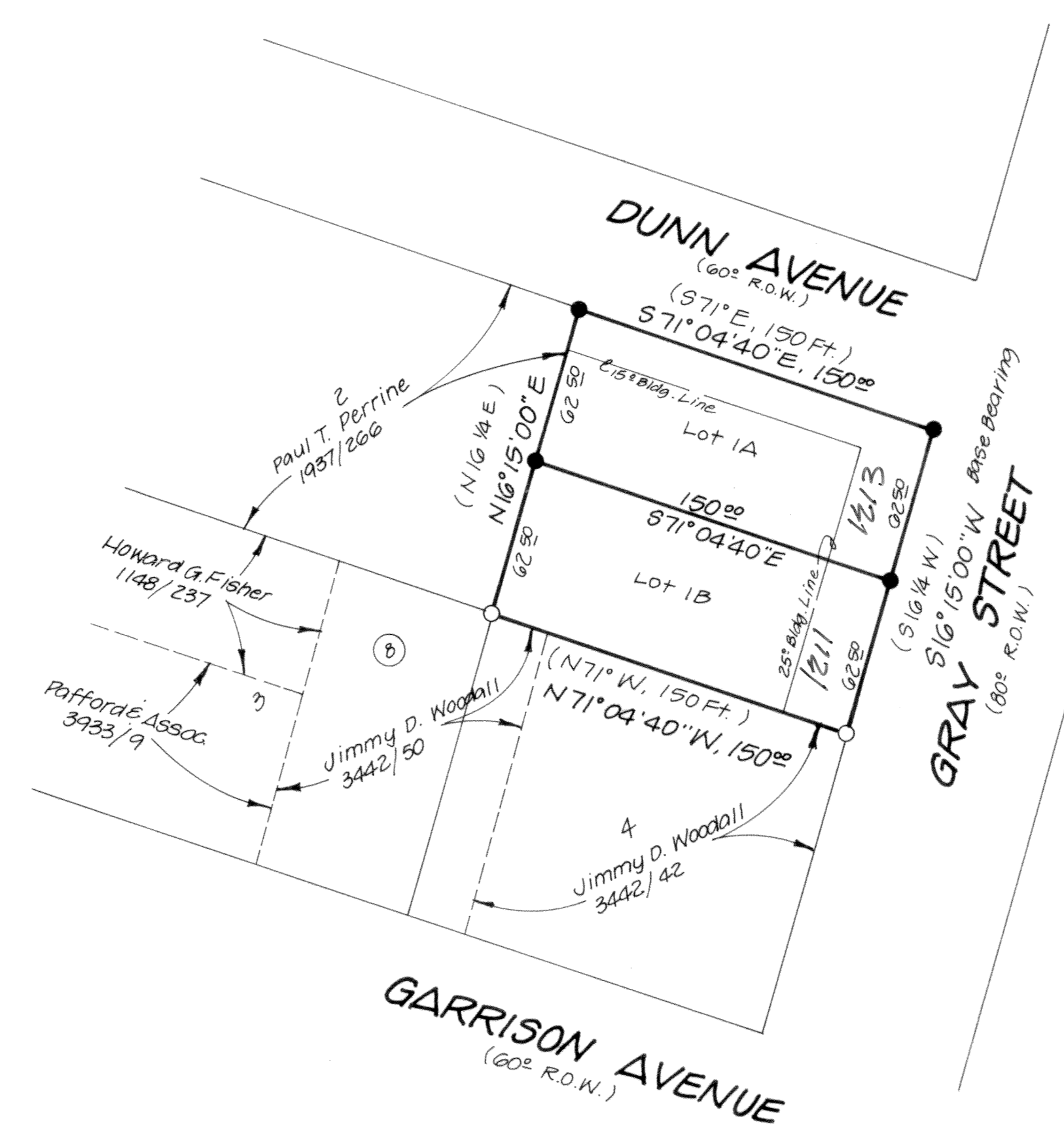
VICINITY MAP

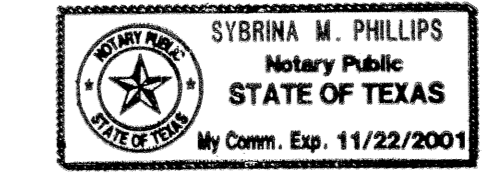

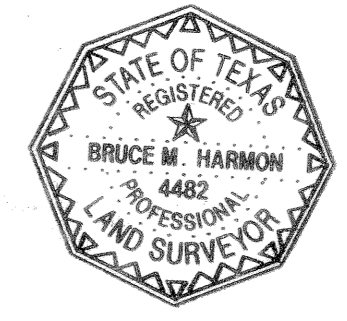
