

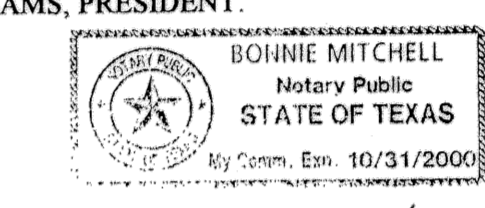
VICINITY MAP
