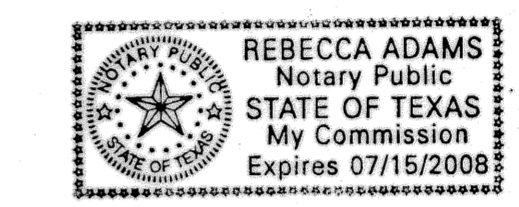
FINAL PLAT

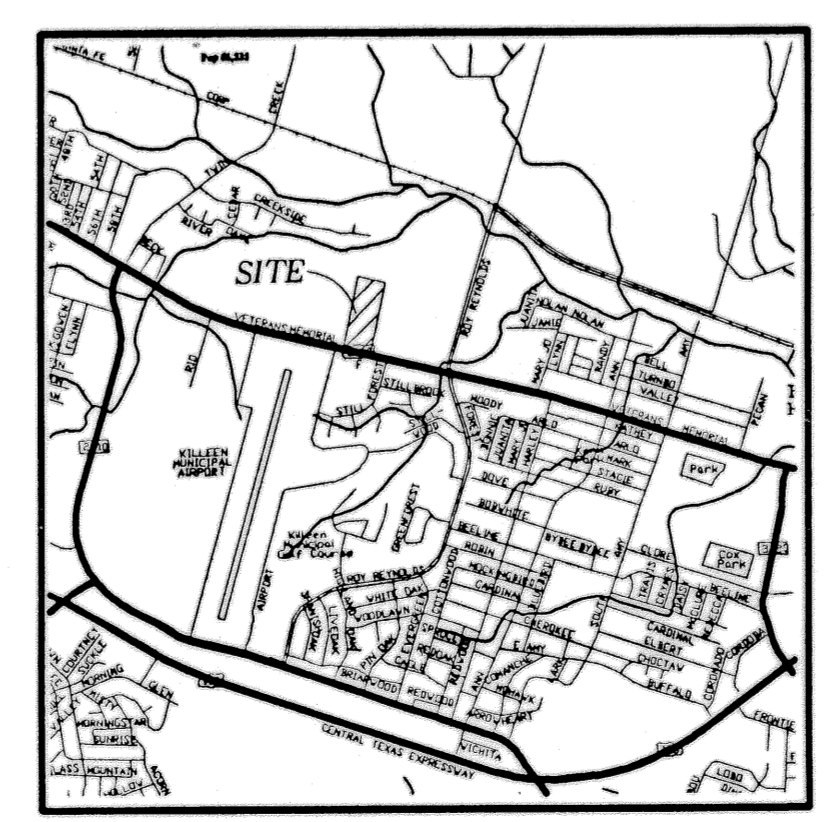

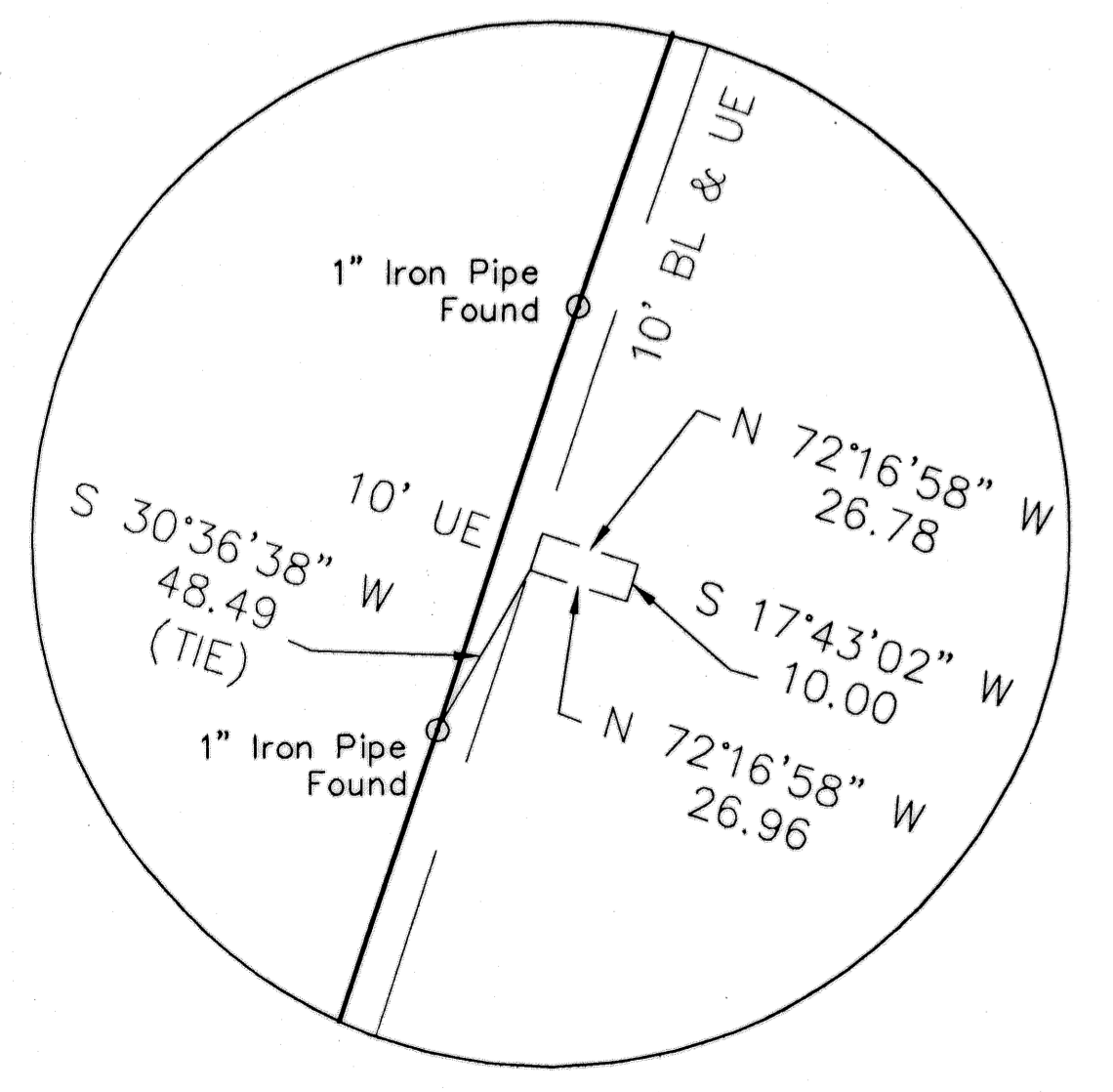
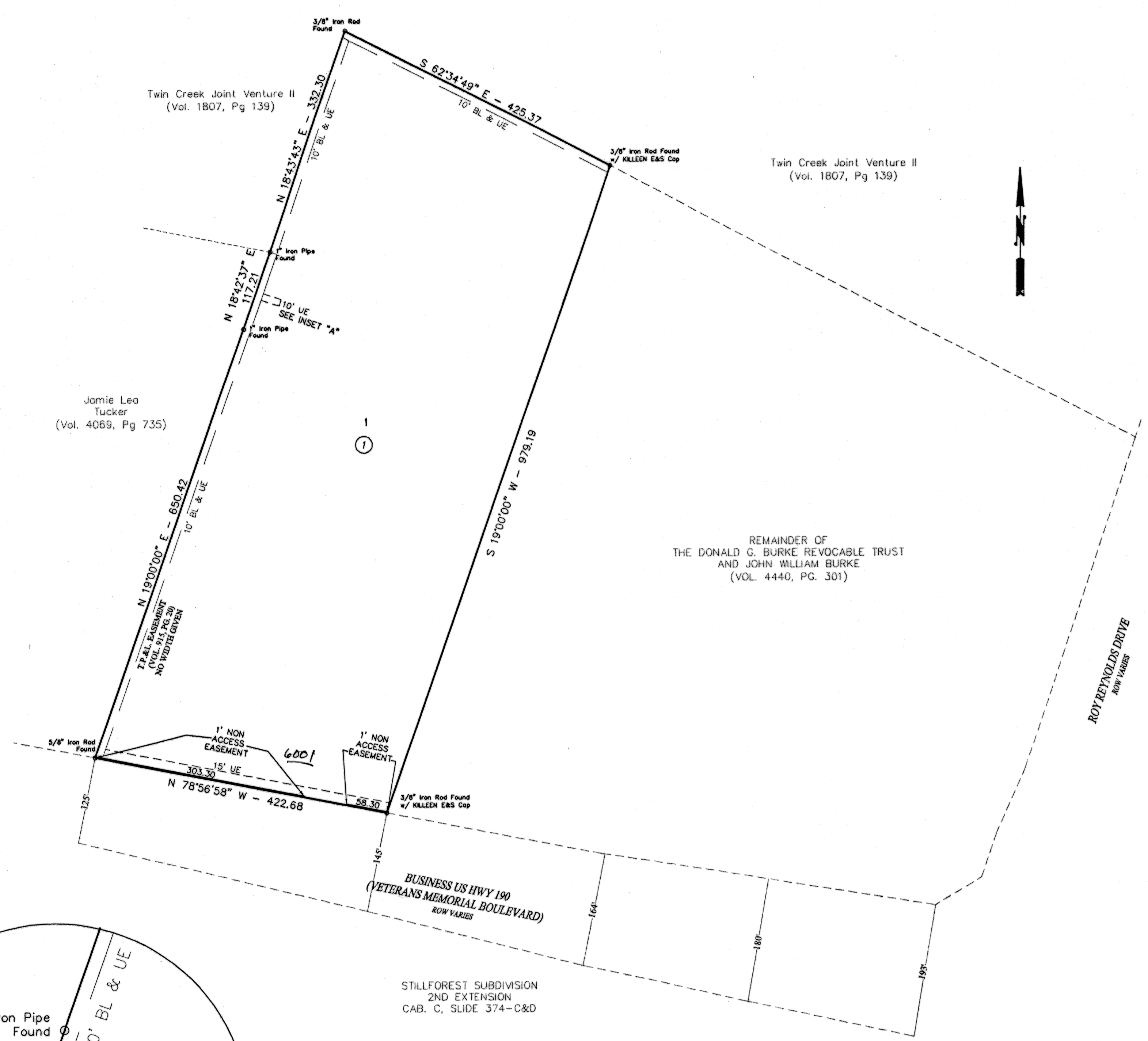
