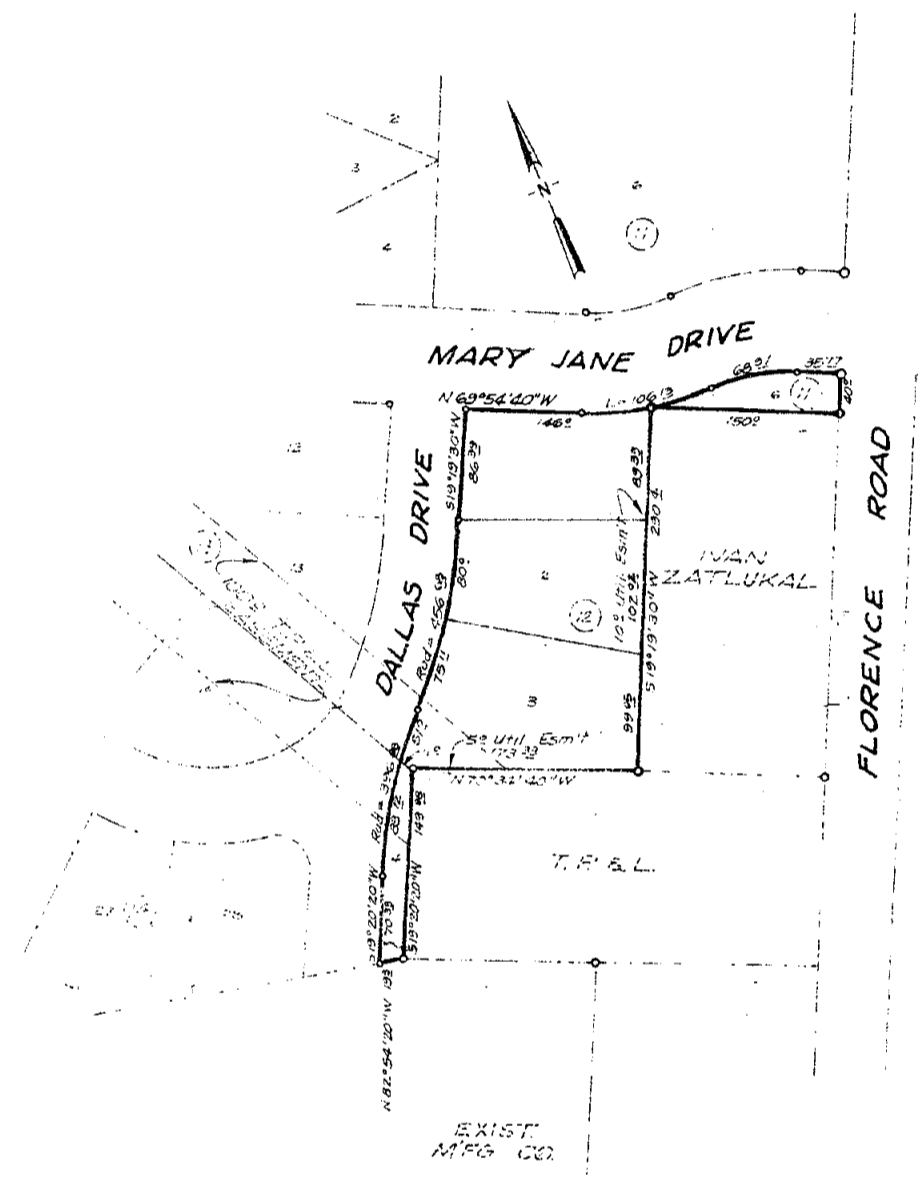

KNOW ALL MEN BY THESE PRESENTS that Cameo Homes, Inc., whose address is 1000 E. Hwy. 190, Killeen, Texas, acting by and through its duly authorized officers, being the sole owner of that certain 1.21 acre tract out of the Nathan Halbert Sur. Abstract No. 389, Killeen, Bell County, Texas, which is fully described in the Dedication of Skyline Terrace, Second Extension, does hereby resubdivide a portion of said land into lots and blocks to be known as a replat of Block No. 12 and a portion of Lot 6, Block No. 11 of Skyline Terrace Second Extension, as shown by the plat hereof, attached hereto, and made a part hereof, and approved by the City Council of the City of Killeen, Bell County, Texas, and Cameo Homes, Inc., does hereby adopt said replat of a portion of Skyline Terrace, Second Extension as an addition to the City of Killeen, Bell County, Texas, and for the purpose of selling lots and blocks of land with reference thereto and for all other purposes; do hereby dedicate to the City of Killeen all streets, avenues, roads, and alleys shown on said plat, the same to be used as public thoroughfares and for the installation and maintenance of public utilities, when and as authorized by the City of Killeen. The utility easements shown on said plat are dedicated to the City of Killeen for installation and maintenance of any and all public utilities, which the City may elect to install and maintain or permit to be installed and maintained.
