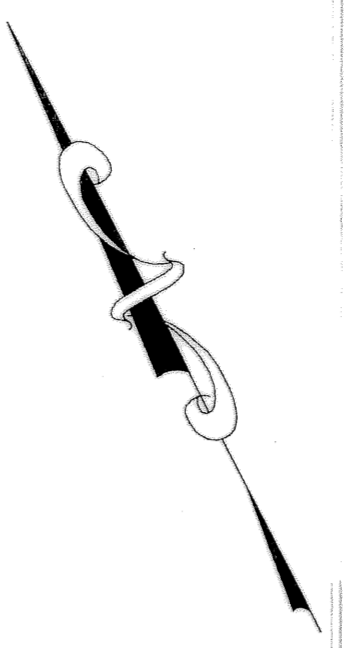
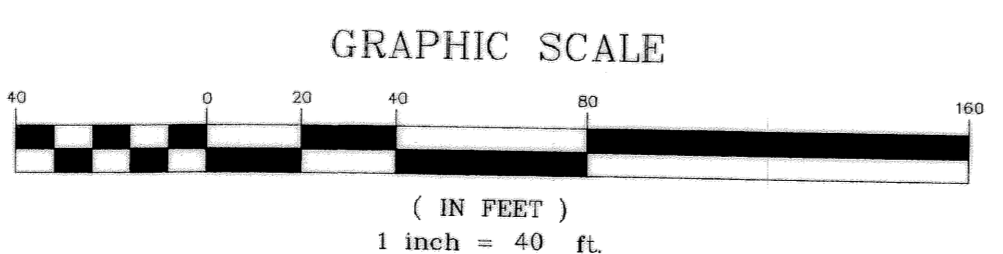


VICINITY MAP

OBTAINED AND SUPPORTED BY A DRAINAGE ANALYSIS.

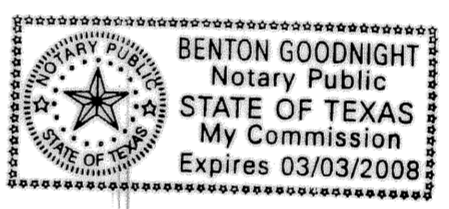

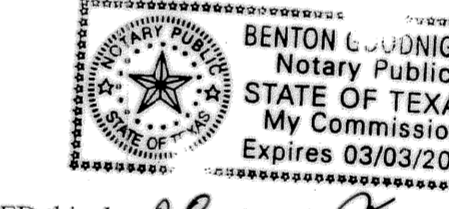

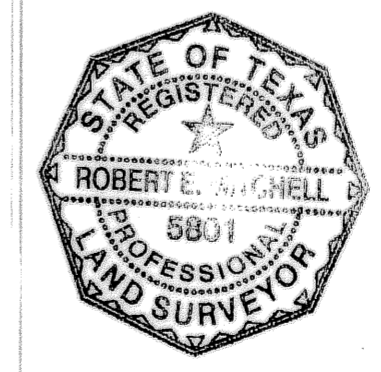
