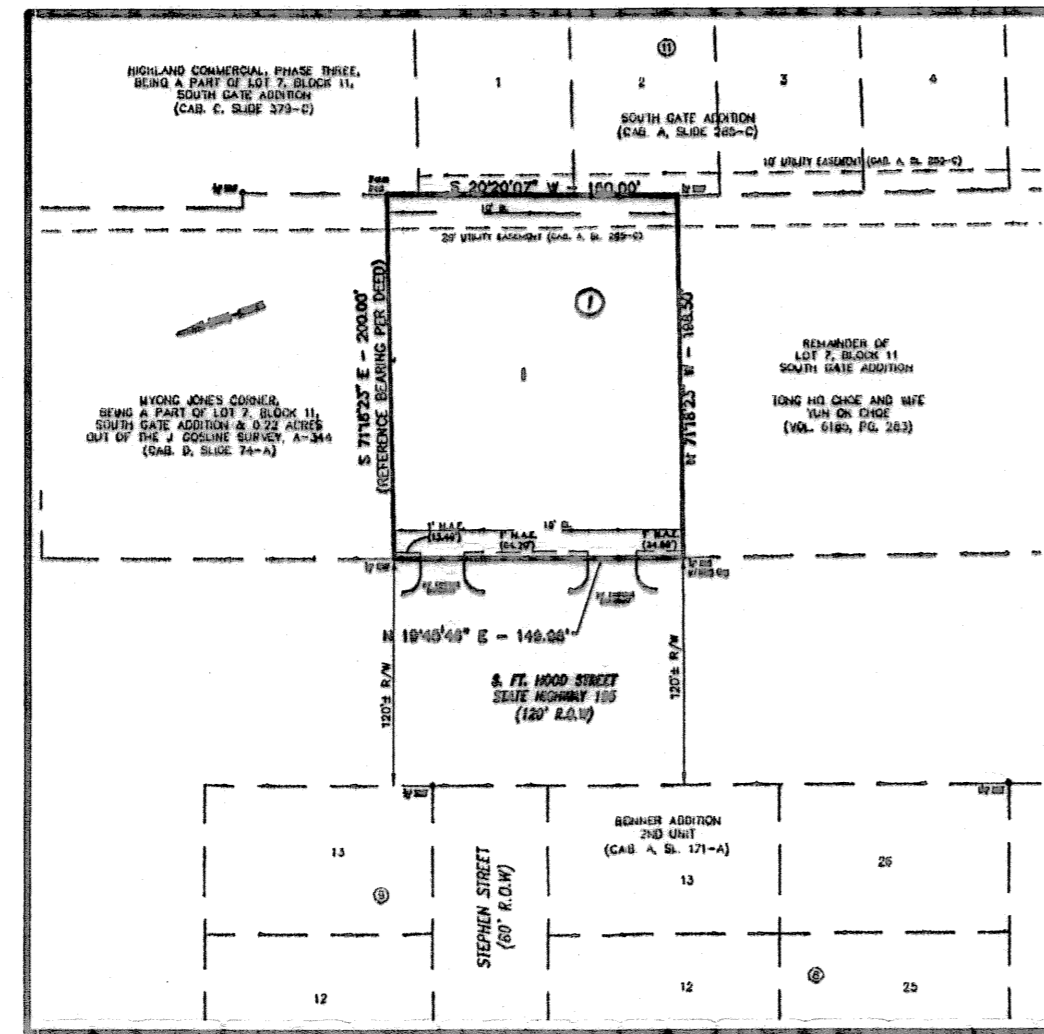
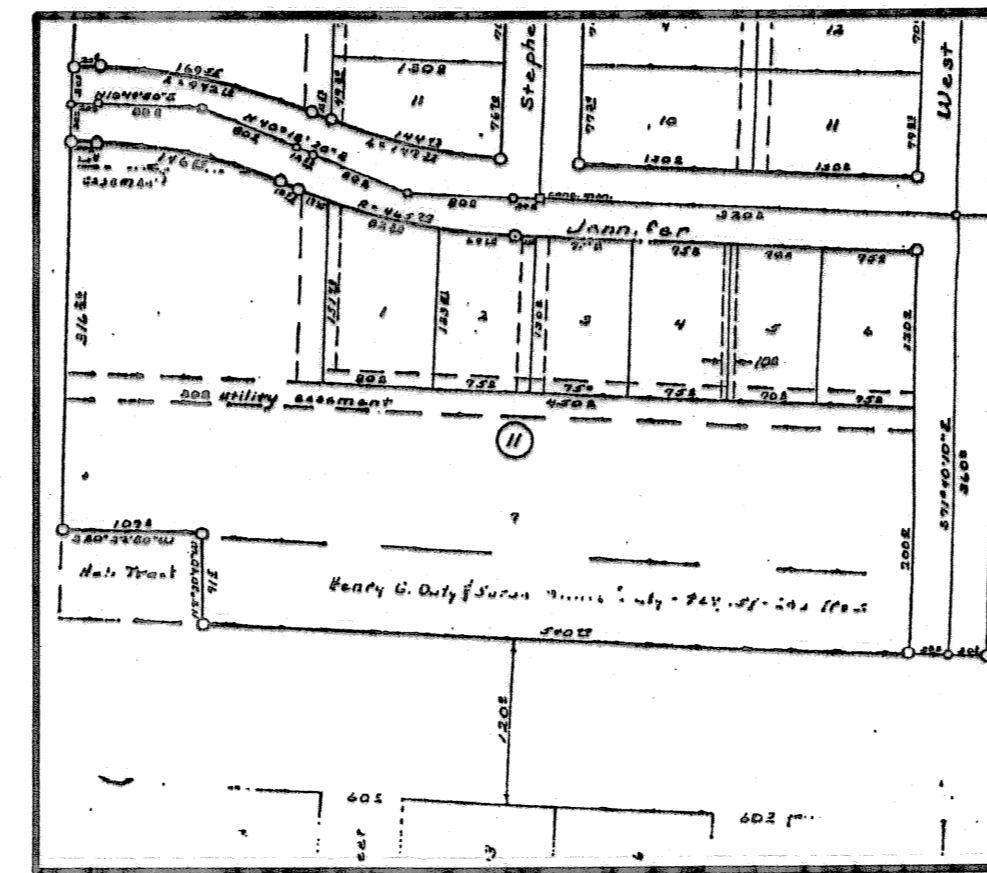


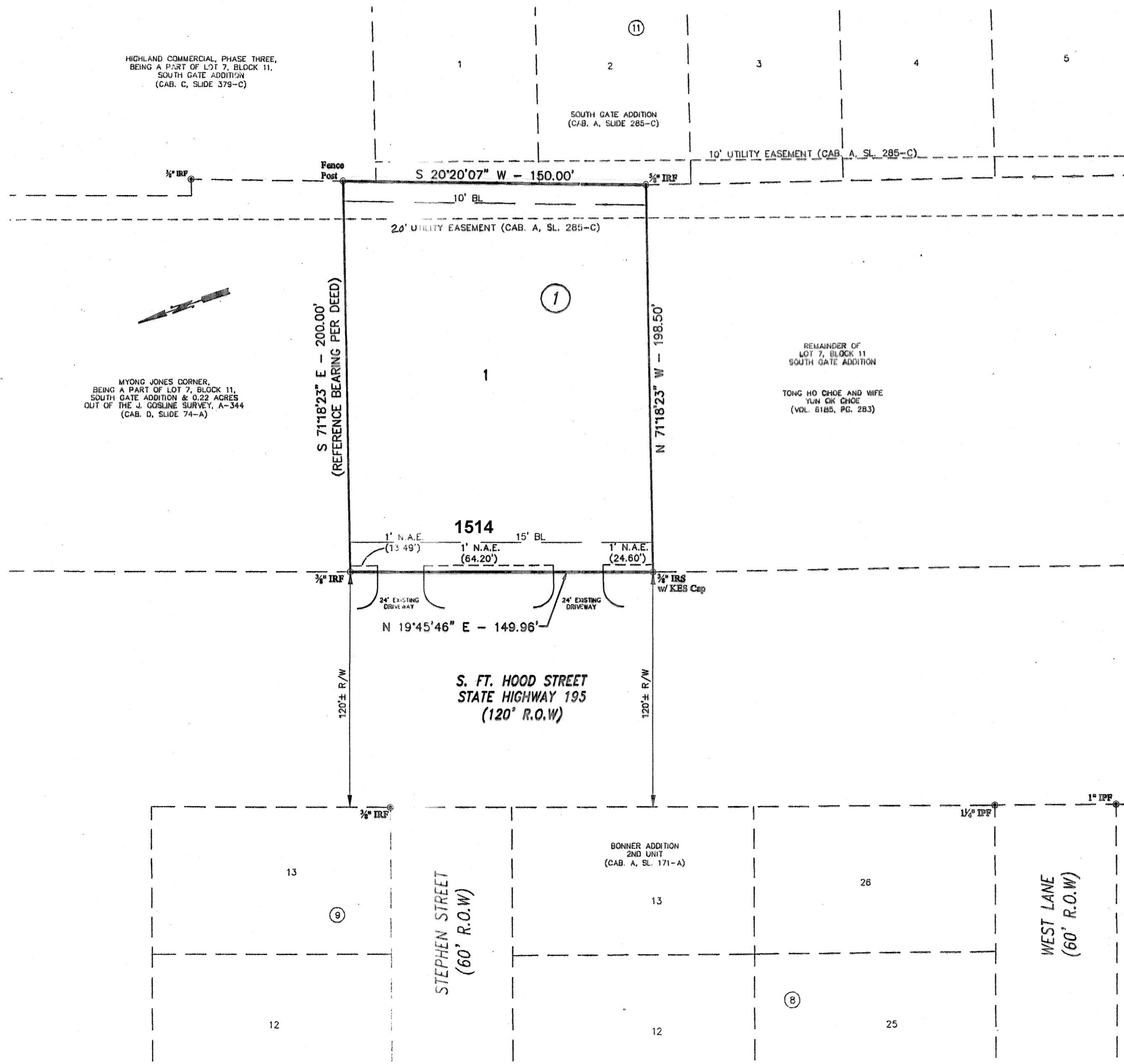
VICINITY MAP
