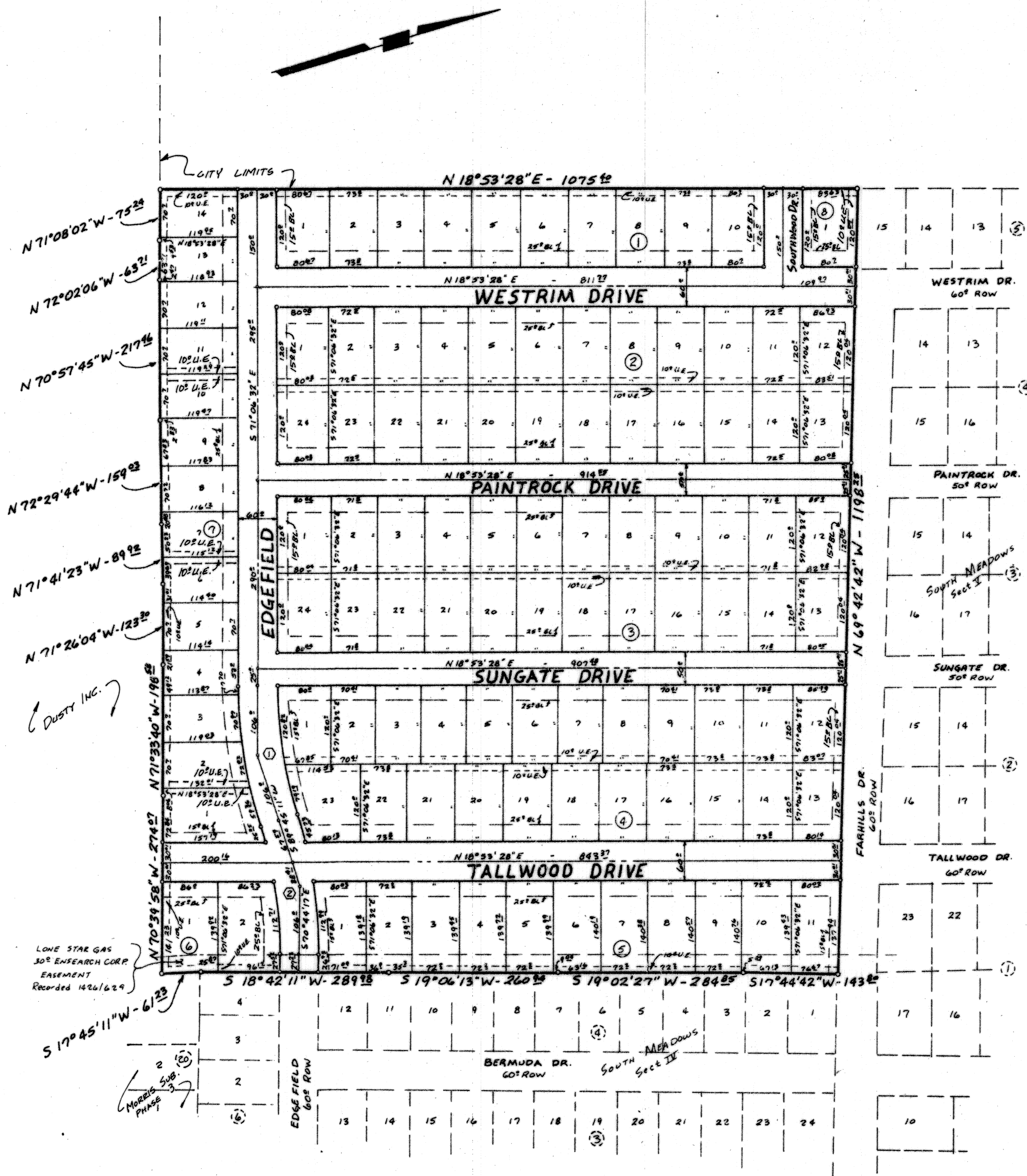


VICINITY MAP
