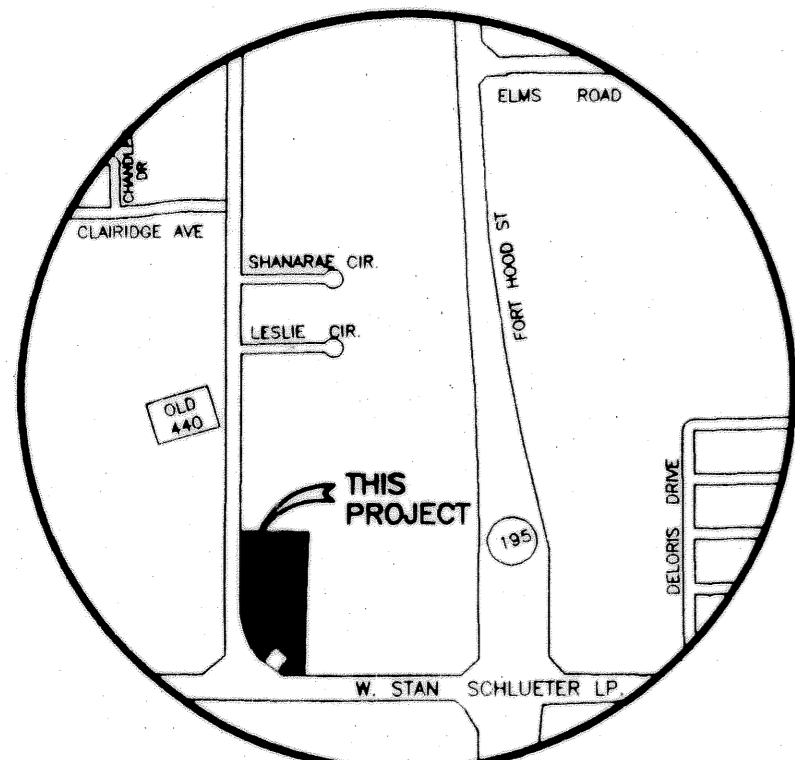
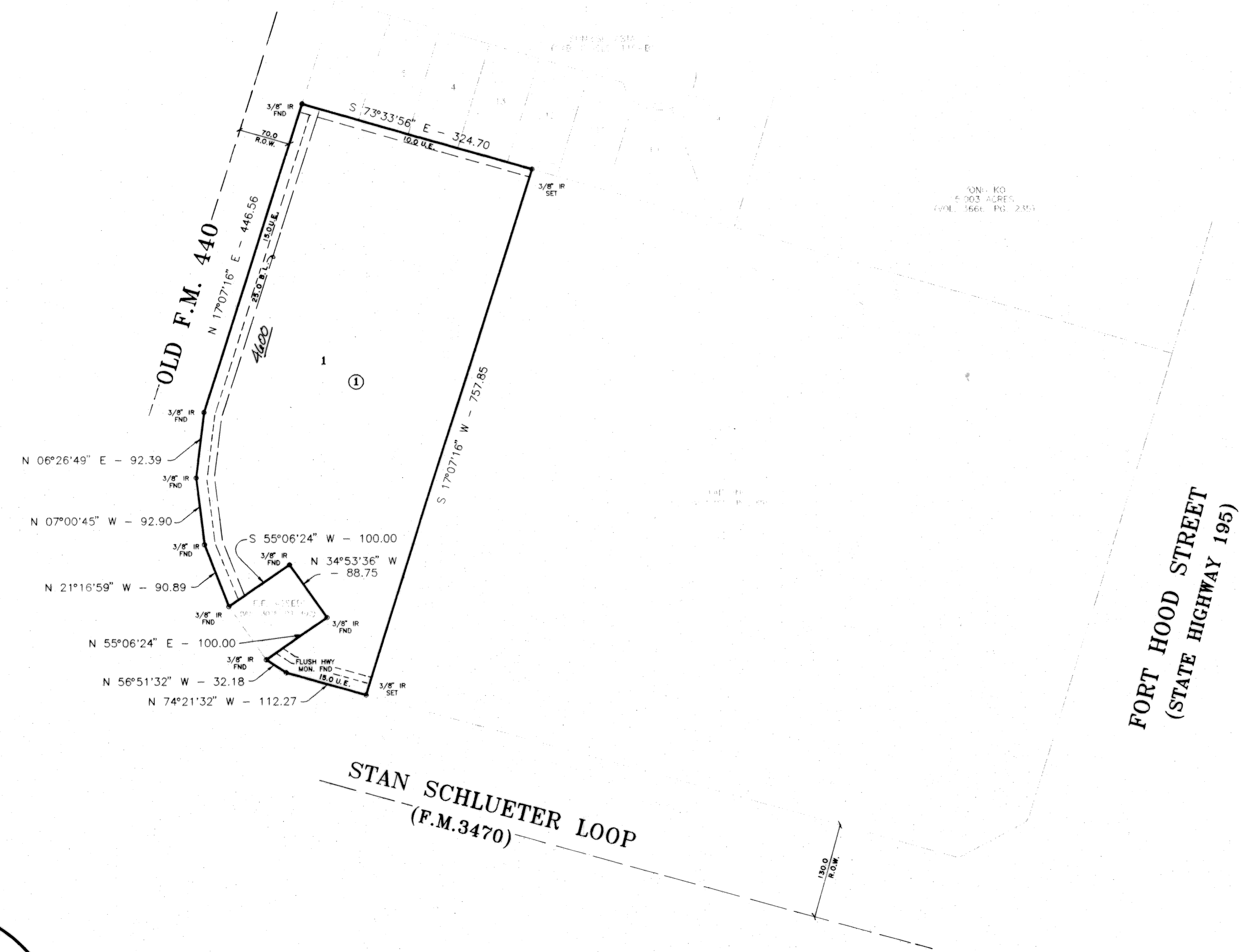

N.T.S.

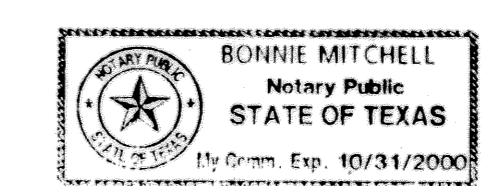

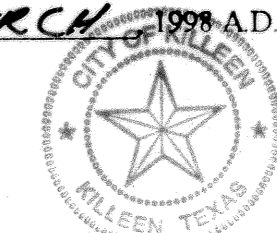

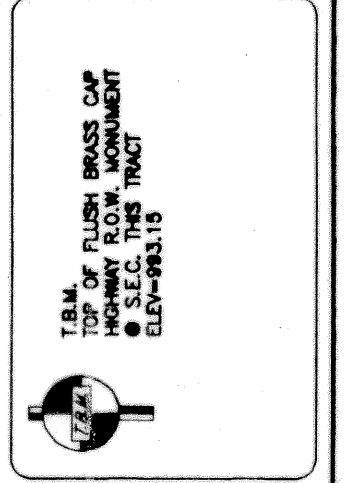
