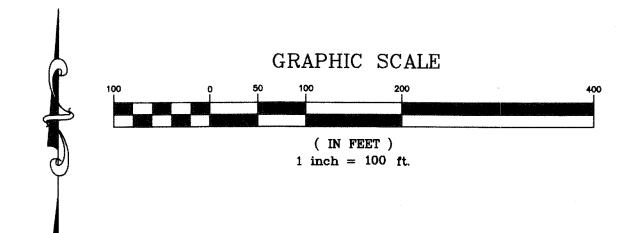
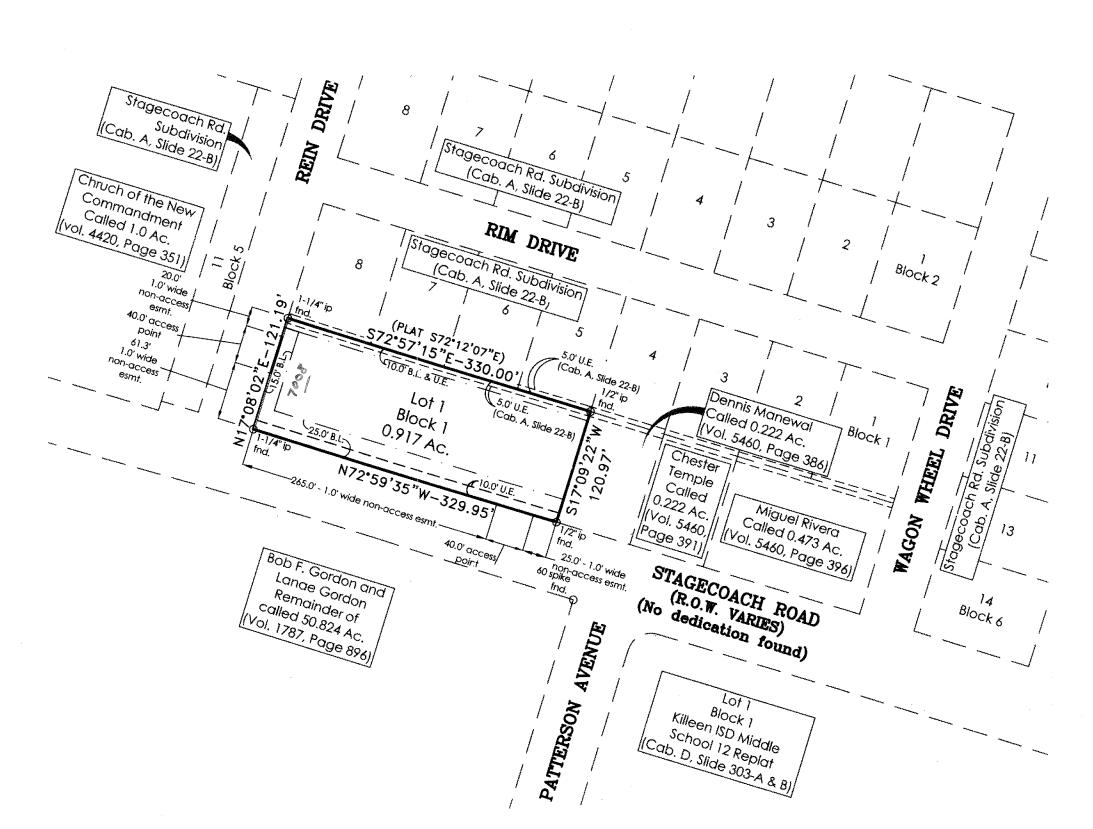
Stagecoach Rd. Subdivision (Cab. A, Slide 22-B) Scale: N.T.S.
